THE MADHYA PRADESH NIJI VISHWAVIDYALAYA (STHAPANA AVAM SANCHALAN)  
TRITIYA SANSHODHAN VIDHEYAK, 2011.

A Bill further to amend the Madhya Pradesh Niji Vishwavidyalaya (Sthapana Avam Sanchalan) Adhiniyam, 2007

Be it enacted by the Madhya Pradesh Legislature in the Sixty-second year of the Republic of India as follows:—

**Short title**

1. This Act may be called the Madhya Pradesh Niji Vishwavidyalaya (Sthapana Avam Sanchalan) Tritiya Sanshodhan Adhiniyam, 2011.

**Amendment of Schedule.**

2. In Schedule to the Madhya Pradesh Niji Vishwavidyalaya (Sthapana Avam Sanchalan) Adhiniyam, 2007 (No. 17 of 2007), after serial number 7 and entries relating thereto, the following serial numbers and entries relating thereto shall be inserted, namely :—

## STATEMENT OF OBJECTS AND REASONS

Section 5 of the Madhya Pradesh Niji Vishwavidyalaya (Sthapana Avam Sanchalan) Adhiniyam, 2007 (No. 17 of 2007) provides for evaluating of the proposal of establishment of Private University in the State by the Regulatory Commission constituted under the Act. Under the said provision, the Regulatory Commission has recommended to establish the Private Universities, in the name of Swami Vivekanand University at Sagar and AKS University at Satna, Under section 6 of the said Act, the State Government has issued the letters of intent to the sponsoring bodies of the said Universities, for the said purpose. Section 9 of the said Act provides, this after being satisfied with the report submitted by the Regulatory Commission, a Private University shall be established by incorporating the name and description thereof in the Schedule to the said Act.

2. Hence this Bill.
