MADHYA PRADESH BILL

THE MADHYA PRADESH VIDHAN MANDAL SADASYA NIRARHATA NIVARAN (SANSHODHAN) VIDHEYAK, 2014

A Bill further to amend the Madhya Pradesh Vidhan Mandal Sadasya Nirarhata Nivaran Adhiniyam, 1967.

Be it enacted by the Madhya Pradesh Legislature in the Sixty-fourth year of the Republic of India as follows:—

Short title.

1. This Act may be called the Madhya Pradesh Vidhan Mandal Sadasya Nirarhata Nivaran (Sanshodhan) Adhiniyam, 2014.

Amendment of Schedule.

- 2. In the Schedule to the Madhya Pradesh Vidhan Mandal Sadasya Nirarhata Nivaran Adhiniyam, 1967 (No. 16 of 1967),—
 - (i) in item 98, after the word "Chairman", the words "and Vice-Chairman" shall be inserted;
 - (ii) after item 98, the following items shall be added, namely:—
 - "99. The Chairman and Vice-Chairman of the Madhya Pradesh State Mining Corporation;
 - 100. The Chairman and Vice-Chairman of the Madhya Pradesh Urja Vikas Nigam;
 - 101. The Chairman and Vice-Chairman of the Madhya Pradesh Mela Pradhikaran;
 - 102. The Chairman and Vice-Chairman of the Madhya Pradesh Jal Nigam Maryadit;
 - 103. The Chairman and Vice-Chairman of the Bhopal Development Authority.".

Repeal and saving.

- 3. (1) The Madhya Pradesh Vidhan Mandal Sadasya Nirarhata Nivaran (Sanshodhan) Adhyadesh, 2013 (No. 4 of 2013) is hereby repealed.
- (2) Notwithstanding the repeal of the said Ordinance anything done or any action taken under the said Ordinance shall be deemed to have been done or taken under the corresponding provisions of this Act.

STATEMENT OF OBJECTS AND REASONS

In order to include certain offices of profit under the Government in the Schedule to the Madhya Pradesh Vidhan Mandal Sadasya Nirarhata Nivaran Adhiniyam, 1967 (No. 16 of 1967), it has been decided to amend the Act suitably, so as not to disqualify the holder thereof from being chosen as, or for being, a member of the State Legislature.

- 2. As the matter was urgent and the Madhya Pradesh Legislative Assembly was not in session, the Madhya Pradesh Vidhan Mandal Sadasya Nirarhata Nivaran (Sanshodhan) Adhyadesh, 2013 (No. 4 of 2013) was promulgated for the purpose. It is now proposed to replace the said Ordinance by an Act of the State Legislature without any modification.
 - 3. Hence this Bill.
