**Eligibility.—Candidate should be himself/ herself NRI OR Children of NRI For proof of NRI.—NRI certificate of current year issued from Indian Embassy must be submitted. (Sponsorship from NRI relatives other than Father/ Mother shall not be considered) :—**

1. The candidates of Unreserved Category should have passed with minimum 50% of aggregate marks in qualifying examination of 12th Standard (10+2 stream) in Physics, Chemistry & Biology/ Biotechnology Subject or equivalent examination thereof and also should have passed Physics, Chemistry & Biology/Biotechnology Subject separately.
2. The Candidates of Reserved Category (ST/SC/OBC) should have passed with minimum 40% of aggregate marks in qualifying examination of 12<sup>th</sup> Standard (10+2 stream) in Physics, Chemistry & Biology/Biotechnology Subject or equivalent examination thereof and also should have passed Physics, Chemistry & Biology/Biotechnology Subject separately.
3. Candidates of Un-Reserved Category as well as Reserved Category should have passed English as a language at 12th Standard exam.

The proof/certificate of passing of qualifying examination of 12th Standard (10+2 stream) must give particulars of the subject and also the percentage of marks obtained/grade awarded in the examination.

#### **Grades must indicate equivalent Percentage of Marks**

4. Candidates who have appeared in the qualifying examination of 12th Standard (10+2 stream) in Physics, Chemistry & Biology/Biotechnology Subject or equivalent examination thereof, can also apply, but they will have to produce proof of passing the qualifying examination with minimum 50% of aggregate marks in Physics, Chemistry & Biology/Biotechnology Subjects in case of candidates of Un-Reserved Category and with minimum 40% of aggregate marks in Physics, Chemistry & Biology/Biotechnology Subjects in case of candidates of Reserved Category (ST/SC/OBC) at the time of counseling.

Candidates of Reserved as well as Un-Reserved Category shall also produce proof of passing English as a language at 12th Standard exam and will also submit proof of passing Physics, Chemistry & Biology/Biotechnology Subjects separately at the time of counseling.

5. The candidates, who have passed their examination from outside India, will have to produce equivalent certificate from Association of Indian Universities, New Delhi, at the time of counseling, otherwise his/her candidature will not be considered.
6. **The candidate should have attained 17 years of age as on 31st Dec. 2014.**
7. **The upper age limit of candidates for admission under state NRI quota seats is 25 years as on 31st December of the year of his/her admission in the 1st year MBBS/BDS course.**

**Further provided that this upper age limit shall be relaxed by a period of 5 (Five) years for the Candidates of Scheduled Caste/Scheduled Tribe/Other Backward Classes.**

**NOTE.—All the certificates submitted should be in English.**

**Application (How to Apply)**

- (i) All applicants have to submit their applications online.
- (ii) Online applications will be accepted through M. P. Online website [www.mponline.gov.in](http://www.mponline.gov.in) Candidate must pay application fee Rs. 10000/- (Rs. Ten Thousand only) through mp online website.

- (iii) **Last date for online application is 30th June 2014 till 5:00 p.m. (I.S.T.) Applications submitted after last date will not be considered.**
- (iv) Candidate has also to submit a hard copy of the application form along with one set of photocopies of all the relevant documents to the Director of Medical Education, Govt. of M.P., Satpura Bhavan, 6th Floor, Bhopal. (M.P.)

**Security deposit & Fees :**

- (I) **Seat allotment shall be done only after deposition of demand draft for Security deposit of US \$ 3000 (Three thousand U. S. dollar) or equivalent in Indian rupees issued by Nationalized Bank in favour of Director Medical Education Madhya Pradesh Bhopal payable at Bhopal, by the candidate.**

**In case if the candidate does not take admission on the allotted seat in the allotted Medical College, his/her security deposit will not be refunded.**

- (II) **Security deposit shall also be non refundable for candidates who do not complete the course after taking admission on the allotted seat.**
- (III) **Security deposit shall be refunded back without any interest to the candidate after completion of the MBBS/BDS course, by the respective institution.**

**At the time of admission candidate has to deposit following fees in the form of Demand Draft of Nationalised Bank or through interest banking.**

- (1) Tuition fees is US\$ 12,000 (Twelve Thousand US\$) per year or equivalent Indian Rupees.
- (2) Hostel fee Rs. 10000/- (Ten Thousand) per year or equivalent US\$.
- (3) Caution Money US\$ 3000 (Three Thousand) or equivalent Indian Rupees (Same amount will be refunded in Indian Rupees after completion of course).
- (4) Student fund US\$ 1000 or equivalent in Indian rupees.
- (5) Other fee as per rule of concerned university/ college. Candidate has to deposit fee at the time of admission and all fees is to be paid in one installment every year as per rule in the concerned college.
- (6) If the duration of MBBS course is extended due to failing in any of the university examination or due to any other reason. The candidate shall be liable to pay extra fees for extended duration of the course.
- (7) No any type of exemption in fees shall be permitted to NRI Candidate.

**Candidate has to bring his / her all Original Documents and the desired Affidavit on stamp paper by Notary at the time of Counseling for verification & to ascertain his / her Eligibility by the Scrutiny Committee.**

**Candidates should also bring two sets of photocopies of all the relevant documents & 20 (Twenty) copies of colored photographs of the candidate of the similar type as affixed on the application form.**

**Seat - Allotment :—9th July, 2014. Venue-Directorate of Medical Education, Bhopal M. P. Satpura Bhavan, 6th Floor.**

1. Allotment of seats through counselling will be done based on category-wise merit list prepared on the basis of aggregate marks in Physics, Chemistry & Biology/Biotechnology subjects obtained in 10+2 or equivalent examination after verification of original documents.
2. Category wise separate merit lists of NRI candidates who are themselves Domicile/Bonafide resident of M. P. State of Children of Parents who are Domicile/Bonafide resident of M. P. State and of NRI candidates who are not Domicile/Bonafide resident of MP State shall be prepared.
3. Preference in seat allotment shall be given to NRI candidates who are themselves, Domicile/Bonafide resident of M. P. State of Children of Parents who are Domicile/Bonafide resident of M. P. State. counseling & Seat allotment will be done for Domicile/Bonafide resident of M. P. State Candidates only in the first round of Counseling.

In case of seats remaining vacant in UR category after allotment to NRI Candidates who are Domicile/Bonafide residents of M. P. State, these seats shall be made available to the eligible NRI candidates who are not Domicile/Bonafide resident of M.P. State according to merit list in the second round of counseling.

4. Reserved category seats (ST/SC/OBC) shall be allotted only to the reserved category candidates (ST/SC/OBC) of M. P. State as per merit list on submission of valid permanent caste certificate issued by competent authority of M. P. Govt. during first round of counseling.
5. Income certificate of current year (yr. 2013-14) issued by Tehsildar/Naib Tehsildar should be brought by O.B.C. candidates.
6. Reserved category seats (ST/SC/OBC) NRI candidates of States other than M.P. shall be considered in UR category.

**Seats remaining vacant, after counselling for NRI Seats, will be reverted back as per the existing reservation criteria. Seats reserved for ST/SC/OBC Categories shall not be converted in to UR category,** and these seats shall be added to M. P. State open seats, in their respective category only, counseling for which shall be held and notified separately. The candidate will have to deposit Rs. 5000/- (Rupees five thousand) towards counseling charges, at the time of counseling. Counseling Committee will consist of following members:—
