## MADHYA PRADESH BILL

No. 20 OF 2014.

**THE MADHYA PRADESH LOKAYUKT EVAM UP-LOKAYUKT (SANSHODHAN)  
VIDHEYAK, 2014****A Bill further to amend the Madhya Pradesh Lokayukt Evam Up-Lokayukt Adhiniyam, 1981.**

Be it enacted by the Madhya Pradesh Legislature in the sixty fifth Year of the Republic of India as follows:—

**Short title.**

1. This Act may be called the Madhya Pradesh Lokayukt Evam Up-Lokayukt (Sanshodhan) Adhiniyam, 2014.

**Amendment of section 5.**

2. In section 5 of the Madhya Pradesh Lokayukt Evam Up-Lokayukt Adhiniyam, 1981 (No. 37 of 1981), in sub-section (1),—

- (i) in the exiting first proviso, for the words "Provided that", the words "Provided further that" shall be substituted;
- (ii) in the existing second proviso, for the words "Provided further that", the words "Provided also that" shall be substituted;
- (iii) before the existing first proviso, the following proviso shall be inserted, namely:—

"Provided that the Lokayukt shall, notwithstanding the expiry of his term, continue to hold office until his successor is appointed and enters upon his office, but this extended period shall not in any case exceed one year:".

## STATEMENT OF OBJECTS AND REASONS

If the post of Lokayukt becomes vacant due to end of his tenure, the process of appintment of forthcoming Lokayukt naturally take time to complete. The vacancy in the office of Lokayukt has an adverse effect on the organizational work.

2. Therefore, in order to ensure the smooth functioning of the Lokayukt organization in the State it is necessary that Section 5 of the Madhya Pradesh Lokayukt Evam Up-Lokayukt Adhiniyam, 1981 (No. 37 of 1981) regarding the term of office of Lokayukt be amended suitably.

3. Hence this Bill.
