**THE MADHYA PRADESH APPROPRIATION (No. 4) BILL, 2015.**

**A Bill to provide for the authorization of appropriation of money out of the Consolidated Fund of the State of Madhya Pradesh to meet the amounts spent on certain services during the Financial Year ended on the 31st day of the March, 1998 in excess of the amounts granted for those services and for that year.**

Be it enacted by the Madhya Pradesh Legislature in the sixty-sixth year of the Republic of India as follows :—

1. This Act may be called the Madhya Pradesh Appropriation (No. 4) Act, 2015.

Short title.

Issue of Rs. 3,02,78,88,464 out of the Consolidated Fund of the State of Madhya Pradesh to meet certain excess expenditure for the year ended on 31st March, 1998.

2. From and out of the Consolidated Fund of the State of Madhya Pradesh, the sums specified in column (3) of the Schedule amounting in the aggregate to the sums of Three Hundred Two Crores Seventy Eight Lakhs Eighty Eight Thousands Four Hundred Sixty Four rupees shall be deemed to have been authorised to be paid and applied to meet the amount spent on defraying the charges in respect of the services specified in column (2) of the said Schedule during the financial year ended on the 31st day of March, 1998 in excess of the amounts granted for those services and that year.

Appropriation.

3. The sum deemed to have been authorized to be paid and applied from and out of the Consolidated Fund of the State of Madhya Pradesh under this Act shall be deemed to have been appropriated for the services and purposes expressed in the Schedule in relation to the financial year ended on the 31st day of March 1998.
