No. F 1 (1) 14-2012-C-XI.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Madhya Pradesh, hereby, makes the following further amendments in the Madhya Pradesh State Industries (Gazetted) Service Recruitment Rules, 1985, namely:-

AMENDMENTS

In the said rules,-

- 1. In rule 8, in sub-rule (1),-
- (i) in clause (c), in sub-clause (i), for the figure and word "38 years", the figure and word "40 years" shall be substituted.
- (ii) in clause (c), in sub-clause (ii), for the figure and word "38 years" the figure and words "40 years" shall be substituted.
- (iii) after Note (2), the following note shall be added, namely:-

"Note (3) In any case the maximum age limit in all classes shall not be more than 45 years after including all concessions provided in this clause. The maximum age shall be calculated in accordance with the General Administration Department Circular No. C-3-XI/12/1/13, dated 3-11-2012 and 20-11-2012."

- 2. For rule 9, the following rule shall be substituted, namely:-
 - "9. Disqualifications.-
- (1) Any attempt on the part of a candidate to obtain support for his candidature by any means may be held by the commission to disqualify him for appearing in the examination/selection.
- (2) A candidate shall be disqualified for appointment in the service who is married before the minimum age fixed for marriage.
- (3) A candidate shall be disqualified for appointment in the service who has more than two living children one of whom is born on or after 26th day of January, 2001:

Provided that such candidate shall not be disqualified for appointment in the service who has already one living child and next delivery takes on or after 26th day of January, 2001 in which two or more than two children are born.

(4) A candidate shall be disqualified for appointment in the service who has been convicted for an offence against women:

Provided that where such case is pending in a court against a candidate, his case of appointment shall be kept pending till the final decision the case.".

- 3. In rule 11, for sub-rule (3), the following sub-rule shall be substituted, namely:-
- "(3) 16% and 20% of the vacant posts available for direct recruitment shall be reserved for Scheduled Castes and Scheduled Tribes respectively and 14% shall be reserved for Other Backward Classes.".
