MADHYA PRADESH BILL**NO. 19 OF 2015****THE MADHYA PRADESH AYURVIGYAN PARISHAD (SANSHODHAN) VIDHEYAK , 2015**

A Bill to amend the Madhya Pradesh Ayurvedigyan Parishad Adhiniyam, 1987.

Be it enacted by the Madhya Pradesh Legislature in the sixty-sixth year of the Republic of India as follows:-

Short title and commencement.

1. (1) This Act may be called the Madhya Pradesh Ayurvedigyan Parishad (Sanshodhan) Adhiniyam, 2015.

(2) It shall come into force from the date of its publication in the Madhya Pradesh Gazette.

Amendment of section 4.

2. In Section 4 of the Madhya Pradesh Ayurvedigyan Parishad Adhiniyam, 1987 (No. 11 of 1990) (hereinafter referred to as the principal Act),-

(i) in sub-section (1), for clause (c), the following clause shall be substituted, namely:-

“(c) Commissioner, Medical Education, Madhya Pradesh.”;

(ii) in sub-section (2), for the words “Director of Medical Services”, the words “Commissioner, Medical Education, Madhya Pradesh” shall be substituted.

Amendment of Schedule.

3. In Schedule to the principal Act, after the existing entries, the following entries shall be added, namely:-

“Bundelkhand Medical College, Sagar	Bachelor of Medicine and Bachelor of Surgery	M.B.B.S.”.

STATEMENT OF OBJECTS AND REASONS

In the year 2009-10 admissions were given to students in first year of M.B.B.S. degree course in Bundelkhand Medical College, Sagar. These students have completed M.B.B.S. degree course in the year 2014 and have completed internship in the year 2015. Due to non-affiliation of Bundelkhand Medical College, Sagar with any of the State University, these M.B.B.S. pass students of Bundelkhand Medical College are facing problem of registration in Madhya Pradesh Ayurvedigyan Parishad. Hence for registration of M.B.B.S. pass student of Bundelkhand Medical College, Sagar in Madhya Pradesh Ayurvedigyan Parishad suitable amendment is proposed in the Schedule to the Madhya Pradesh Ayurvedigyan Parishad Adhiniyam, 1987 (No. 11 of 1990). Amendment of Section 4 is minor in nature which call for no explanation.

2. Hence this Bill.
