MADHYA PRADESH BILL No. 8 of 2016

THE MADHYA PRADESH VIDHAN SABHA SADASYA VETAN, BHATTA TATHA PENSION (SANSHODHAN) VIDHEYAK, 2016

A Bill further to amend the Madhya Pradesh Vidhan Sabha Sadasya Vetan, Bhatta Tatha Pension Adhiniyam, 1972.

Be it enacted by the Madhya Pradesh Legislature in the sixty-seventh year of the Republic of India as follows:—

Short title.

1. This Act may be called the Madhya Pradesh Vidhan Sabha Sadasya Vetan, Bhatta Tatha Pension (Sanshodhan) Adhiniyam, 2016.

Amendment of Section 3.

2. In Section 3 of the Madhya Pradesh Vidhan Sabha Sadasya Vetan, Bhatta Tatha Pension Adhiniyam, 1972 (No. 7 of 1973) (hereinafter referred to as the principal Act), for the words "ten thousand", the words "thirty thousand" shall be substituted.

Amendment of Section 4.

3. In Section 4 of the principal Act, for the words "twenty five thousand", the words "thirty five thousand" shall be substituted.

Substitution of Section 4-C.

4. For Section 4-C of the principal Act, the following Section shall be substituted, namely:—

Computer Operator / Orderly allowance.

"4-C. There shall be paid to every member a Computer Operator / Orderly allowance of fifteen thousand rupees per mensem.".

Deletion of Section 5.

5. Section 5 of the principal Act, shall be deleted.

Amendment of Section 5-A.

- 6. In Section 5-A of the Principal Act :-
 - (i) in sub-section (1), for the figure and word "6,000 kilometers", the figure and word "10,000 kilometers" shall be substituted;
 - (ii) in sub Section (3), for the words "three thousand", the words "four thousand" shall be substituted.".

Amendment of Section 6-A.

- 7. In Section 6-A of the principal Act, in sub-section (1),—
 - (i) in the first paragraph, for the words "fifteen thousand", the words "twenty thousand" shall be substituted:
 - (ii) in first proviso, for full stop, the colon shall be substituted and thereafter the following proviso shall be inserted namely:—

"Provided furthor that eight hundred rupees per month shall be added per year in pension.".

Amendment of Section 6-B.

8. In Section 6-B of the principal Act, for the words "ten thousand", the words "eighteen thousand" shall be substituted and for ful stop, the colon shall be substituted and thereafter the following proviso shall be addec, namely:—

"Provided that five hundred rupees per month shall be added per year in family pension.".

9. In Section 6-C of the principal Act, for the words "ten thousand", the words "fifteen thousand" shall be substituted.

Amendment of Section 6-C.

10. In Section 7 of the principal Act, in sub-section (1), for the words "five thousand", the words "ten thousand" shall be substituted.

Amendment of Section 7.

11. After Section 7 of the principal Act, the following Section shall be inserted, namely:—

insertion of Section 7-A.

"7-A. "There shall be paid ex-gratia of rupees five lakh to the dependant of deceased member.".

STATEMENT OF OBJECTS AND REASONS

Due to inflation in recent years, it has become necessary to enhance the salary, allowances, pension and other facilities given to members and ex-members of the Madhya Pradesh Legislative Assembly.
