THE MADHYA PRADESH GRAMO ME KI DAKHALRAHIT BHOOMI  
(VISHESH UPABANDH) SANSHODHAN VIDHEYAK, 2017.

**A Bill further to amend the Madhya Pradesh Gramo Me Ki Dakhalrahit Bhoomi  
(Vishesh Upabandh), Adhiniyam, 1970.**

Be it enacted by the Madhya Pradesh Legislature in the Sixty-eighth year of the Republic of India as follows :—

1. This Act may be called the Madhya Pradesh Gramo Me Ki Dakhalrahit Bhoomi (Vishesh Upabandh) Sanshodhan Adhiniyam, 2017. **Short title.**

2. In Section 3 of the Madhya Pradesh Gramo Me Ki Dakhalrahit Bhoomi (Vishesh Upabandh) Adhiniyam, 1970 (No. 26 of 1970) (hereinafter referred to as the principal Act), for the figures, letters and words “31st day of December, 2011”, the figures, letters and words “31st day of December, 2014”, shall be substituted. **Amendment of Section 3.**

3. In Section 5 of the principal Act, for the figures, letters and words “31st day of December, 2011”, the figures, letters and words “31st day of December, 2014”, shall be substituted. **Amendment of Section 5.**

## STATEMENT OF OBJECTS AND REASONS

It is provided in Section 3 of the Madhya Pradesh Gramo Me Ki Dakhalrahit Bhoomi (Vishesh Upabandh) Adhiniyam, 1970 (No. 26 of 1970) that all unoccupied lands in a village on which inhabitants of such village have, prior to the 31st day of December, 2011, erected any building for the purpose of residence, be allotted and settled with such inhabitants in Bhumiswami rights in accordance with the provisions of the said Act.

2. It has come to the notice of the State Government that several inhabitants of rural areas, who have been in possession of homestead after 31st day of December, 2011 on unoccupied land, could not get the Bhumiswami rights on such land. With a view to confer Bhumiswami rights to such inhabitants having homesteads in unoccupied land, it has been decided to amend the principal Act. Suitably.

3. Hence this Bill.
