## MADHYA PRADESH BILL

No. 16 OF 2017

**THE MADHYA PRADESH NIJI VISHWAVIDYALAYA (STHAPANA AVAM SANCHALAN) SANSHODHAN VIDHEYAK, 2017**

**A Bill further to amend the Madhya Pradesh Niji Vishwavidyalaya (Sthapana Avam Sanchalan) Adhiniyam, 2007.**

Be it enacted by the Madhya Pradesh Legislature in the sixty-eighth year of the Republic of India as follows:—

**Short title.**

1. This Act may be called the Madhya Pradesh Niji Vishwavidyalaya (Sthapana Avam Sanchalan) Sanshodhan Adhiniyam, 2017.

**Amendment of Schedule.**

2. In Schedule to the Madhya Pradesh Niji Vishwavidyalaya (Sthapana Avam Sanchalan) Adhiniyam, 2007 (No. 17 of 2007),—

(i) for serial number 2 and entries relating thereto, the following serial number and entries relating thereto shall be substituted, namely:—

3. (1) The Madhya Pradesh Niji Vishwavidyalaya (Sthapana Avam Sanchalan) Sanshodhan Adhyadesh, 2017 (No. 4 of 2017) is hereby repealed. **Repeal and saving.**

(2) Notwithstanding the repeal of the said Ordinance, anything done or any action taken under the said Ordinance shall be deemed to have been done or taken under the corresponding provision of this Act.

#### STATEMENT OF OBJECTS AND REASONS

As per the provisions of the Madhya Pradesh Niji Vishwavidyalaya (Sthapana Avam Sanchalan) Adhiniyam, 2007 (No. 17 of 2007), the D. C. University, Indore was established by an amendment Act, which was duly notified in the Madhya Pradesh Gazette (Extra-ordinary) dated 27<sup>th</sup> August, 2016. The Madhya Pradesh Private University Regulatory Commission, Bhopal in its letter dated 9<sup>th</sup> February, 2017 informed the State Government that the President, Daly College Society, Indore in her letter dated 22<sup>nd</sup> January, 2017 has requested the Commission that on account of challenging financial position, the Society has decided to call off the Setting up of the Private University project. As per the recommendation of the Commission, the D. C. University, Indore shall be wined up by omitting the name and description thereof in serial number 22 of the Schedule to the said Act.

2. In section 5 of principal Act, it is provided that the Regulatory Commission constituted under the Act shall evaluate the proposal of establishment of Private University in the State. In the light of the said provision, the Regulatory Commission has recommended to establish the Private Universities, namely, VIT Bhopal University, Bhopal-Indore National Highway, Kothri Kalan, Sehore and Sage University, Rau, Indore. In the light of section 6 of the said Act, the State Government have issued the letters of intent to the sponsoring bodies of the said Universities. with regard to the establishment of the said Universities Section 9 of the said Act provides that after being satisfied on considering the report submitted by the Regulatory Commission, Private University shall be established by incorporating the name and description thereof in the Schedule to the said Act.

3. As the matter urgent and the Madhya Pradesh Legislative Assembly was not in session, the Madhya Pradesh Niji Vishwavidyalaya (Sthapana Avam Sanchalan) Sanshodhan Adhyadesh, 2017 (No. 4 of 2017) was promulgated for the purpose. It is now proposed to replace the said Ordinance by an Act of State Legislature with modifications firstly, as to change of the name of AISECT University situated at village Mendua, Bhopal-Chiklod Road, Tehsil Goharganj, District Raisen, which was established in the year 2010 under the provisions of the principal Act, and the reason of change of its name is that the sponsoring body of the AISECT University is conducting various other academic activities in the name of AISECT, which creates confusion regarding name of the University. Therefore, to remove this confusion the name of AISECT University is to be changed to Rabindranath Tagore University. Secondly a new private University namely Renaissance University, Gram Reoti, Indore is also proposed to be establish, the proposal of which has been duly approved by the Regulatory Commission and the State Government.

4. Hence this Bill.
