THE MADHYA PRADESH AYURVIGYAN PARISHAD (SANSHODHAN) VIDHEYAK, 2019
A Bill further to amend the Madhya Pradesh Ayurvedic Parishad Adhiniyam, 1987.

Be it enacted by the Madhya Pradesh Legislature in the Seventieth year of the Republic of India as follows:—

Short title.

1. This Act may be called the Madhya Pradesh Ayurvedic Parishad (Sanshodhan) Adhiniyam, 2019.

Amendment of Section 29.

2. In Section 29 of the Madhya Pradesh Ayurvedic Parishad Adhiniyam, 1987 (No. 11 of 1990), in sub-section (1), for the words "Director of Medical Services", the words "Commissioner, Medical Education, Madhya Pradesh" shall be substituted.

STATEMENT OF OBJECTS AND REASONS

At the time of enactment of the Madhya Pradesh Ayurvedic Parishad Adhiniyam, 1987 (No. 11 of 1990), the Department of Medical Education was part of the Public Health and Family Welfare Department. In 1995, the Department of Medical Education was separated from the Department of Public Health and Family Welfare.

2. In the Madhya Pradesh Ayurvedic Parishad (Sanshodhan) Adhiniyam, 2015 (No. 9 of 2016) in sub-section (1) (c) and sub-section (2) of Section 4, the words "Director, Medical Services" was substituted by the words "Commissioner, Medical Education, Madhya Pradesh".

3. In the principal Act, sub-section (1) of Section 29, provides that under sub-section (1) of Section 3 of the principal Act till the constitution of State Medical Council "Director, Medical Services, Madhya Pradesh" shall be the special officer to exercise the powers and perform the functions of State Medical Council.

4. Due to findings on this anomaly as pointed out by the Hon'able High Court it has become necessary to substitute the words "Commissioner, Medical Education, Madhya Pradesh" in place of "Director, Medical Services, Madhya Pradesh".

5. Hence this Bill.
