**THE MADHYA PRADESH MAKHANLAL CHATURVEDI RASHTRIYA PATRAKARITA
AVAM SANCHAR VISHWAVIDYALAYA (SANSHODHAN) VIDHEYAK, 2019**

**A Bill further to amend the Madhya Pradesh Makhanlal Chaturvedi Rashtriya Patrakarita
Avam Sanchar Vishwavidyalaya Adhiniyam, 1990.**

Be it enacted by the Madhya Pradesh Legislature in the Seventieth year of the Republic of India as follows:—

1. (1) This Act may be called the Madhya Pradesh Makhanlal Chaturvedi Rashtriya Patrakarita Avam Sanchar Vishwavidyalaya (Sanshodhan) Adhiniyam, 2019. Short title and commencement.

(2) It shall come into force on such date as the State Government may, by notification, appoint. Amendment of Section 15.

2. In Section 15 of the Madhya Pradesh Makhanlal Chaturvedi Rashtriya Patrakarita Avam Sanchar Vishwavidyalaya Adhiniyam, 1990 (No. 15 of 1990), in sub-section (1),—

- (i) for clauses (vi) and (vii), the following clauses shall be substituted, namely:—
- “(vi) A Member of Parliament from Madhya Pradesh to be nominated by the State Government;
- (vii) A Member of Rajya Sabha from Madhya Pradesh to be nominated by the State Government;”;
- (ii) for clause (ix), the following clause shall be substituted, namely:—
- “(ix) One media representative each from three different States to be nominated by the Chief Minister of Madhya Pradesh;”;
- (iii) for clause (xiii), the following clause shall be substituted, namely:—
- “(xiii) An eminent public relation expert or an expert from the field of advertisement to be nominated by the State Government;”;
- (iv) for clause (xv), the following clause shall be substituted, namely:—
- “(xv) The Director General, Indian Institute of Mass Communication, New Delhi;”;
- (v) for clauses (xx), (xxi) and (xxii), the following clauses shall be substituted, namely:—
- “(xx) A senior journalist among five largest circulated daily Newspaper of Indian Language (other than Hindi Language) the circulation of which (including all combined editions) is certified by Registrar, Newspapers for India;
- (xxi) A senior journalist of the largest circulated Daily Hindi Newspaper of India the circulation of which (including all combined editions) is certified by Registrar, Newspapers for India;
- (xxii) The Additional Chief Secretary or any officer nominated by him not below the rank of a Secretary;”;
- (vi) for clause (xxv), the following clause shall be substituted, namely:—
- “(xxv) One senior expert from the field of entertainment communication to be nominated by the State Government;”;

- (vii) for clauses (xxvii), (xxviii) and (xxix), the following clauses shall be substituted, namely:—

“(xxvii) One eminent expert each from the following fields nominated by the State Government :—

- (a) Journalist of Television News Channel;
- (b) eminent expert of Computer or Information Technology;
- (c) distinguished expert of Social Media;
- (d) distinguished expert of Development Communication;

(xxviii) One eminent Hindi Media Professional from two different States to be nominated by the Chief Minister of Madhya Pradesh;

(xxix) A Vice-Chancellor of a University of Madhya Pradesh to be nominated by the State Government;”.

STATEMENT OF OBJECTS AND REASONS

The Madhya Pradesh Makhn Lal Chaturvedi Rashtriya Patrakarita Avam Sanchar Vishwavidyalaya Adhiniyam, 1990 (No. 15 of 1990) is in force since 28 years. In Section 15 of the aforesaid Act the provision for constitution of the General Council of the University has been provided. The General Council consist of many persons. The General Council is the supreme authority of the University.

2. Certain practical difficulties have been experienced in the implementation of the provisions of the Act. In order to obviate diffculties, the State Government has decided to revise certain provisions of Section 15 of the Act.

3. Hence this Bill.
