MADHYA PRADESH BILL

THE MADHYA PRADESH VISHWAVIDYALAYA (SANSHODHAN) VIDHEYAK, 2019**A Bill further to amend the Madhya Pradesh Vishwavidyalaya Adhiniyam, 1973.**

Be it enacted by the Madhya Pradesh Legislature in the seventieth year of the Republic of India as follows:—

Short title and commencement.

1. (1) This Act may be called the Madhya Pradesh Vishwavidyalaya (Sanshodhan) Adhiniyam, 2019.

(2) It shall come into force on the date of its publication in the Madhya Pradesh Gazette.

Amendment of Second Schedule.

2. In the Second Schedule to the Madhya Pradesh Vishwavidyalaya Adhiniyam, 1973 (No. 22 of 1973).

(i) in Part I, for serial numbers 2, 5 and 6 and entries relating thereto, the following serial numbers and entries relating thereto shall be substituted, namely:—

(ii) in Part II, after serial numbers 1 and entries relating thereto, the following serial number and entries relating thereto shall be added, namely:—

Repeal and saving.

3. (1) the Madhya Pradesh Vishwavidyalaya (Sanshodhan) Adhyadesh, 2019 (No. 4 of 2019) is hereby repealed.

(2) Notwithstanding the repeal of the said Ordinance, anything done or any action taken under the said Ordinance shall be deemed to have been done or taken under the corresponding provision of this Act.

STATEMENT OF OBJECTS AND REASONS

In order to give easy access of higher education for the youths living in Seoni, Chhindwara, Balaghat and Betul districts of the State, a new university is being established with its headquarter at Chhindwara.

2. At present the colleges in the district of Seoni, Chhindwara and Balaghat are affiliated to Rani Durgawati University, Jabalpur and those of Betul district are affiliated to Barkatullah University, Bhopal. The students of these districts have to travel for more than 200 km for the redressal of their university related problems. The establishment of university at Chhindwara will certainly help such students.

3. The establishment of University at Chhindwara is expected to help the significant number of tribal youths living in those districts to have easy access to quality education in the teaching departments of the proposed university. It will also help in improving the Gross Enrolments Ratio of the State.

4. The setting up a university at Chhindwara is likely to reduce the excessive burden on Rani Durgawati University, Jabalpur and Barkatullah University, Bhopal.

5. Therefore, in order to establish proposed new university suitable amendments are proposed in the Madhya Pradesh Vishwavidyalaya Adhiniyam, 1973 (No. 22 of 1973).

6. As the matter was urgent and the Madhya Pradesh Legislative Assembly was not in session, the Madhya Pradesh Vishwavidyalaya (Sanshodhan) Adhyadesh, 2019 (No. 4 of 2019) was promulgated for the purpose. It is now proposed to replace the said Ordinance by an Act of the State Legislature without any modification.

7. Hence this Bill.
