MADHYA PRADESH BILL

No. 15 OF 2019

THE MADHYA PRADESH LOK SEVA (ANUSUCHIT JATIYON, ANUSUCHIT JAN JATIYON AUR ANYA PICHHADE VARGON KE LIYE ARAKSHAN) SANSHODHAN VIDHEYAK, 2019

A Bill further to amend the Madhya Pradesh Lok Seva (Anusuchit Jatiyon, Anusuchit Jan Jatiyon Aur Anya Pichhade Vargon Ke Liye Arakshan) Adhiniyam, 1994.

Be it enacted by the Madhya Pradesh Legislature in the seventieth year of the Republic of India as follows:-

Short title.

1. This Act may be called the Madhya Pradesh Lok Seva (Anusuchit Jatiyon, Anusuchit Jan Jatiyon Aur Anya Pichhade Vargon Ke Liye Arakshan) Sanshodhan Adhiniyam, 2019.

Amendment of Section 4.

2. In Section 4 of the Madhya Pradesh Lok Seva (Anusuchit Jatiyon, Anusuchit Jan Jatiyon Aur Anya Pichhade Vargon Ke Liye Arakshan) Adhiniyam, 1994 (No. 21 of 1994), in sub-section (2), in Clause (i),—

- (i) in sub-Clause (a), for the words and figure “Other Backward Classes 14 percent”, the words and figure “Other Backward Classes 27 percent” shall be substituted.
- (ii) in sub-Clause (b), for the words and figure “Other Backward Classes 14 percent”, the words and figure “Other Backward Classes 27 percent” shall be substituted.

Repeal and saving.

3. (1) The Madhya Pradesh Madhya Pradesh Lok Seva (Anusuchit Jatiyon, Anusuchit Jan Jatiyon Aur Anya Pichhade Vargon Ke Liye Arakshan) Sanshodhan Adhyadesh, 2019 (No. 2 of 2019), is hereby repealed.

(2) Notwithstanding the repeal of the said Ordinance, anything done or any action taken under the said Ordinance shall be deemed to have been done or taken under the corresponding provision of this Act.

STATEMENT OF OBJECTS AND REASONS

The Other Backward Classes are 27 percent of the total population of Madhya Pradesh. This category is socially and financially backward. The State Government has prepared some schemes for the upliftment of this category, even then the said category could not be socially and financially uplifted.

2. Therefore, it is decided to enhance the provision of reservation of vacancies in public services and posts for Other Backward Classes from 14 percent to 27 percent by suitable amendment in section 4 of the Madhya Pradesh Lok Seva (Anusuchit Jatiyon, Anusuchit Jan Jatiyon Aur Anya Pichhade Vargon Ke Liye Arakshan) Adhiniyam, 1994 (No. 21 of 1994).

3. As the matter was urgent and the Madhya Pradesh Legislative Assembly was not in session, the Madhya Pradesh Lok Seva (Anusuchit Jatiyon, Anusuchit Jan Jatiyon Aur Anya Pichhade Vargon Ke Liye Arakshan) Sanshodhan Adhyadesh, 2019 (No. 2 of 2019) was promulgated for the purpose. It is now proposed to replace the said Ordinance by an Act of the State Legislature without any modification.

4. Hence this Bill.
