**THE MADHYA PRADESH SINCHAI PRABANDHAN ME KRISHKON KI
BHAGIDARI (SANSHODHAN) VIDHEYAK, 2019**

A Bill further to amend the Madhya Pradesh Sinchai Prabandhan Me Krishkon Ki Bhagidari Adhinyam, 1999.

Be it enacted by the Madhya Pradesh Legislature in the seventieth year of the Republic of India as follows:-

- Short title and commencement.** 1. (1) This Act may be called the Madhya Pradesh Sinchai Prabandhan Me Krishkon Ki Bhagidari (Sanshodhan) Adhinyam, 2019.
2. In shall be deemed to have come into force from the 8th day of March, 2019.
- Amendment of Section 4.** 2. In Section 4 of the Madhya Pradesh Sinchai Prabandhan Me Krishkon Ki Bhagidari Adhinyam, 1999 (No. 23 of 1999), in sub-section (3), in the existing proviso, for full stop, colon shall be substituted and thereafter the following proviso shall be inserted, namely:—
- “Provided further that on expiry of term of office of members, if the managing committee is not reconstituted, the State Government may, by notification, extend the term of office of the members for further period of six months, from the date of such expiration, recording the reason for such extension. After election this extended period shall be adjusted in the period as specified in sub-section (3) and sub-section (7).”.
- Repeal and saving.** 3.(1) The Madhya Pradesh Sinchai Prabandhan Me Krishkon Ki Bhagidari (Dwitiya Sanshodhan) Adhyadesh, 2019 (No. 5 of 2019) is hereby repealed.
- (2) Notwithstanding the repeal of the said Ordinance, anything done or any action taken under the said Ordinance shall be deemed to have been done or taken under the corresponding provision of this Act.

STATEMENT OF OBJECTS AND REASONS

In sub-section (3) and sub-section (7) of Section 4 of the Madhya Pradesh Sinchai Prabandhan Me Krishkon Ki Bhagidari Adhinyam, 1999 (No. 23 of 1999), it is provided that the President and the members of the managing committee of water users' association shall if not recalled or removed, be in office for a term of six years from the date of appointment.

2. After enforcement of the Act, election for 1765 water user's associations was conducted and the notification of appointment of competent authority is issued on 4 January, 2017 in the official Gazette. The term of office of the chairmen of these water users' association and one third member of 5120 territorial constituencies had been expiring on 3 January, 2019, but in compliance of Ordinance No. 3 of 2019 dated 8th March, 2019, the term of office was extended for period of six months from the expiration dated 3 January, 2019, by the departmental notification No. 32-18-201-medium-145 dated 9 April, 2019, which will be expired on 3 July, 2019, and due to the retirement of one third members of 360 territorial constituencies of 93 water user's associations and Chairmen thereof on 3 July, 2019. This all 1765+93=1858 institutions will be ineffective. Therefore, it is necessary that the term of said all institutions be further extend for the period of six months. After election this extended period shall be adjusted as specified in sub-section (3) and sub-section (7) of Section 4.

3. As the matter was urgent and the Madhya Pradesh Legislative Assembly was not in session, the Madhya Pradesh Sinchai Prabandhan Me Krishkon Ki Bhagidari (Dwitiya Sanshodhan) Adhyadesh, 2019 (No. 5 of 2019) was promulgated for the purpose. It is now proposed to replace the said Ordinance by an Act of the State Legislature without any modification.

4. Hence this Bill.
