No. 20 OF 2019

THE MADHYA PRADESH PUBLIC HEALTH (AMENDMENT) BILL, 2019

A Bill further to amend the Madhya Pradesh Public Health Act, 1949.

Be it enacted by the Madhya Pradesh Legislature in the seventieth year of the Republic of India as follows:-

Short title.	1. This Act may be called the Madhya Pradesh Public Health (Amendment) Act, 2019.
Deletion of Section 79.	2. Section 79 of the Madhya Pradesh Public Health Act, 1949 (No. 36 of 1949) (hereinafter referred to as principal Act) shall be deleted.
Deletion of Section 80.	3. Sections 80 of the Principal Act shall be deleted.
Deletion of Section 81.	4. Section 81 of the principal Act shall be deleted.
Deletion of Section 82.	5. Section 82 of the principal Act shall be deleted.
Deletion of Section 83.	6. Section 83 of the principal Act shall be deleted.

STATEMENT OF OBJECTS AND REASONS

In Writ Petition (Civil) No. 1151/2017 Vidhi Centre for Legal Policy versus Union of India and others, pending in the Supreme Court of India, the issue pertains to abolition/ amendment of various States and Central enactment where persons suffering from leprosy have been treated in discriminatory manner, despite leprosy is now a curable disease. In this regard Sections 79 to 83 of the Madhya Pradesh Public Health Act, 1949 (No. 36 of 1949) have been identified which contains discriminatory provisions in regard to leprosy patients. Therefore, it is decided to make suitable amendments.

2. Hence this Bill.
