MADHYA PRADESH BILL

No. 22 OF 2019

THE MADHYA PRADESH APPROPRIATION (No. 5) BILL, 2019

A Bill to provide for the authorization of appropriation of money out of the Consolidated Fund of the State of Madhya Pradesh to meet the amounts spent on certain services during the financial year ended on the 31st day of the March, 2009 in excess of the amounts granted for those services and for that year.

Be it enacted by the Madhya Pradesh Legislature in the Seventieth year of the Republic of India as follows:—

Short title.

1. This Act may be called the Madhya Pradesh Appropriation (No. 5) Act, 2019

Issue of Rs. 5,79,25,773 out of the Consolidated Fund of the State of Madhya Pradesh to meet certain excess expenditure for the year ended on 31st March, 2009.

2. From and out of the Consolidated Fund of the State of Madhya Pradesh the sums specified in column (3) of the Schedule amounting in the aggregate to the sum of Five crore seventy-nine lakh twenty five thousand seven hundred seventy three rupees shall be deemed to have been authorised to be paid and applied to meet the amount spent on defraying the charges in respect of the services specified in column (2) of the said Schedule during the financial year ended on the 31st day of March, 2009 in excess of the amounts granted for those services and for that year.

Appropriation.

3. The sums deemed to have been authorized to be paid and applied from and out of the Consolidated Fund of the State of Madhya Pradesh under this Act shall be deemed to have been appropriated for the services and purposes expressed in the Schedule in relation to the financial year ended on the 31st day of March, 2009.

STATEMENT OF OBJECTS AND REASONS

This Bill is introduced in pursuance of article 204(1) of the Constitution of India, read with article 205 thereof, to provide for the appropriation out of the Consolidated Fund of the State of Madhya Pradesh of the moneys required to meet the expenditure incurred in excess of the appropriation charged on the fund and grants made by the Legislative Assembly for the expenditure of the State Government for the financial year ended on the Year 31st day of March, 2009.
