**THE MADHYA PRADESH VISHWAVIDYALAYA (DWITIYA SANSHODHAN)
VIDHEYAK, 2019**

A Bill further to amend the Madhya Pradesh Vishwavidyalaya Adhiniyam, 1973.

Be it enacted by the Madhya Pradesh Legislature in the Seventieth year of the Republic of India as follows:—

Short title and commencement.

1. (1) This Act may be called the Madhya Pradesh Vishwavidyalaya (Dwitiya Sanshodhan) Adhiniyam, 2019.

(2) It shall come into force from the date of its publication in the Madhya Pradesh Gazette.

Amendment of Section 13.

2. In Section 13 of the Madhya Pradesh Vishwavidyalaya Adhiniyam, 1973 (No. 22 1973),—

(i) in sub-section (2), for clause (i), the following clause shall be substituted, namely :—

"(i) one person nominated by the State Government;"

(ii) in sub-section (3), for the words "Executive Council", the words "State Government" shall be substituted.

STATEMENT OF OBJECTS AND REASONS

In sub-section (2) of Section 13 of the Madhya Pradesh Vishwavidyalaya Adhiniyam, 1973 (No. 22 1973) presently there is a provision of appointment of regular Kulpati through the Committee. In the Universities established under the said Act, there is no role of the State Government for appointment of regular Kulpati, whereas the State Government is directly responsible for determination of policy for successful conduct of the Universities and also makes the financial provision for the Universities. The State Government is directly responsible to the public for the matters relating to the Universities. To ensure the good governance in the Universities, it is proposed to make suitable amendment in Section 13 of the said Act.

2. Hence this Bill.
