**THE MAHARSHI PANINI SANSKRIT VISHWAVIDYALAYA
(SANSKODHAN) VIDHEYAK, 2019**

A Bill further to amend the Maharshi Panini Sanskrit Vishwavidyalaya Adhiniyam, 2006.

Be it enacted by the Madhya Pradesh Legislature in the Seventieth year of the Republic of India as follows:—

Short title and commencement.

1. (1) This Act may be called the Maharshi Panini Sanskrit Vishwavidyalaya (Sanshodhan) Adhiniyam, 2019.

(2) It shall come into force from the date of its publication in the Madhya Pradesh Gazette.

Amendment of Section 28.

2. In Section 28 of the Maharshi Panini Sanskrit Vishwavidyalaya Adhiniyam, 2006 (No. 15 of 2008),—

(i) in sub-section (2), for clause (i), the following clause shall be substituted, namely :—

"(i) one person nominated by the State Government;"

(ii) in sub-section (3), for the words "Executive Council", the words "State Government" shall be substituted.

STATEMENT OF OBJECTS AND REASONS

In sub-section (2) of Section 28 of the Maharshi Panini Sanskrit Vishwavidyalaya Adhiniyam, 2006 (No. 15 of 2008) presently there is a provision of appointment of regular Vice-Chancellor through the Committee. In the Maharshi Panini Sanskrit Vishwavidyalaya, there is no role of the State Government for appointment of regular Vice-Chancellor, whereas the State Government is directly responsible for determination of policy for successful conduct of the University and also makes the financial provision for the University. The State Government is directly responsible to the public for the matters relating to the University. To ensure the good governance in the University, it is proposed to make suitable amendment in Section 28 of the said Act.

2. Hence this Bill.
