**THE MADHYA PRADESH ZILA YOJANA SAMITI  
(SANSHODHAN) VIDHEYAK, 2019**

**A Bill Further to amend the Madhya Pradesh Zila Yojana Samiti Adhiniyam, 1995.**

Be it enacted by the Madhya Pradesh Legislature in the seventieth year of the Republic of India as follows :—

Short title.

1. This Act may be called the Madhya Pradesh Zila Yojana Samiti (Sanshodhan) Adhiniyam, 2019.

Amendment of Section 4.

2. In Section 4 of the Madhya Pradesh Zila Yojana Samiti Adhiniyam, 1995 (No. 19 of 1995) (hereinafter referred to as the principal Act),-

(i) for sub-section (1), the following sub-section shall be substituted, namely:-

“(1) The Committee shall consist of twenty members in each district.

**Explanation.-** The elected and nominated members in the existing Committee prior to the commencement of the Madhya Pradesh Zila Yojana Samiti (Sanshodhan) Adhiniyam, 2019 shall continue to be members of the Committee till the expiry of their current term.”;

(ii) in sub-section (3), for clause (c), the following clause shall substituted, namely:-

“(c) two members to be nominated by the State Government.”;

(iii) for sub-section (4), the following sub-section shall be substituted, namely:-

“(4) The members nominated under clause (c) of sub-section (3) shall hold office for a term of two years and shall be eligible for re-nomination. However, no such member shall hold office for a continuous period of more than five years. The State Government in its discretion may terminate the nomination of these members any time prior to the expiry of their term.

**Explanation.-** The nominated members in the existing Committee prior to the commencement of the Madhya Pradesh Zila Yojana Samiti (Sanshodhan) Adhiniyam, 2019 shall continue to be members of the Committee till the expiry of their current term.”.

Amendment of Section 5.

3. In Section 5 of the principal Act, in sub-section (1), after clause (b), the following new clauses shall be added, namely:-

“(c) Two persons of prominence who are resident of the concerned district, to be nominated by the In-charge Minister (nominated by the State Government as provided in clause (a) of sub-section (3) of Section 4 shall be permanent special invitees to the meetings of the Committee.

(d) The invitees nominated under clause (c), shall hold office for a term of two years and shall be eligible for re-nomination. However, no such member shall hold office for a continuous period of more than five years. The State Government in its discretion may terminate the nomination of these members any time prior to the expiry of their term.”.

4. In Section 9 of the principal Act, in sub-section (2), the following new clause and ex-planation shall be added, namely:- Amendment of Section 9.

(iii) carry out any other functions assigned to it by the Committee.

**Explanation.-** The Sub-Committees may be constituted for such functions only, which are within the powers so entrusted to the Committee by the State Government.”.

5. The Schedule to the principal Act is deleted.

Deletion of Schedule.

### STATEMENT OF OBJECTS AND REASONS

The Madhya Pradesh Zila Yojana Samiti Adhiniyam, 1995 (No. 19 of 1995) provides to form District Planning Committees in accordance with article 243-ZD of the Constitution of India and to discharge the functions of the State Government in regard to the items of the business of the State Government.

2. The State Government intends to make District Planning Committees more efficient to conduct their business, so the concept of decentralization of powers of State Government to the District level is materialized in the real sense. For this purpose the amendments are being proposed to—

- (i) increase the number of members in the Committee, to twenty in place of existing provision of ten, fifteen and twenty as per the Schedule appended to the Act;
- (ii) nominate two persons of prominence from the district as permanent special invitees by the In-charge Minister. This shall facilitate bringing in expertise from the persons of repute in the district to the District Planning Committee;
- (iii) form Sub-Committees for carrying out any specific activity assigned by the District Planning Committee.

3. Hence this Bill.
