**THE MADHYA PRADESH NIJI VISHWAVIDYALAYA (STHAPANA AVAM
SANCHALAN) SANSHODHAN VIDHEYAK, 2021**

A Bill further to amend the Madhya Pradesh Niji Vishwavidyalaya (Sthapana Avam Sanchalan) Adhinyam, 2007.

Be it enacted by the Madhya Pradesh Legislature in the seventy-second year of the Republic of India as follows:—

Short title.

1. This Act may be called the Madhya Pradesh Niji Vishwavidyalaya (Sthapana Avam Sanchalan) Sanshodhan Adhinyam, 2021.

Amendment of Schedule.

2. In Schedule to the Madhya Pradesh Niji Vishwavidyalaya (Sthapana Avam Sanchalan) Adhinyam, 2007 (No. 17 of 2007), after serial number 37 and entries relating thereto, the following serial numbers and entries relating thereto shall be added, namely:—

Repeal and saving.

3.(1) The Madhya Pradesh Niji Vishwavidyalaya (Sthapana Avam Sanchalan) Sanshodhan Adhyadesh, 2020 (No. 14 of 2020) and the Madhya Pradesh Niji Vishwavidyalaya (Sthapana Avam Sanchalan) Dwitiya Sanshodhan Adhyadesh, 2020 (No. 11 of 2021) is hereby repealed.

(2) Notwithstanding the repeal of the said Ordinances, anything done or any action taken under the said Ordinances shall be deemed to have been done or taken under the corresponding provisions of this Act.

STATEMENT OF OBJECTS AND REASONS

In Section 5 of the Madhya Pradesh Niji Vishwavidyalaya (Sthapana Avam Sanchalan) Adhiniyam, 2007 (No. 17 of 2007), it is provided that the Regulatory Commission constituted under the Act shall evaluate the proposal of establishment of Private University in the State. In the light of the said provision, the Regulatory Commission has recommended to establish the Private Universities, namely, Eklavya University, Damoh, Sri Aurobindo University, Indore and Mahakaushal University, Jabalpur. In the light of Section 6 of the said Act, the State Government have issued letters of intent to the sponsoring bodies of the Universities, with regard to establishment of the said Universities. Section 9 of the said Act provides that after being satisfied on considering the report submitted by the Regulatory Commission, Private University shall be established by incorporating the name and description thereof in the Schedule to the said Act.

2. As the matter was urgent and the Legislative Assembly was not in session, the Madhya Pradesh Niji Vishwavidyalaya (Sthapana Avam Sanchalan) Sanshodhan Adhyadesh, 2020 (No. 14 of 2020) and the Madhya Pradesh Niji Vishwavidyalaya (Sthapana Avam Sanchalan) Dwitiya Sanshodhan Adhyadesh, 2020 (No. 11 of 2021) were promulgated for the purpose. It is now proposed to replace the said Ordinances by an Act of the State Legislature without any modification.

3. Hence this Bill.
