## MADHYA PRADESH BILL

No. 25 OF 2021

**THE MAHATMA GANDHI CHITRAKOOT GRAMODAYA VISHWAVIDYALAYA  
(SANSHODHAN) VIDHEYAK, 2021**

A Bill further to amend the Mahatma Gandhi Chitrakoot Gramodaya Vishwavidyalaya Adhiniyam, 1991.

Be it enacted by the Madhya Pradesh Legislature in the seventy-second year of the Republic of India as follows :—

**Short title and commencement.**

1. (1) This Act may be called the Mahatma Gandhi Chitrakoot Gramodaya Vishwavidyalaya (Sanshodhan) Adhiniyam, 2021.

(2) It shall come into force from the date of its publication in the Madhya Pradesh Gazette.

**Amendment of Section 11.**

2. In Section 11 of the Mahatma Gandhi Chitrakoot Gramodaya Vishwavidyalaya Adhiniyam, 1991 (No. 9 of 1991),—

(i) in sub-section (1),—

(a) in clause (1), for the word “Chancellor”, the word “Vice-Chancellor” shall be substituted;

(b) in clause (3), the words “Vice-Chancellor and” shall be omitted;

(ii) in sub-section (2), for the word “Chancellor”, the word “Vice-Chancellor” shall be substituted.

## STATEMENT OF OBJECTS AND REASONS

At present it is provided in clause (1) of sub-section (1) of Section 11 of the Mahatma Gandhi Chitrakoot Gramodaya Vishwavidyalaya Adhiniyam, 1991 (No. 9 of 1991) that the Chancellor shall be the ex-officio Chairman of the Board. Whereas it is provided in all Government Universities, that the Vice-Chancellor of the concerning University is the Chairman of the Executive Council/Board. Therefore, as per all the Acts of Government Universities, it is proposed to amend Section 11 of the Principal Act suitably.

2. Hence this Bill.
