**THE MADHYA PRADESH KASHTHA CHIRAN (VINIYAMAN)
SANSHODHAN VIDHEYAK, 2021**

A Bill Further to amend the Madhya Pradesh Kashtha Chiran (Viniyaman) Adhiniyam, 1984.

Be it enacted by the Madhya Pradesh Legislature in the seventy-second year of the Republic of India as follows :—

Short title

1. This Act may be called the Madhya Pradesh Kashtha Chiran (Viniyaman) Sanshodhan Adhiniyam, 2021.

Amendment of Section 4.

2. In section 4 of the Madhya Pradesh Kashtha Chiran (Viniyaman) Adhiniyam, 1984. (No. 13 of 1984), in clause (a), in the existing proviso, for semi-colon, colon shall be substituted and thereafter the following new provisos shall be inserted, namely :—

"Provided further that in areas other than prohibited areas such industries or processing plants which do not use round logs of wood of domestic origin ro which operate without a band saw or re-saw or circular saw of more than thirty centimeter diameter, shall not require license:

Provided further that such industries or processing plants which use:

- (i) sawn timber, cane, bamboo, reed, plywood, veneers or imported wood;
- (ii) block board, medium density fiber-board or similar wood-based products;
- (iii) round log or timber from species exempted from the purview of felling and transit regime in the State,

shall not require license:

Provided also that such industries or processing plants exempted from licensing shall operate in a fixed premises and maintain records in such manner as may be prescribed by the State Government;".

STATEMENT OF OBJECTS AND REASONS

In compliance of directions contained in the order dated 5th October, 2015 of the Hon'ble Supreme Court of India in Writ Petition (Civil) No. 202 of 1995, T. N. Godavarman Thirumulpad versus Union of India and others, the Ministry of Environment, Forest and Climate Change, Government of India vide resolution dated 11th November, 2016 had issued Wood Based Industries (Establishment and Regulation) Guidelines, 2016 and in resolution dated 11th September, 2017, in point No. 6(ii), the following provision has been made:—

In areas other than prohibited areas such industries or processing plants do not use round logs of domestic origin or which operate without a band saw or re-saw or circular saw of more than thirty centimeter diameter, shall not require license.

Such Industries or processing plants which use :—

- a. sawn timber, cane, bamboo, reed, plywood, veneers or imported wood;

b. block board, medium density fiber-board or similar wood-based products;

c. round log or timber from species exempted from the purview of felling and transit regime in the State,

shall not require license:

2. Therefore, as per the guidelines issued by the Government of India, Ministry of Environment, Forest and Climate Change and to provide relief to small carpenters, who use cutters for finishing and fashioning of wood based products and to promote wood based industries, it has been decided to make suitable amendment in section 4 of the Madhya Pradesh Kashtha Chiran (Viniyaman) Adhiniyam, 1984. (No. 13 of 1984),

3. Hence this Bill.
