**NANAJI DESHMUSKH PASHU CHIKITSA VIGYAN VISHWAVIDYALAYA  
(SANSHODHAN) VIDHEYAK, 2021**

A Bill Further to amend Nanaji Deshmukh Pashu Chikitsa Vigyan Vishwavidyalaya Adhiniyam, 2009.

Be it enacted by the Madhya Pradesh Legislature in the seventy-second year of the Republic of India as follows :—

**Short title** 1. This Act may be called Nanaji Deshmukh Pashu Chikitsa Vigyan Vishwavidyalaya (Sanshodhan) Adhiniyam, 2021.

**Amendment of Section 11.** 2. In section 11 of Nanaji Deshmukh Pashu Chikitsa Vigyan Vishwavidyalaya Adhiniyam, 2009 (No. 16 of 2009), in sub-section (3), for the opening paragraph and the first proviso, the following opening paragraph and first proviso shall be substituted, namely :—

"The Vice-Chancellor shall hold office for a period of five years and shall be eligible for reappointment for a further period of five years or until he attains the age of seventy years, whichever is earlier :

Provided that no person shall hold the office of the Vice-Chancellor for more than ten years in the aggregate."

**STATEMENT OF OBJECTS AND REASONS**

In order to extend the tenure of Vice-Chancellor from four years to five years, which may further be extended from four years to five years but which may not be more than ten years in aggregate, suitable amendments are proposed in section 11 of Nanaji Deshmukh Pashu Chikitsa Vigyan Vishwavidyalaya Adhiniyam, 2009 (No. 16 of 2009), so that it may be similar to the provisions of Acts of Jawaharlal Nehru Krishi Vishwavidyalaya, Jabalpur and Rajmata Vijaya Raje Scindia Krishi Vishwavidyalaya, Gwalior.

2. Hence this Bill.
