No. F 4-5/2018/29-1, The State Government, in exercise of powers conferred by Section 3, read with section 5 of the Essential Commodities Act, 1955 (No. 10 of 1955) and G.S.R. 800 dated 09th June, 1978 of the Central Ministry of Agriculture and Cooperation (Department of Food), and Government of India order S.O. 1509(E) dated the 30th March, 2022 as the State Government is of the opinion that it is necessary and expedient to do so to ensure the availability of edible oils and oilseeds at reasonable prices, hereby, makes the following order, namely:-

1. Short title, extent and commencement-

- (i) The short name of this order is Madhya Pradesh Edible Oils and Oilseeds Trader (Control) Order, 2022.
- (ii) It extends to all over Madhya Pradesh.
- (iii) This order shall come into force from the date of its publication in the Gazette of Madhya Pradesh and shall be in force till the 31st December, 2022 or such period as may be prescribed by the Government of India in this behalf.

2. Definitions-

In this order, unless the context otherwise requires -

- (a) "Trader" means a person or his representative including "wholesaler", "retailer", "refiner". "miller", "commission agent", "extractor", "importer", "exporter", who at a time worked as a trader of scheduled commodities purchase, sale or purchase of edible oil/oilseeds mentioned in Schedule- "I" collects of intend to sell, excluding the stock of edible oil/oilseeds produced by him for personal cultivation.
- (b) "Commission agent" means a person or his representative engaged in the business of purchase, sale and storage for sale on commission on behalf of another person.
- (c) "Miller" means a person or his representative who processes anyone or all of the oilseeds of commodities mentioned in Schedule-I.
- (d) "Refiner" means a person or dealer who refines the oil.
- (e) "Extractor" means a person or his representative who extracts oil from one or all the oilseeds specified in Schedule-I.
- (f) "Importer" means a person or his representative who imports edible oil/oilseeds mentioned in Schedule-I.
- (g) "Exporter" means a person or his representative who exports edible oil/oilseeds mentioned in Schedule-I.
- (h) "Mandi" means the Mandi as specified in the Madhya Pradesh Krishi Upaj Mandi Act, 1972 (No. 24 of 1973).
- (i) "State Government" means the Government of Madhya Pradesh.
- (j) "Schedule" means the schedule annexed to this Order.
- (k) "Form" means the Form annexed to this Order.

3. Maximum Stock Limit

No trader or his agent or servant or any other person acting on his behalf shall store stock in respect of edible oil/oilseeds in excess of the maximum stock limit prescribed in Schedule-II of this Order; provided that if the time period specified by the Government of India or the maximum stock limit is amended, accordingly, the time period and stock limit shall come into force in the state from the date of notification by the Government of India.

4. Exemption in determination of stock limit and calculation of edible oil/oilseeds

While computing the available stock of edible oil/oilseeds with a trader, the stock held with the following traders for the following purposes will not be included in the total stock calculation.

- (a) If an exporter, who is a refiner, miller, extractor, wholesaler or retailer or dealer, having an Importer-Exporter Code number issued by the Directorate General of Foreign Trade, is competent to show that his whole stock or part of his stock in respect of edible oil/oilseeds is within the limits of stock for the purpose of export.
- (b) If an importer who is a refiner, miller, extractor, wholesaler or retailer or dealer, is competent to show that in respect of edible oil/oilseeds, a part of his stock is derived from imports.

5. Restriction on trade in edible oil/oilseeds:

- (a) Every dealer by whom the edible oil/oilseeds mentioned in Schedule-I is stored for purchase and sale, shall maintain the relevant accounts of the purchase, sale and storage, including the daily stock register, true invoices of purchase, sale and Mandi receipt in the prescribed Form 'A'. and shall produce it at the time of inspection on demand.
- (b) Every trader shall physically deal in edible oil/oilseeds and shall not deal in a speculative manner which would adversely affect its easy availability in the Mandi.
- (c) Every trader shall display at the entrance of the premises of his business or at any other conspicuously prominent place a board of the stock of edible oil/oilseeds kept for sale.

- legibly written in Devanagari script, including the different varieties of edible oil/oilseeds for each day, and the opening stock of oil/oilseeds separately.
- (d) No trader shall refuse to sell the stored edible oil/oilseeds.
- (e) If the edible oil/oilseeds stock held by the concerned legal entities is more than the prescribed limit, the same shall be declared by them on the portal of Department of Food and Public Distribution (https://evegoils.nic.in) and it shall be brought to the stock limit prescribed in this control order within 30 days from the date of issue of the notification.
- (f) The stock of edible oil/oilseeds will be declared regularly and updated on the portal of Department of Food and Public Distribution, Government of India (https://evegoils.nic.in)

6. Violation of order-

No dealer or his agent or servant or any other person acting on his behalf shall violate any provision of this Order.

7. Powers of entry, search and seizure, etc-

- (i) In order to ensure due compliance of the provisions of this order, Additional Chief Secretary/Principal Secretary/Secretary/Commissioner/Director, Food Civil Supplies and Consumer Protection, Madhya Pradesh or any officer authorized by him within the state limits and Additional Director / Joint Director / Deputy Director / Assistant Director / Assistant Supply Officer / Junior Supply Officer, Directorate of Food Civil Supplies and Consumer Protection, Madhya Pradesh within the limits of the state and Collector, Additional Collector, Joint Collector, Deputy Collector, Tehsildar, District Supply Controller, District Supply Officer, Assistant Supply Officer, Junior Supply Officer within the limits of the district with such assistance, if any, as he may deem fit-
 - (1) Require any person other than the owner, occupier or person in charge of any place, premises, vehicle or ship in respect of which he has reason to believe that a contravention of this Order or the provisions thereof has been, is being or is about to be done, to produce books, accounts or other records showing the transactions relating to such contravention.
 - (2) Enter, inspect or open or search any place, premises, vehicle or ship in respect of which he has reason to believe that the contravention of any of the provisions of this order has been done, is being or is about to be done.
 - (3) Seize or cause to be seized the register, bill book or any document showing the transactions relating to such contravention
 - (4) Search and seize the stock of edible oil/oilseeds and animals, vehicles, ships or other vehicles used for carrying the said edible oil/oilseeds in contravention of the provisions of this Order, and remove them and thereafter to take or authorize to do all such measures as may be necessary for the purpose of ensuring the production of edible oil/oilseeds stocks and animals, vehicles, ships or other vehicles before a competent court and for their safe custody till such production is made.
- (ii) the provisions of the Code of Criminal Procedure, 1973 (No. 2 of 1974) relating to searches and seizures shall, so far as may be, apply to searches and seizures under this section.

8. Exemption-

The State Government may, by general or special order, exempt any class of persons from all or any of the provisions of this order and at any time such exemption may be suspended or revoked.
