#### MADHYA PRADESH BILL No. 25 of 2022

#### THE MADHYA PRADESH NIRSAN VIDHEYAK, 2022

#### A Bill to repeal certain enactments.

Be it enacted by the Madhya Pradesh Legislature in the seventy-third year of the Republic of India as follows:—

#### Short title

1. This Act may be called the Madhya Pradesh Nirsan Adhiniyam, 2022.

### Repeal of certain enactments.

2. The enactments specified in the Schedule are hereby repealed to the extent mentioned in the fourth column thereof.

#### Savings.

3. The repeal by this Act of any enactment shall not affect any other enactment in which the repealed enactment has been applied, incorporated or referred to;

and this Act shall not affect the validity invalidity, effect or consequences of anything already done or suffered, or any right, title, obligation or liability already acquired, accrued or incurred; or any remedy or proceeding in respect thereof, or any release or discharge of or from any debt, penalty, obligation, liability, claim or demand, or any indemnity already granted, or the proof of any past act or thing;

nor shall this Act affect any principle or rule of law, or established jurisdiction, form or course of pleading, practice or procedure, or existing usage, custom, privilege, restriction, exemption, office or appointment, notwithstanding that the same respectively may have been in any manner affirmed or recognized or derived by, in or from any enactment hereby repealed;

nor shall the repeal by this Act of any enactment revive or restore any jurisdiction, office, custom, liability, right, title, privilege, restriction, exemption, usage, practice, procedure or other matter or things not now existing or in force.

#### STATEMENT OF OBJECTS AND REASONS

The State Government is committed to repeal the useless and ineffective laws (Madhya Pradesh Acts) lying on the Statute Book, which are obsolete, redundant or lost their significance. The Government of Madhya Pradesh has identified 5 Acts so far for repeal by the Madhya Pradesh Legislative Assembly, for which consent of the concerning administrative department have been obtained.

- 2. As part of the ongoing initiative of the State Government, the present proposal of the State Government is to repeal 5 useless and ineffective laws by the State Legislative Assembly. An appropriate saving clause has been incorporated in the Bill. On being enacted, it would reduce useless and ineffective laws and bring in clarity to those for whose benefit the laws are enacted.
  - 3. Hence this Bill.
