ANNEXURE-A

A. CIVIL MATTERS

SINGLE BENCH.—In sub-rule (2) of rule 1 of Chapter IV, the following words are deleted:

“Except those specified under rule 2 (1) of this chapter”

Division Bench.—In sub-rule (1) of rule 2 of Chapter IV, shall be substituted by the following;

- (1) **Arbitration Appeal**—An arbitration appeal under section 50 or 59 of the Arbitration and Conciliation Act, 1996, specified under rule 2(2) of Chapter II, of these Rules.

- (2) **First Appeal.**—sub-rule 3 (a) (i) (ii) of rule 2 of Chapter IV, is deleted. sub-rule 3 (e) of rule 2 of Chapter IV, is deleted. sub-rule 3(h) of rule 2 of Chapter IV, is deleted.

B. CRIMINAL MATTERS

SINGLE BENCH.—In sub-rule (1) of rule 3 of Chapter IV, “(1)” is deleted.

Division Bench.—In sub-rule (1) of rule 4 of Chapter IV, the word “life” shall be substituted by “more than 10 years”.

After sub-rule (1) of rule 4 of chapter IV, the following shall be inserted:—

4.1(A)—Appeal against Acquittal under-section 372 of Cr. P. C.—An appeal under proviso to Section 372 of the Cr. P. C. from a Judgment/order of acquittal in respect of offences punishable with sentence of death or imprisonment for more than 10 years shall be heard by a Division Bench.

In sub-rule (2) of rule 4 of Chapter IV, the word “life” shall be substituted by “more than 10 years”.

In sub-rule (3) of rule 4 of Chapter IV, the words “life” shall be substituted by “more than 10 years”.

In sub-rule (4) of rule 4 of Chapter IV, the words “ (other than victim)” shall be inserted between the words “party” and “under” and the words “life” shall be substituted by “more than 10 years”.

After rule 5 of Chapter IV, the following shall be inserted:

5A—Appeal by a victim against the conviction for lesser offence—An appeal under proviso to Section 372 of the Cr. P. C. against an accused who has been convicted for a lesser offence instead of the main offence which was punishable with sentence of death or imprisonment for more than 10 years shall be heard and disposed of by a Division Bench.

In sub-rule (6) of rule 4 of Chapter IV, the word “life” shall be substituted by “more than 10 years”.

In sub-rule (8) of rule 4 of Chapter IV, the words “life” shall be substituted by “more than 10 years”.

In sub-rule (b) of rule 2 of Chapter X, the word “one” shall be substituted by “one/both”.

After sub-rule 2(c) of rule 3 of Chapter X, the following shall be inserted:

(d) in all writs filed under Article-226, 227 and petitions filed U/s 397, 407, 482 of the Cr. P. C., Second Appeal, Miscellaneous Appeal, first Appeal, Arbitration Appeal, Civil Revision, Arbitration Revision, Section 24 C.P.C. and appeal under Family court Act, no separate applications for interim relief is to be filed. The interim relief can be claimed in the main application itself. However, it is made clear that if any Interlocutory Application is filed subsequent to the main Writ or Petition then it should be by separate application only.

In sub-rule (17) of rule 4 of Chapter I, Registrar shall be substituted by “Principal Registrar” and Registrar (Judicial) shall be substituted by “Principal Registrar (Judicial)”.

In rule 11 of Chapter II, word “any” shall be inserted between the words “ a” and “ order”.

After sub-rule (2) of rule 16 of Chapter II, the following shall be inserted:—

16(2) (a)—An appeal under section 372 of the Cr. P. C., 1973 by a victim.

In the explanation of sub-rule (1) of rule 19 of Chapter II, between the words “ private person” and “ against acquittal” words “(other than victim)” are inserted and between the words “ or” and “ for enhancement of sentence” words “ by a private person (including victim)” shall be inserted.
