2. Amendment in Ordinance No. 2 Admission of Students

In ordinance no. 2 as amended on vide notification no. R-41-cc-2015-xxxviii Dated 13 February 2015 in clause (2) sub clause (iii) & (iv) shall be added as follows:-

- (iii) Admission of students to various institutions will be done as per admission cycle and mode of admission as selected by the candidate which includes Online, Regular, Part-Time, Non-Collegiate, Private or any other mode as may be defined or decided by the University, the Vice-Chancellor can make changes in the admission cycle and mode of admission on application,
- (iv) Candidates coming on transfer from other Universities due to the transfer of their Parents/ Guardians or any other genuine reason will be given admission beyond the last date for admission, subject to the provisions of 5(ii), 5(iii) & 6(ii).

Swami Vivekanand University, Sagar (M.P.)**3. Amendment in Ordinance No.4 Examination General**

In Ordinance No. 4 as amended on vide notification no. R-41-cc-2015-xxxviii Dated 13 February 2015 in clause part (I). Following Definitions shall be added after the definition "Recognized Teacher", shall be added as follows:-

"Online Examination" means the mode of examination where the student performance is assessed and evaluated using Computer Software /Digital Technology.

"Virtual Candidates" means a person who has a regular course of study by means of online classes and seeks admission to an examination of the university as such.

"Private Candidate" means a person who seeks admission to an examination of the University other than as a regular candidate or ex-student candidate.

In clause Part-II sub clause (2) shall be modified as follows:-

Filled up examination forms of all the candidates with the complete examination fees shall be forwarded by the Head of the Institution so as to reach to the designated center on or before the last date prescribed for the purpose by the University. The candidate will be allowed to appear in the examination in the mode and method as he/she has mentioned/applied at the time of admission. It will be the responsibility of the Head of the Institution to see that the candidate possesses minimum academic qualifications for appearing in the examination, has fulfilled attendance norms and is of good conduct.

In clause part-II sub clause 11(v) shall be modified as follows:-

For special reasons such as prolonged illness deficiency in percentage of attendance not exceeding fifteen percent (i.e. Upto ten percent and a further five percent) of the total number of lectures delivered and practical held in each subject may be condoned by the Head of the Institution and by the Vice-Chancellor respectively whereas for other Candidate Attendance will be as per the definition.

4. Amendment in Ordinance No.5 Conduct of Examination

In Ordinance No. 5 as amended on vide notification no. R-41-cc-2015-xxxviii Dated 13 February 2015 in clause No. 1 sub clause A shall be modified as follows.

- 1 (A) All arrangements and recognition of online examination center for the conduct of Entrance Test and Academic (Yearly/Semester) Examination to be held by the University shall be made by the Examination Controller in accordance with such directions as may be issued by the Academic Council of the University.

In ordinance no. 5 amended as on vide notification no. R-346/cc/2012/38 Dated 11th July 2012 In clause part II under the heading of Semester system of Examination for 3 Year/6 Semester course sub clause 7 a(i) shall be added as follows:-

A candidate admitted in a three year six semester course will be promoted to the higher class in accordance with the following rules:

- a. i. A candidate who has taken admission in A-B Group and has appeared in the examination of odd semester of a particular year will automatically be promoted to even semester of that year irrespective of failing in any number of subjects of previous semester.
- ii. A candidate who has taken admission in even semester under B-A Group and has appeared in the examination of even semester will automatically be promoted to next applicable odd semester irrespective of failing in any number of subjects of previous semester.

Note: The candidate who seeks admission in odd semester of an academic year is said to be in A-B group, while, a candidate who seeks admission in even semester of an academic year is said to be in B-A group, i.e. a Candidate of A-B Group will take admission generally in July; whereas, candidate of B-A Group will take admission generally in January in the relevant academic year.

A candidate-passing minimum 2/3 rd of total number of subjects prescribed for an examination shall be allowed to keep term for next higher semester/ year. A candidate with ATKT / Backlog shall be eligible for admission to the next higher semester/year as shown in table given below:

Subject head without passing requirement shall not be considered as a subject for this purpose. Provided further that the candidate will be permitted to appear in 5th semester only when she / he clears all the subjects / papers and practical up of 1st & 2nd Semester. No Division shall be awarded up to 5th Semester. Candidate will be awarded degree in the year in which she / he clears all the papers and practical of 6th semester. In such situation, mark-sheet for each semester will be issued separately up to 5th semester with the result Pass / A.T.K.T./ Backlog. Once the candidate clears all the subjects upto 6th semester, composite mark-sheet will/be issued in the 6th semester with the mention of Division also. Provided further that if a candidate has A.T.K.T./ Backlog in subject/subjects of a Semester, she/he be permitted to take repeat examination as ex-student in that subject/subjects along with the regular examination of these papers conducted by the university in an immediately subsequent semester.

In ordinance No. 5 clause Part II (B) under the heading in Yearly System of Examination for 4 years Graduate Courses shall be added as follows:-

1. The provisions of this ordinance will be application to all the Four year degree courses at undergraduate courses being taught in School of Studies of SVN University running on Yearly system.
2. The courses shall be divided in four session covering four academic years.
3. Admission to these courses will be made either on merit (to be defined by the university / constituent College) in qualifying examination or in the entrance test held for the purpose.
4. The under graduate courses in yearly system shall consist of:
 - a. Such courses (Theory papers) as prescribed by the SVN University.
 - b. Such job internship / lab work / practical I projects etc. as prescribed by the SVN University.
 - c. Such other types scheme of examination as prescribed by the SVN University.
5. Each student shall have to appear in the theory, practical (if applicable) and continuous comprehensive examination (CCE) / Internal assessment tests. The internal assessment of CCE will be held in a manner prescribed by the University/Central Board of Studies of concern subjects from time to time.
 - a. Examination ordinarily be held in the month of December/January and April /May.
6. There shall be supplementary or second examination after the declaration of year end result.
7. A candidate-passing minimum 2/3 rd of total number of subjects prescribed for an examination shall be allowed to appear in supplementary or second examination.

Provided further, Student will be promoted to II year only when he passes all the papers Theory / Practical of I year, Similarly student will be promoted to III year only when he passes all the papers Theory / Practical of II year and so on. A candidate will be awarded degree only when he/she clears all the papers of all the four sessions.

8. The Division shall be awarded on the basis of total marks obtained in Internal Assessment / CCE , University Examination (Theory & Practical) and project work (if any) taken together at the end of IV final session of examination.
 - 75% and above - First Division with distinction
 - 60% or above - First Division
 - 45% but less than 60% - Second Division
 - 33% but less than 45% - Third Division
9. A candidate has to complete the entire course of under graduate degree within a maximum period of Six years from the session of first admission or as per ordinance of SVN University for different courses.
10. The V.C. Grace up to maximum of five marks will be given to pass in a paper in each Year and five marks for improvement in division in the final Session. However, in no case both the grace each for passing and for division cannot be taken together as per ordinance of this university for grant of grace mark.
11. The matter of admission attendance, examination and all other matters not provided in this ordinance shall be governed by the provisions of the relevant ordinances of the SVN University. Not with standing anything contained in forgoing Para, shall be in contravention and in consistence with other examination ordinance or specific ordinance if any and stand independent.
12. In case of any dispute /ambiguity in yearly system of examination / course, the Vice-Chancellor decision shall be final.

In Ordinance No. 21 as amended on vide notification no. R-346/cc/2012/38/ Dated 11th July, 2012 published in official gazette on 13th July, 2012 in clause (2) shall be added as follows after the Bachelor of Home Science (B.H.Sc.).

Degrees cover under this ordinance Bachelor of Hotel Management / Aeronautical / Public Health /Optometry/Aircraft Maintenance.

In clause (7) under the heading eligibility shall be added as follows:-

Eligibility

Candidates seeking admission to these courses must have passed the Senior Secondary (12th) examination as specified below from any recognized Board or an equivalent.

B.Sc. (IT) -Passed 10+2 Exam with any Stream or equivalent Examination.

B.Sc. (Fire Safety & Hazard Management) - Passed 10+2 Exam with Science/Agriculture, One year Diploma in Fire Safety Management/ Diploma in Fire Engineering/ Diploma in Industrial Safety Management is eligible for Lateral Entry in B.Sc. 2nd year.

B.Sc. (Home Science)- Passed 10+2 Exam with any Stream or other any other equivalent Vocational/Professional Course.

B.Sc. (Hotel Management) - Passed 10+2 Exam with any Stream or equivalent Examination.

B. Music - Passed 10+2 exam with any subject

10. Amendment in Ordinance No. 38 Bachelor of Education (B.Ed.) (2 Years Degree Course)

1.0 In Ordinance no.38 as amended on vide notification no.R-346/cc/2012/38 Dated 11th July, 2012 published in official gazette on 13th July, 2012 replaced/repealed by new ordinance of no. 38 Bachelor of Education (B.Ed.) 2 Years degree course shall be substituted as follows. **(As per the direction issued by NCTE)**

In the direction issued by the NCTE previous ordinance No.38 replaced and new substituted as follows.

Bachelor of Education (B.Ed.) Two Year degree course shall be substituted as follows:-

This Ordinance Governed by rules/ guidelines/ norms laid down by NCTE and shall be applicable for the award of Bachelor of education (B.Ed.) degree.

2.0 The Duration of Degree of Bachelor of Education of the University shall spread over two academic years. The Minimum teaching days will be as per NCTE norms.

3.0 Admission:-

3.1 A Person who has obtained a Bachelor's degree of the University or a degree recognized as equivalent for the purpose, securing at least 50% marks or a grade/standard equal to it shall be eligible for admission to the course leading to the Degree of Bachelor of Education. Govt. Norms will be followed for relaxation in eligibility criteria for candidate in any category.

Provided further that in the case of untrained teachers in schools, sponsored by the Institute/School Management for B.Ed. training in the institution maintained by it, the requirement of marks or Grade as prescribed in Para 2 above may be relaxed by the Vice Chancellor, on the recommendation of the Director /Principal/Dean of the institution concerned. The fees for each course shall be decided by Board of Management of University.

Provided further that all norms laid down by NCTE and that of State Government shall be followed.

4.0 ATTENDANCE

Candidates appearing as regular for Semester examination are required to attend 80 percent of the lectures and the practical classes held separately in each subject of the course of study, provided that a short fall in attendance upto 5% can be condoned by the Vice- Chancellor of the University, respectively for satisfactory reasons.

5.0 Candidates intending to present themselves at the examination shall submit through the Dean/HOD of the School/Department, their applications on prescribed forms, so as to reach the Controller Examination by the date fixed for the purpose, together with the fees as required by the rules in force for the time being and produce the following certificates from the Principal of the college, viz: Certificates.

(i) Of good conduct

(ii) Of having completed regular course of study by attending at least the minimum number of Classes/ Practices/Practical's as required by Para 3 above.

5.1 Course Commencement - The course will start in July as approved by Board of Management/ date notified by other competent authority of the State Government every year.

5.2 Admission under this Course will be made as follows:

- (a) The University will issue admission notification in newspapers, on the University's Website, Notice Board of the University and in other publicity media before the start of academic year.
- (b) List of candidates provisionally selected for admission/ shortlisted based on merit will be displayed on the notice Board of the University/ University's website/or the student will be informed directly of their admission.
- (c) The application form may be rejected due to any of the following reasons:-
 - The candidates does not fulfill the eligibility conditions
 - The prescribed fees is not enclosed
 - The application form is not signed by the candidate and his/her parent or guardian, wherever required
 - Supporting documents for admission are not enclosed.
- (d) Enrollment/ Registration number will be assigned to the student by the University after verification & submission of all the necessary document /fees.

6.0 Examination:

- (a) The examination shall consist of two parts, namely:-
 - (i) Part I - Theory
 - (ii) Part II – Practical, Sessional and Viva-Voce.
- (b) The scope of studies in different papers shall be such as prescribed by the Board of Studies as per guideline of NCTE, New Delhi as amended time to time and approved by Academic council and the Board of Management.
- (c) Practical & sessional work shall be as per the scheme and syllabus of the course.

7.0 DIVISION

- (a) A Student obtaining 40% or more but less than 50 % marks shall be placed in Pass Division.
- (b) A Student obtaining 50% or more but less than 60% marks shall be placed in Second Division.
- (c) A Student obtaining 60% or more marks but less than 75% shall be placed in First Division.
- (d) A Student obtaining 75% or more marks shall be placed in First division with Distinction.

- 8.0** Deficiency upto five marks can be condoned to the best of the advantage of the student for passing the examinations. The deficiency can be condoned in not more than two subjects (theory and practical subject shall be considered as two separate subjects, for the purpose of awarding grace marks).

After condonation of marks, the result of concerned subject shall be declared as "Pass by Grace".

9.0 PROMOTION TO HIGHER SEMESTER/ YEAR

8.1 As per NCTE norms.

8.2 The Vice Chancellor may condone the deficiency of one mark in case a candidate failing or missing a Division/Distinction by one mark subject to the condition that where the deficiency of one mark is so condoned it shall nowhere be added.

10. REVALUATION/RE-TOTALING

(a) Revaluation and re-totaling of marks is permitted for theory papers only. The University, on application within the stipulated time and remittance of a prescribed fee, shall permit a recounting of Marks and/or revaluation for the subject(s) applied.

(b) The result after revaluation/re-totaling shall be declared as per prevailing revaluation/re-totaling rules and regulation of the University.

11.0 DURATION OF COURSE

The maximum duration of the course shall be four years. However, for one mercy attempt can be given by the Vice-Chancellor of University on reasonable ground.

However, a candidate fails to complete the B.Ed. Degree in the maximum duration of the course, as specified in above Para can avail the facility of one mercy attempt by submitting the application form (as prescribed by University) within one year after the maximum duration of the course (in continuation of the Academic Year). The number of subjects should not be more than three (Theory and Practical Subjects taken together). All application forms will be scrutinized by a committee consisting of (1) Nominee of Vice-Chancellor (2) Any Two Board of Management Members (3) Dean of the concerning faculty & (4) one Professor of the concerning subject. Three members shall form quorum. The committee will scrutinize the application forms & submit their report to Vice-Chancellor. On the recommendation of the Committee, the Vice-Chancellor may permit the applicant to avail the one mercy attempt facility. If a candidate fails to complete the course after availing one mercy attempt, he/she will not be eligible to appear in any University examination in future.

12.0 In the notification declaring results of the examination the names of successful candidates who secure First division separately in each of part of examination shall be arranged in order of merit.

12.1 Award of Credits and Grades shall be as per prevailing NCTE norms.

13.0 Notwithstanding anything stated in this Ordinance, for any unforeseen issues arising, and not covered by this Ordinance, or in the event of differences of interpretation, the Vice-Chancellor may take a decision after obtaining, if necessary, the opinion / advice of a Committee consisting of any two or all the Directors of the Schools. The decision of the Vice-Chancellor shall be final.

14.0 MERIT LIST

Merit list of first top ten (10) rank candidates in the order of merit shall be declared by the University at the end of last examination securing at least first division and passing all theory and practical examinations in single attempt. Merit list shall be declared only after considering the revaluation result, if any.

15.0 MEDIUM OF INSTRUCTION AND EXAMINATION

14.1 The medium of instruction and examination shall be Hindi or English throughout the course of study.

14.2 The subjects to be studied in one year of course shall be as per the scheme approved by the Board of Studies of the University.

11. Amendment in ORDINANCE No. 41 Bachelor of Physical Education (B.P.Ed.) (2 Years Degree Course)

1.0. In Ordinance no.41 as amended on vide notification no.R-346/cc/2012/38 Dated 11th July, 2012 published in official gazette on 13th July, 2012 replaced/repealed by new ordinance of no. 41 Bachelor of Physical Education (B.P.Ed.). 2 Years degree course shall be substituted as follows. (As per the direction issued by NCTE)

This Ordinance framed as per rules/ regulations/ guidelines laid down by NCTE and shall be applicable to candidates admitted to Bachelor of Physical Education (B.P.Ed.).

2.0 ADMISSION

(a) A candidate who after passing his/her graduation examination in any discipline with minimum 50% marks of any recognized University and having at least participation in the Inter.College/Inter- Zonal/District/ School competition in sports and games as recognized by the AIU/IOA/SGFI/Govt. of India

Or

(b) Bachelor's degree in Physical Education with 45% marks

Or

(c) Bachelor's degree in any discipline with 45% marks and studied Physical Education as compulsory/elective subject.

Or

(d) Bachelor's degree with 45% marks and having participated in National/Inter University/State competition or secured 1st, 2nd or 3rd Position in Inter college/Inter Zonal/District/School Competition in sports and games as recognized by the AIU AIU/IOA/SGFI/Govt. of India

(e) Bachelor's degree with participation in international competition or secured 1st, 2nd or 3rd Position in National/Inter University/competition in sports and games as recognized by respective federations/AIU/IOA/SGFI/Govt. of India.

Or

(f) Graduation with 45% marks and at least three years of teaching experience (for deputed in-service candidates i.e. trained physical education teachers/Coaches). shall be admitted to the B.P.Ed. Course.

The relaxation in the percentage of marks in the qualifying examination and in the reservation of seats for SC/ST/OBC and other categories shall be as per the rules of the Central Government/State Government shall be applicable.

3.0 FEES: The fees for each course shall be decided by Board of Management of University.

4.0 MINIMUM MARKS TO PASS EXAMINATION & RESULTS

(a) In order to pass at any part of the two Year Degree Course examinations, the prevailing norms of NCTE will be applicable.

(b) In determining the final result total marks obtained by the examinees at their semesters examinations in each subjects and in the aggregate shall be taken into account. No division shall be assigned on the result of the B. P. Ed. (2YDC) Semester Ist to IIIrd examination.

6.0 DIVISION

- (a) A Student obtaining 40% or more but less than 50 % marks shall be placed in Pass division,
- (b) A Student obtaining 50% or more but less than 60% marks shall be placed in Second division.
- (c) A Student obtaining 60% or more marks but less than 75% shall be placed in First division.
- (d) A Student obtaining 75% or more marks shall be placed in First division with distinction.

7.0 Deficiency up to five marks can be condoned to the best of the advantage of the student for passing the examinations. The deficiency can be condoned in not more than two subjects (theory and practical subject shall be considered as two separate subjects, for the purpose of awarding grace marks).

After condonation of marks, the result of concerned subject shall be declared as "Pass by Grace".

8.0 PROMOTION TO HIGHER SEMESTER/ YEAR

- 8.1 As per NCTE/ state Govt. Norms.
- 8.2 The Vice Chancellor may condone the deficiency of one mark in case a candidate failing or missing a division/Distinction by one mark subject to the condition that where the deficiency of one mark is so condoned it shall nowhere be added.

9.0 REVALUATION/RE-TOTALING

- (a) Revaluation and re-totalling of marks is permitted for theory papers only. The University, on application within the stipulated time and remittance of a prescribed fee, shall permit a recounting of marks and/or revaluation for the subject(s) applied.
- (b) The result after revaluation/re-totalling shall be declared as per prevailing revaluation/re- totalling rules and regulation of the University.

11.0 In the notification declaring results of the examination the names of successful candidates who secure First division separately in each of part of examination shall be arranged in order of merit.**11.1** Award of Credits and Grades shall be as per prevailing NCTE norms.**12.0** Notwithstanding anything stated in this Ordinance, for any unforeseen issues arising, and not covered by this Ordinance, or in the event of differences of interpretation, the Vice-Chancellor may take a decision after obtaining, if necessary, the opinion / advice of a Committee consisting of any two or all the Directors of the Schools. The decision of the Vice-Chancellor shall be final.**13.0 MERIT LIST**

Merit list of first top ten (10) rank candidates in the order of merit shall be declared by the University at the end examination securing at least first division and passing all theory and practical examinations in single attempt. Merit list shall be declared only after considering the revaluation result, if any.

14.0 MEDIUM OF INSTRUCTION AND EXAMINATION

- 14.1 The medium of instruction and examination shall be Hindi or English throughout the course of study.
- 14.2 The subjects to be studied in one year of course shall be as per the scheme approved by the Board of Studies of the University.

No. F-3-48/2017/18-5 :- The following draft of amendment in the Madhya Pradesh Bhumi Vikas Rules, 2012, which the State Government proposes to make in exercise of the powers conferred by sub-section (3) of Section 24 of the Madhya Pradesh Nagar Tatha Gram Nivesh Adhiniyam, 1973 (No.23 of 1973), is hereby published, as required by sub-section (1) of section 85 of the said Adhiniyam for the information of all persons, likely to be affected thereby and notice is hereby given that the said draft of amendment shall be taken into consideration on the expiry of thirty days from the date of publication of this notice in the Madhya Pradesh Gazette.

Any objection or suggestion, which may be received from any persons, with respect to the said draft before the expiry of the period specified above shall be considered by the State Government.

DRAFT OF AMENDMENT

In the said rules, after Rule 42 the following rule shall be inserted namely :-

"42 A. Norms for Information Technology:-

Information Technology (IT), Information Technology Enabled Services (ITES) and Electronic System Design and Manufacturing shall be called Information Technology.

- (1) **Land required for plot:-** Minimum area of plot shall be 3000 sq.m.
- (2) **Information Technology (Investment) Planning Area:-** Such area shall be termed as Information Technology Investment Area which bears a minimum area of 2 Hectare (5 acre) and such areas which shall be notified by Science and Technology Department, Madhya Pradesh Government.
- (3) **Floor Area Ratio (FAR) :-** Plots for Information and Technology, and in Information and Technology Investment Area shall have maximum FAR of 1:2.50 or maximum FAR permissible in the relevant development plan, whichever is higher.

Provided that if the plot/building situated in the Information Technology Investment Area is being used for non IT purposes in excess of the percentage mentioned in the following table-5 A, then the FAR and land use of whole plot/building shall be accepted as per the relevant development plan.
