No. F-4-3-2010-1-LV : The State Government, hereby, makes the following rules relating to entrance to Under Graduate Medical (MBBS) & Dental (BDS) Courses in Private Unaided Medical and Dental Colleges in the State of Madhya Pradesh. These rules shall be subject to the final decision of the Hon'ble Supreme Court of India to be passed in SLP (Civil) No. 13111/09 : Modern Dental College V/s State of M.P. & others and pending similar other petitions.

RULES

1. **Short title and Commencement.**—(1) These rules may be called the “Madhya Pradesh Private Medical and Dental Under Graduate Course Entrance Examination Rules, 2010”.

(2) They shall come into force from the date of their publication in the Madhya Pradesh Gazette and shall remain in force for the academic year, 2010.

2. **Definition.**— In these rules, unless the context otherwise requires,—

- (a) “Board” means the Madhya Pradesh Professional Examination Board;
- (b) “College” means **Private** unaided Medical or a Dental College in the State of Madhya Pradesh;
- (c) “Examination” means the Entrance Examination conducted by the Madhya Pradesh Professional Examination Board.
- (d) “Other Backward Classes” means Other Backward Classes as specified and laid down by the Government of Madhya Pradesh;

- (e) "Scheduled Castes" means Scheduled Castes as specified and laid down by the Government of Madhya Pradesh;
- (f) "Scheduled Tribes" means Scheduled Tribes as specified and laid down by the Government of Madhya Pradesh;
- (g) "Government" means Government of Madhya Pradesh;
- (h) "MCI" means Medical Council of India;
- (i) "DCI" means Dental Council of India;
- (j) "Admission and Fee Regulatory Committee" means the Committee constituted by the State Government for the supervision and guidance of admission process and for the fixation of fee to be charged from candidates seeking admission in a professional educational institution;
- (k) "Competent Authority" means any Authority as authorized by the State Government in this behalf ;
- (l) "NRI" means Non-resident Indian shall have the same meaning as assigned to it in clause (e) of Section 115 C of the of Income Tax Act, 1961 (43 of 1961);
- (m) "Rules" means Madhya Pradesh Private Medical and Dental Under Graduate Course Entrance Examination Rules, 2010".

3.0 General.—(i) Under Graduate Courses in MBBS and BDS shall be governed and regularised by MCI / DCI / University / the College/ State Government / Government of India / under the rules and regulations in force at the time of entrance examination, allotment, admission and amended from time to time.

(ii) These rules shall apply to all colleges & candidates for entrance examination, allotment and admission in the following courses and colleges :—

1. M.B.B.S. Course of Private unaided Medical Colleges in the State of M.P.
2. B.D.S. Course of Private unaided Dental Colleges, in the State of M.P.

3.1 Correct information must be furnished and produced whenever required. Before filling up the application form the candidates are advised to read and understand the rule book thoroughly and then fill up complete, correct and required information and must enclose required documents, failing which applicant shall not be entitled to entrance examination, allotment and admission.

3.2 If it is found that a candidate has hidden any relevant facts and / or provided incorrect information while filling up the application form, at the time of allotment of a seat, at the time of scrutiny of the documents or at the time of his / her admission, then the admission shall be cancelled by the Dean / Principal of the college, at any time during his/her studies.

3.3 Students found guilty of misconduct, indiscipline and absence would be liable to disciplinary action including EXPULSION from college by the Dean / Principal and CANCELLATION OF REGISTRATION by the University.

3.4 The examination shall be held at the centres fixed by the Board. Centre once allotted shall not be changed. The candidate shall abide by the rules and regulation of the Board failing which his / her candidature will be CANCELLED.

3.5 A candidate once allotted and/or admitted to M.B.B.S. course shall not be entitled to change the college on any ground.

3.6 During the first counselling allotment of seats of Private unaided Medical/Dental colleges shall be done. A candidate who has opted a BDS course during the first counselling, if desirous of re-allocation to MBBS course than such he/she will be eligible for re-allocation to vacant seats of MBBS course of Private unaided Medical Colleges, as per his/her merit/category/class, at the next counselling only. However, such candidate has to submit an NOC & documents deposited certificate from the Principal/Head of the respective Dental College in the proforma-14.

4.0 Availability of seats.— College wise list of seats available in M.B.B.S. and B.D.S. courses are shown in table number 1 to 3.

4.1 Students found guilty of misconduct, indiscipline and unauthorized absence shall be liable to disciplinary action including expulsion from College by the Dean / Principal and cancellation of registration by the University.

4.2 Every candidates must abide by the admission rules of VYAPAM and he/she has to deposit the prescribed fee.

4.3 All dispute related to Counselling to Under Graduate courses of Private unaided Medical/Dental Colleges will be decided by the Counselling Committee.

4.4 All dispute related to Admission of Under Graduate Courses of Private Unaided Medical & Dental Colleges will be decided by Admission & Fee Regulatory Committee.

5 Reservation.—Every Institution shall be allowed to fill up to 15% of the sanctioned seats by NRI candidates only, in the manner prescribed by the admission and Fee Regulatory Committee. These NRI seats shall be filled up though a separate Counselling. NRI Seats remaining vacant shall be merged into the Counselling of Non NRI Candidates.

20% Seats are reserved for candidates belonging to Scheduled tribes, 16% seats to Scheduled castes and 14% seats to Other Backward Classes other than creamy layer of OBC of Madhya Pradesh or as amended from time to time.

20% Seats are reserved for candidates belonging to scheduled tribe, 16% to scheduled caste and 14% to Other Backward Classes and remaining seats are available for Unreserved Category candidates. Permanent Caste certificate is compulsory for admission on reserve seats. If provisional caste certificate is produced it must be valid at the time of counselling. Otherwise will not be allowed in the counselling. Certificate must contain dispatch no., date & signature with official seal of the authorized person, who shall not be below the rank of Deputy Collector, otherwise, certificate will not be accepted.

- (1) In each category, 30% Reservation for woman candidates shall be made on merit-cum-option basis.
- (2) The minimum percentage of marks in entrance examination for eligibility for admission to Under Graduate Medical and Dental courses shall be 40% for SC / ST / OBC candidates and 50% for unreserved category candidates.
- (3) Candidates claiming to be a candidate belonging to SC / ST / OBC (Non Creamy layer) category of Madhya Pradesh shall have to attach a valid certified copy of certificate issued by the Competent Authority under his signature and official seal, not below the rank of Deputy Collector, with the application form. The original certificate has to be produced at the time of counselling.

- (4) Three percent (3%) seats are reserved for admission to M.B.B.S./ B.D.S. courses for Physically Handicapped who are bonafide residents of Madhya Pradesh and belong to ST, SC, OBC and Unreserved category. This Reservation shall be horizontal.

Firstly, the seats will be filled up from Candidates with locomotory disability of lower limbs between 50% to 70%. In case of non availability of candidates with locomotory disability of lower limbs between 50% to 70% then such unfilled seats shall be filled up by persons with locomotory disability of lower limbs between 40% to 50%

Candidate claiming admission against these seats shall have to produce a certificate, in the prescribed form, from District Medical Board and an eligibility certificate, should not have been issued before 3 months on the date of counseling, from Superintendent Vocational Rehabilitation Centre for Physically Handicapped, Government of India, Ministry of Labour, Napier Town, Jabalpur. Both the certificates are necessary to be produced at the same time, else, the candidate will not be eligible for counseling.

Following categories of handicapped will not be eligible for admission as per the instructions of MCI :—

- (A) Handicapped by hand/hands
- (B) Handicapped by eyesight.
- (C) Deafness
- (D) Handicapped of legs more than 70%

**6. Fee Structure.— (a) For BDS Courses
As decided by Fee regulatory Committee.**

**(b) For MBBS/ Courses
As decided by Fee regulatory Committee.**

7. Security Deposit.— As decided by Fee regulatory Committee.

8. Eligibility.—(1) The Candidate must be a citizen of India

AND

For admission to MBBS/BDS course, only those candidates are eligible, who have passed the qualifying examination of Higher Secondary(10+2) from Board of Secondary Education, Madhya Pradesh, Bhopal. passing Physics, Chemistry and Biology subjects individually and have secured at least minimum 50% marks in aggregate in case of Un-reserved and 40% marks in case of reserved category candidates

Candidates of all categories and classes are required to have passed ENGLISH as a subject in the 12th (Higher Secondary) examination of 10+2.

OR

The candidate has passed an equivalent or higher examination from any recognized Board or higher or equivalent examination conducted by University certified by School Education Department, Government of Madhya Pradesh with passing Physics, Chemistry and Biology subjects individually and have secured at least 50% marks in aggregate in case of unreserved category candidate and 40% marks in case of reserved category candidate. For foreign nationals seeking admission, eligibility shall be considered on the basis of equivalence certificate granted to them by concerned Board/University and approved by the External Affairs Ministry, Government of India.

Candidate of all categories and class are required to have passed ENGLISH as a subject in the 12th (Higher Secondary) examination of 10+2.

(2) No candidate shall be allowed to be admitted to a Private unaided Medical/Dental Colleges until the candidate has completed or shall complete the age of 17 year on or before 31 December of the year of examination.

For reckoning the age, as aforesaid, the date of birth as mentioned in the certificate of Higher School/ Higher Secondary certificate examination or in MARK-SHEET of the said examination shall be the authentic documentary proof.

The evidence in support of proof of age may be considered if a candidate who otherwise satisfies the domicile requirements and who on account of being with his/her parents in a foreign country passes examination abroad, certified by the School Education Department of Government of Madhya Pradesh as equivalent to Higher Secondary School Certificate examination in Madhya Pradesh.

9. Examination.—(1) A common entrance examination will be conducted for Government Autonomous/ Government Medical/Dental Colleges and for Private unaided Medical/Dental Colleges of the State.

(2) A candidate has to give his/her option in the application form for (A) Government Autonomous/Government Medical/Dental Colleges of the state (B) Private Unaided Medical/Dental Colleges of the State, (C) both. Candidates who are not bonafide residents of Madhya Pradesh can only choose option (B).

(3) Entrance Examination shall be conducted in ENGLISH AND HINDI medium. Candidate has to choose one medium, while filling up the application form.

(4) There shall be only one paper (multiple choice) of three hours duration. First part of this Paper will contain hundred multiple choice questions of the Physics and Chemistry subjects and the second part will contain hundred multiple choice question of the Botany and Zoology subjects.

10. Declaration of Result.—The Board shall conduct the examination and evaluate the answer sheets. Thereafter, the result will be declared along with the publication of merit list.

The allotment of a seat to eligible candidate in course and college shall be done by Counselling on merit-cum-option basis.

11. Merit List.— (1) A merit list of Un reserved (Open) category shall be declared which shall consist of all successful candidates who have

secured not less than 50% marks in P.M.T. entrance examination, 2010.

50% marks are necessary for reserve category candidates also if they opt. a seat from unreserved category.

(2) A separate merit list of all reserved category (Scheduled Caste / scheduled Tribe /Other backward Classes) will be prepared who have secured not less than 40% marks in P.M.T. entrance examination.

(3) In all the category-wise lists the PH,MP & FF candidates will be shown distinctly as such according to their merit.

(4) The separate list of PH,MP & FF candidate will also be prepared category wise as per their merit.

(5) There will be no waiting list.

NOTE :- Vyapam will prepare a combined merit list of all the eligible candidates of all the categories and classes.

12. **Counselling.**— (1) The allotment of seats shall be made to the candidates through counselling on personal appearance.

The State Government shall constitute the counselling committee consist of the following , namely :-

(2) **The programme for counseling shall be advertised in the leading Newspapers of the State. Separate call letters will not be sent.**

(3) In case, a candidate is unable to appear in person for the counseling, he / she can authorised his / her representative with an undertaking and an authority letter in Proforma 2 and 2-A along with the original documents as mentioned in proforma 01, for verification. The seat opted by the representative shall be binding on the candidate.

(4) The candidate during counseling or his/her representative shall have to travel for the Counseling at his/her own cost.

(5) Candidate or his / her representative shall not be allowed to enter the area specified for the counseling without showing the PMT 2010 Examination Mark Sheet.

(6) The candidate or his / her authorised representative without original documents, as mentioned in proforma 01, and along with set of two attested photocopies of original documents shall not be eligible to participate in the Counseling.

(7) The candidates or their authorised representatives shall wait for their turn in the order of merit. They shall be called in small groups of 10-20 for scrutiny i.e. verification of original documents and if found eligible, shall be further permitted for the Counseling, **where they shall exercise their option for allotment of any one of the available seats. A seat once opted shall be final and the same shall be allotted to them and the allotment letter shall be issued on payment of Bank Draft payable to Dean / Principal of the College as per rule 7.1.**

(8) (A) **Candidate or his/her representative must remain present on the day of scrutiny of documents. Due to any unavoidable circumstances if any candidate of his/her authorized representative does not remain present on the date and time fixed for the counseling, then such candidate, if he/she come afterwards, shall be considered only at the stage where the counseling is in progress, irrespective of his/her merit. He/She shall be considered only if the counseling of his/her category is going on. Earlier allotment of other candidates made on the basis of their merit shall remain unchanged. Counseling will not be withheld for any such candidate, and will continue.**

(B) Candidates who remain absent or who could not participate in the counseling due to incomplete documents shall be eligible in the next counseling.

(9) During the first counseling, allotment of seats of Medical/Dental colleges shall be done. A candidate who has opted a BDS course during the first counseling, if he/she is desirous for re-allocation to MBBS course, he/she will be eligible for re-allocation on vacant seats of the MBBS course as per merit/category/class at the next counseling. However, such candidate has to submit NOC & documents deposited certificate from the respective Dental College in the proforma-14.

(10) Candidate's name should appear same in all the related documents i.e. mark sheet, certificates and other documents.

(11) Counseling shall be done on merit-cum-option basis according to the category in the following sequence ;

- A) ST Category
- B) SC Category
- C) OBC Category
- D) Unreserved Category

(12) In case, the eligible candidates to the extent of reservations in any category are not available, the vacant seats will be filled up by making them available in other categories as given below :-

- (A) The vacant seats of ST category shall be filled up by the eligible SC category candidates.
- (B) The vacant seats of SC category shall be filled up by eligible ST category candidates.
- (C) In case, the eligible candidates to the extent of reservation in ST and SC categories are not available, the vacant seats shall be filled up by eligible OBC category candidates.
- (D) In case, the eligible candidates are not available in these above THREE reserved categories in the above manner, the vacant seats shall then be filled up by the eligible unreserved category candidates.

(13) If eligible candidates are not available for admission on vacant seats in PH and F class of any category such vacant seats shall be included in the OPEN [X] seats of the same category.

Even if OPEN [X] category eligible candidates are not available for admission on vacant seats of reserved category to the extent of reservation in any reserved category, the vacant seats shall be filled up by making them available in other categories as described in 12.12.

(14) A candidate belonging to ST/SC/OBC category, whose name also appears in the merit list of unreserved category, besides the merit list of his/her own reserved category shall have an option during counseling to select the seat either from reserved category or the un-reserved category. This option will not be changed in the subsequent counseling and he/she candidate will be eligible for the allotment of seat as per his chosen option.

(15) A Candidate admitted to MBBS/BDS course on the basis of previous year's PMT examinations, if succeeds in the present examination, shall have to submit all the original documents with completed profarma-1 or photocopies there of together with a certificate of the Dean/Head of the institution certifying that such certificates are in his custody (showing list). On allotment of a seat the candidate shall have to present all the original documents to the authorities of the allotted college.

13. Admission.—Candidates who are allotted a subject course and a college by Counselling shall report on the notified date and time to the Dean / Principal of the College concerned.

13.1 The College admission committee consisting of Dean / Principal, two Professors and at least two Medical Teachers belonging to the reserved category shall also verify the original documents and, if found eligible shall give admission in the course and the college allotted to the candidate.

13.2 A candidate once admitted, all his/her original certificates shall be kept in custody by the college and a certificate to that effect will be issued to him/her by the college authorities.

13.3 Original documents shall be returned to the candidates only on completion of their **Course (internship)** or accepting their **RESIGNATION or leaving** from the course and the college, due to some reason.

13.4 **The claim of admission of a candidate who fails to join by the last date of joining or left after joining shall be forfeited and allotment /admission given to him/her shall be deemed to have been cancelled and will not be eligible to participate in the counseling again in the same year.**

13.5 The candidates shall have to undergo TEST FOR MEDICAL FITNESS and shall be admitted only if they are found **MEDICALLY FIT**.

14. The academic session shall commence from 01-08-2010. Last date up to which students can be admitted against vacancies arising due to any reason is 30-09-2010.

Note:

- 1- As per the order dated 11-09-2002 of Hon'ble Supreme Court in Madhu Singh Vs MCI, **no admission shall be made, in any condition, beyond 30th September of the concerned year. After 30-09-2010 the admission process will come to an end, irrespective of any vacancy .**
- 2- **As given in Rule 12.1 a detailed programme of the counseling will be advertised in the leading News papers of the State or any change in the programme shall also be advertised in the news papers besides uploading the same information on the website www.mp.nic.in/medicaleducation.**
- 3- **Any student identified as having obtained admission after the last date of closure of admission, he/she shall be discharged from the course of study or any Medical /Dental qualification acquired by such student on such admission, the same shall not be treated as a recognized qualification for the purpose of MCI Act. 1956 or the Dentist Act. 1948, as the case may be.**

15. Expalanation of Rules.— The State Government reserves the right to amend any rule and procedure for admission. In case, any dispute related to the interpretation of these rules and amendments thereto, the decision of the State Government shall be final and binding on all concerned.
