THE MADHYA PRADESH VIDHAN SABHA SADASYA VETAN, BHATTA TATHA PENSION
(SANSHODHAN) VIDHEYAK, 2011.

**A Bill further to amend the Madhya Pradesh Vidhan Sabha Sadasya Vetan Bhatta
Tatha Pension Adhiniyam, 1972.**

Be it enacted by the Madhya Pradesh Legislature in the Sixty-second year of the Republic
of India as follows:—

**Short title and
commencement.**

1. (1) This Act may be called the Madhya Pradesh Vidhan Sabha Sadasya Vetan, Bhatta
Tatha Pension (Sanshodan) Adhiniyam, 2011.

(2) It shall be deemed to have come into force from the 27th April, 2010.

**Substitution of
Sectioni 5.**

2. For Section 5 of the Madhya Pradesh Vidhan Sabha Sadasya Vetan, Bhatta Tatha Pension
Adhiniyam, 1972 (No. 7 of 1973), the following Section shall be substituted, namely :—

**Bus Travelling
Allowance.**

"5. There shall be paid to every member and every person entitled to pension under
section 6-A Bus Travelling Allowance at the rate of five hundred rupees per
mensem."

STATEMENT OF OBJECTS AND REASONS

There was a provision of free transit in buses of the Madhya Pradesh State Road Transport Corporation
for ex-members of the Madhya Pradesh Legislative Assembly. Due to non-operation of buses of Corporation,
the provision of Bus Travelling Allowance is being made instead of free transit. Therefore, suitable amend-
ment is proposed in the Madhya Pradesh Vidhan Sabha Sadasya Vetan, Bhatta Tatha Pension Adhiniyam,
1972 (No. 7 of 1973).

2. Hence this Bill.
