THE MADHYA PRADESH CONTINGENCY FUND (AMENDMENT)
BILL, 2011.**A Bill further to amend the Madhya Pradesh Contingency Fund Act, 1957.**

Be it enacted by the Madhya Pradesh Legislature in the Sixty-second year of the Republic of India as follows:—

- Short title.** 1. This Act may be called the Madhya Pradesh Contingency Fund (Amendment) Act, 2011.
- Amendment of Section 3.** 2. In Section 3 of the Madhya Pradesh Contingency Fund Act, 1957 (No. 7 of 1957), for the words “one hundred crores rupees”, the words “two hundred crores rupees” shall be substituted.

STATEMENT OF OBJECTS AND REASONS

The Madhya Pradesh Contingency Fund was established on 1st November, 1956 with an imprest of two crores rupees. As this amount was found insufficient to meet the growing requirements of the State, the corpus of the Fund was raised from time to time, at present it stands at one hundred crores rupees. Lately even this amount has been found to be inadequate to meet unforeseen expenditure related to contingencies. In view of the increase in plan expenditure and other expenditure, it is expedient to raise the corpus of the Contingency Fund. It is, therefore, proposed to raise the Contingency Fund to two hundred crores rupees by amending the Madhya Pradesh Contingency Fund Act, 1957 (No. 7 of 1957) suitably.

2. Hence this Bill.
