THE MADHYA PRADESH KRISHI UPAJ MANDI (DWITIYA SANSHODHAN)
VIDHEYAK, 2011.

A Bill further to amend the Madhya Pradesh Krishi Upaj Mandi Adhiniyam, 1972.

Be it enacted by the Madhya Pradesh Legislature in the Sixty-second year of the Republic of India as follows :—

**Short title and
Commencement.**

1. (1) This Act may be called the Madhya Pradesh Krishi Upaj Mandi (Dwitiya Sanshodhan) Adhiniyam, 2011.

(2) It shall come into force from the date of its publication in the Madhya Pradesh Gazette.

**Amendment of
Section 11-B.**

2. In Section 11-B of the Madhya Pradesh Krishi Upaj Mandi Adhiniyam, 1972 (No. 24 of 1973), in sub-section (1), for clause (a), the following clause shall be substituted namely :—

“(a) Whose name is entered as Bhumiswami in the village land records or who has acquired forest right under clause (a) of sub-section (1) of Section 3 of the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 (No. 2 of 2007);”.

STATEMENT OF OBJECTS AND REASONS

As per the provision of clause (a) of sub-section (1) of Section 11-B of the Madhya Pradesh Krishi Upaj Mandi Adhiniyam, 1972 (No. 24 of 1973) only such person whose name is entered as Bhumiswami in the village land records is qualified to vote in the constitution of market committee. With a view to equate and provide the right of voting in the market committee elections to such Scheduled Tribes and Other Traditional Forest Dwellers, who have acquired forest right under clause (a) of sub-section (1) of Section 3 of the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 (No. 2 of 2007), it is decided to make suitable amendment in Section 11-B of the principal Act.

2. Hence this Bill.
