MADHYA PRADESH BILL

No. 43 OF 2011.

THE MADHYA PRADESH APPROPRIATION, (No.-8) BILL, 2011.

A Bill to provide for the authorization of appropriation of moneys out of the consolidated fund of the State of Madhya Pradesh to meet the amounts spent on certain services during the financial year ended on the 31st day of March, 2002 in excess of the amounts granted for those services and for that year.

Be it enacted by the Madhya Pradesh Legislature in the Sixty-second year of the Republic of India as follows:—

Short title.

1. This Act may be called the Madhya Pradesh Appropriation (No.-8) Act, 2011.

Issue of Rs. 6,25,60,594 out of the consolidated fund of the State of Madhya Pradesh to meet certain excess expenditure for the year ended on 31st March, 2002.

2. From and out of the consolidated Fund of the State of Madhya Pradesh the sums specified in column (3) of the Schedule amounting in the aggregate to the sum of Six crores twenty five lakhs sixty thousands five hundred ninety four rupees shall be deemed to have been authorised to be paid and applied to meet the amount spent on defraying the charges in respect of the services specified in column (2) of the said Schedule during the financial year ended on the 31st day of March, 2002 in excess of the amounts granted for those services and for that year.

Appropriation.

3. The sums deemed to have been authorized to be paid and applied from and out of the consolidated Fund of the State of Madhya Pradesh under this Act, shall be deemed to have been appropriated for the services and purposes expressed in the Schedule in relation to the financial year ended on the 31st day of March, 2002.

STATEMENT OF OBJECTS AND REASONS
