**THE MADHYA PRADESH NAGARIYA KSHETRON KE BHOOMIHIN VYAKTI
(PATTADHRITI ADHIKARON KA PRADAN KIYA JANA) SANSHODHAN
VIDHEYAK, 2013.**

A Bill further to amend the Madhya Nagariya Kshetron Ke Bhoomihin Vyakti (Pattadhriti Adhikaron Ka Pradan Kiya Jana) Adhiniyam, 1984.

Be it enacted by the Madhya Pradesh Legislature in the sixty-fourth year of the Republic of India as follows :—

Short title.

1. This Act may be called the Madhya Pradesh Nagariya Kshetron Ke Bhoomihin Vyakti (Pattadhriti Adhikaron Ka Pradan Kiya Jana) Sanshodhan Adhiniyam, 2013.

Amendment of Section 3.

2. In section 3 of the Madhya Pradesh Nagariya Kshetron Ke Bhoomihin Vyakti (Pattadhriti Adhikaron Ka Pradan Kiya Jana) Adhiniyam, 1984 (No. 15 of 1984) (hereinafter referred to as the principal Act),—

- (i) in sub-section (1), for the figures and words “31st day of December, 2007”, the figures and words “31st day of December, 2012” shall be substituted;
- (ii) in sub-section (2), for the figures and words “31st December, 2007” wherever they occur, the figures and words “31st December, 2012” shall be substituted.

Amendment of Section 4.

3. In section 4 of the principal Act, in sub-section (2), for the figures and words “31st December, 2007”, the figures and words “31st December, 2012” shall be substituted

Amendment of Section 5.

4. In section 5 of the principal Act,-

- (i) in sub-section (1), for the words “and with fine which shall not be less than five hundred rupees but which may extend to one thousand rupees”, the words “and with fine which shall not be less than two thousand rupees but which may extend to ten thousand rupees” shall be substituted;
- (ii) in sub-section (2), for the words “may extend to three months or with fine which may extend to one thousand rupees or with both”, the words “shall not be less than three months but which may extend to three years and with fine which shall not be less than two thousand rupees but which may extend to ten thousand rupees” shall be substituted;
- (iii) in sub-section (3), for the words “may extend to one year or with fine which may extend to five thousand rupees or with both”, the words “shall not be less than three months but which may extend to three years and with fine which shall not be less than two thousand rupees but which may extend to ten thousand rupees” shall be substituted.

STATEMENT OF OBJECTS AND REASONS

The Madhya Pradesh Nagariya Kshetron Ke Bhoomihin Vyakti (Pattadhriti Adhikaron Ka Pradan Kiya Jana) Adhiniyam, 1984 (No. 15 of 1984) provide for allotment of leasehold rights to landless poor residing in the urban areas for residential purpose. The existing provisions of the Act authorize the Competent Authority to give leasehold rights to the landless urban poor residing on Government land or on the land belonging to Municipalities and Development Authorities who are in possession of such land on 31st December, 2007. Since then a number of poor have migrated to urban areas in the State for livelihood purpose and have settled on such land. Therefore, in order to provide leasehold right to these landless urban poor, it is proposed to extend the cut off date to 31st December, 2012.

2. It is also proposed to make the penal provisions of the Act more stringent in order to check the activities of unauthorised transfer, sale, dispossession or renting out of the such land.

3. Hence this Bill.
