MADHYA PRADESH BILL

**THE MADHYA PRADESH VIDHAN SABHA ADHYAKSHA TATHA UPADHYAKSHA
EVAM NETA PRATIPAKSHA VETAN TATHA BHATTA VIDHI (SANSHODHAN)
VIDHEYAK, 2016.**

A Bill further to amend the Madhya Pradesh Vidhan Sabha Adhyaksha Tatha Upadhyaksha (Vetan Tatha Bhatta) Adhiniyam, 1972 and the Madhya Pradesh Vidhan Sabha Neta Pratipaksha (Vetan Tatha Bhatta) Adhiniyam, 1980.

Be it enacted by the Madhya Pradesh Legislature in the sixty-seventh year of the Republic of India as follows:—

Short title.

1. This Act may be called the Madhya Pradesh Vidhan Sabha Adhyaksha Tatha Upadhyaksha Evam Neta Pratipaksha Vetan Tatha Bhatta Vidhi (Sanshodhan) Adhiniyam, 2016.

PART I

**AMENDMENT TO THE MADHYA PRADESH VIDHAN SABHA ADHYAKSHA TATHA
UPADHYAKSHA (VETAN TATHA BHATTA) ADHINIYAM, 1972 (NO. 27 OF 1972)**

Substitution of Section 2.

2. For Section 2 of the Madhya Pradesh Vidhan Sabha Adhyaksha Tatha Upadhyaksha (Vetan Tatha Bhatta) Adhiniyam, 1972 (No. 27 of 1972) (hereinafter referred to as the principal Act), the following Section shall be substituted, namely:—

Salary of Speaker and Deputy Speaker.

“2. There shall be paid a salary per mensem of rupees forty seven thousand to the Speaker and rupees forty five thousand to the Deputy Speaker.”.

Substitution of Section 3.

3. For Section 3 of the principal Act, the following Section shall be substituted, namely:—

Sumptuary allowance, constituency allowance and daily allowance to Speaker and Deputy Speaker.

- “3. (1) There shall be paid to the Speaker a sumptuary allowance of forty eight thousand rupees per mensem and to the Deputy Speaker a sumptuary allowance of forty five thousand rupees per mensem.
- (2) There shall be paid to the Speaker a constituency allowance of forty five thousand rupees per mensem and to the Deputy Speaker a constituency allowance of thirty five thousand rupees per mensem.
- (3) There shall be paid to the Speaker and the Deputy Speaker a daily allowance of one thousand five hundred rupees per day.”.

**AMENDMENT TO THE MADHYA PRADESH VIDHAN SABHA NETA PRATIPAKSHA
(VETAN TATHA BHATTA) ADHINIYAM, 1980 (NO. 8 OF 1980)**

Amendment of Section 3.

4. In Section 3 of the Madhya Pradesh Vidhan Sabha Neta Pratipaksha (Vetan Tatha Bhatta) Adhiniyam, 1980 (No. 8 of 1980) (hereinafter referred to as the principal Act), for the words “twenty seven thousand”, the words “forty five thousand” shall be substituted.

Amendment of Section 4.

5. In Section 4 of the principal Act,—

- (i) in sub-section (1), for the words “thirty thousand”, the words, “forty five thousand” shall be substituted;

- (ii) in sub-section (2), for the words “twenty seven thousand”, the words “thirty five thousand” shall be substituted;
- (iii) in sub-section (3), for the words “one thousand two hundred”, the words “one thousand five hundred” shall be substituted.

STATEMENT OF OBJECT AND REASONS

Due to inflation in recent years, it has become necessary to enhance the salary and allowances of Adhyaksha, Upadhyaksha and Neta Pratipaksha of the Madhya Pradesh Legislative Assembly.

2. Hence this Bill.
