## MADHYA PRADESH BILL

NO. 9 OF 2018

## THE MADHYA PRADESH GRAMO ME KI DAKHALRAHIT BHOOMI (VISHESH UPABANDH) SANSHODHAN VIDHEYAK, 2018

**A Bill further to amend the Madhya Pradesh Gramo Me Ki Dakhalrahit Bhoomi (Vishesh Upabandh) Adhiniyam, 1970.**

Be it enacted by the Madhya Pradesh Legislature in the sixty-ninth year of the Republic of India as follows:—

**Short title.**

1. This Act may be called the Madhya Pradesh Gramo Me Ki Dakhalrahit Bhoomi (Vishesh Upabandh) Sanshodhan Adhiniyam, 2018.

**Amendment of Section 3.**

2. In Section 3 of the Madhya Pradesh Gramo Me Ki Dakhalrahit Bhoomi (Vishesh Upabandh) Adhiniyam, 1970 (No. 26 of 1970) (hereinafter referred to as the principal Act), in the proviso,—

(i) for clause (a), the following clause shall be substituted, namely:—

“(a) situated in,—

- (i) any development plan area;
- (ii) any local body or village situated on the outer periphery of any local body;
- (iii) area of operation of the Madhya Pradesh Nagriya Kshetro Ke Bhoomihin Vyakti (Pattadhriti Adhikaron Ka Pradan Kiya Jana) Adhiniyam, 1984 (No. 15 of 1984); and
- (iv) five hundred metres on both sides of a national highway specified in, or declared under, the National Highways Act, 1956 (XLVII of 1956) or highway notified under Section 3 of the Madhya Pradesh Rajmarg Adhiniyam, 2004 (No. 11 of 2005);”;

(ii) after clause (c), the following explanation shall be added, namely:—

“**Explanation.**—For the purpose of this Section;

- (a) “development plan” shall have the same meaning as assigned to it in the Madhya Pradesh Nagar Tatha Gram Nivesh Adhiniyam, 1973 (No. 23 of 1973);
- (b) “local body” means any municipal corporation constituted under the Madhya Pradesh Municipal Corporation Act, 1956 (No. 23 of 1956), or any municipality or any municipal council constituted under the Madhya Pradesh Municipalities Act, 1961 (No. 37 of 1961).”.

**Amendment of Section 4.**

3. In Section 4 of the principal Act in sub-section (3), for the words “unoccupied land”, the words “upto 60 square metre unoccupied land” shall be substituted.

**Repeal and Saving.**

4. (1) The Madhya Pradesh Gramo Me Ki Dakhalrahit Bhoomi (Vishesh Upabandh) Sanshodhan Adhyadesh, 2018 (No. 8 of 2018) is hereby repealed.

(2) Notwithstanding the repeal of the said Ordinance, anything done or any action taken under the said Ordinance shall be deemed to have been done or taken under the corresponding provisions of this Act.

STATEMENT OF OBJECTS AND REASONS

The Madhya Pradesh Gramo Me Ki Dakhalrahit Bhoomi (Vishesh Upabandh) Adhiniyam, 1970 (No. 26 of 1970) was enacted to provide for allotment of unoccupied land to inhabitants of villages. In order to widen the scope of the said Act suitable amendments are proposed.

2. As the matter was urgent and the Madhya Pradesh Legislative Assembly was not in session, the Madhya Pradesh Gramo Me Ki Dakhalrahit Bhoomi (Vishesh Upabandh) Sanshodhan Adhyadesh, 2018 (No. 8 of 2018) was promulgated for the purpose. It is now proposed to replace the said Ordinance by an Act of the State Legislature without any modification.

3. Hence this Bill.
