MADHYA PRADESH BILL

No. 15 of 2018

THE MADHYA PRADESH SHASKIYA SEVAK (ADHIVARSHIKI-AYU) SANSHODHAN VIDHEYAK, 2018

A Bill further to amend the Madhya Pradesh Shaskiya Sevak (Adhivarshiki-Ayu) Adhiniyam, 1967.

Be it enacted by the Madhya Pradesh Legislature in the sixty-ninth year of the Republic of India as follows:-

Short title.

1. This Act may be called the Madhya Pradesh Shaskiya Sevak (Adhivarshiki-Ayu) Sanshodhan Adhiniyam 2018.

Amendment of Fundamental Rule 56 as substituted by section 2 of the Madhya Pradesh Act No. 29 of 1967.

- 2. In section 2 of the Madhya Pradesh Shaskiya Sevak (Adhivarshiki-Ayu) Adhiniyam, 1967 (No. 29 of 1967), in rule 56 of the Fundamental Rules, in sub- rule (1),—
 - (i) the brackets, figures and letters "(1-a), (1-b)," occurring twice, shall be omitted;
 - (ii) for the words "sixty years" occurring twice, the words "sixty two years" shall be substituted.

Repeal and saving.

- 3. (1) The Madhya Pradesh Shaskiya Sevak (Adhivarshiki-Ayu) Sanshodhan Adhyadesh, 2018 (No. 4 of 2018) is hereby repealed.
- (2) Notwithstanding the repeal of the said Ordinance, anything done or any action taken under the said Ordinance shall be deemed to have been done or taken under the corresponding provision of this Act.

STATEMENT OF OBJECTS AND REASONS

As per the provision of the Madhya Pradesh Shaskiya Sevak (Adhivarshiki-Ayu) Adhiniyam, 1967 (No. 29 of 1967) the age of superannuation of Government Servants, (other than Government teacher, Government nurse, person appointed on medical posts and class IV employees), is sixty years. Promotion of Government Servants are hindered due to court judgment and there is shortcoming of Government Servants on senior posts of various cadres. In order to obviate this shortcoming it is decided to enhance the age of superannuation of Government Servants from sixty years to sixty two years by suitable amendment in the said Act.

- 2. As the matter was urgent and the Legislative Assembly was not in session, the Madhya Pradesh Shaskiya Sevak (Adhivarshiki-Ayu) Sanshodhan Adhyadesh, 2018 (No. 4 of 2018) was promulgated for the purpose. It is now proposed to replace the said Ordinance by an Act of the State Legislature without any modification.
 - 3. Hence this Bill.
