**THE MADHYA PRADESH CIVIL COURTS (AMENDMENT) BILL, 2022**

**A Bill Further to amend the Madhya Pradesh Civil Courts Act, 1958.**

Be it enacted by the Madhya Pradesh Legislature in the seventy-third year of the Republic of India as follows :—

**Short title.**

1. This Act may be called the Madhya Pradesh Civil Courts (Amendment) Act, 2022.

**Amendment of Section 2.**

2. In section 2 of the Madhya Pradesh Civil Courts Act, 1958 (No. 19 of 1958), for clause (a), the following clause shall be substituted, namely:—

“(a) “cadre of Higher Judicial Service” means the cadre of District Judges and shall include the Principal District Judge, District Judge (Super Time Scale), District Judge (Selection Grade) and District Judge (Entry Level);”.

**STATEMENT OF OBJECTS AND REASONS**

The Shetty Pay Commission (First National Judicial Pay Commission) made certain recommendation with intent to adopt uniform designation of members of Higher Judicial Service and Lower Judicial Service in the country, which has been approved by the Hon'ble Supreme Court in the matter of “All India Judges Association versus Union of India and Others” (judgment dated 8<sup>th</sup> February, 2001).

2. In view of the judgment of Hon'ble the Supreme Court in the aforesaid matter, nomenclature has been incorporated in the Madhya Pradesh Higher Judicial Service (Recruitment and Conditions of Services) Rules, 2017.

3. In the Madhya Pradesh Gazette (Extra-ordinary), vide publication dated 30-03-2021, the same nomenclature was incorporated in the Madhya Pradesh Civil Courts Act, 1958 (No. 19 of 1958). Accordingly, in section 2 of the principal Act, for clause (a), the following clause had been substituted:—

“(a) “cadre of higher judicial service” means the cadre of District Judges and shall include the Principal District Judge, District Judge (Entry Level) and District Judge (Selection Grade);”.

4. In the aforesaid amendment, the cadre of “District Judge (Super Time Scale)” is not included and mentioned cadres are not in sequence. Therefore, there is a need to further amend the aforesaid clause.
