MADHYA PRADESH BILL No. 26 of 2022

THE MADHYA PRADESH CO-OPERATIVE SOCIETIES (AMENDMENT) BILL, 2022

A Bill further to amend the Madhya Pradesh Co-operative Societies Act, 1960.

Be it enacted by the Madhya Pradesh Legislature in the seventy-third year of the Republic of India as follows:—

Short title and commencement.

- 1. This Act may be called the Madhya Pradesh Co-operative Societies (Amendment) Act, 2022.
 - (2) It shall come into force from the date of its publication in the Madhya Pradesh Gazette.

Amendment of Section 49.

2. In Section 49 of the Madhya Pradesh Co-operative Societies Act, 1960 (No. 17 of 1961) (hereinafter referred to as the principal Act), in sub-section (7-A), in clause (b), in the second proviso, after the words "Central Society", the words "or Primary Agriculture Credit Co-operative Society" shall be inserted.

Amendment of Section 53.

- 3. In Section 53 of the principal Act.—
 - (i) in sub-section (1), in the second proviso, after the words "Central Society", the words "or Primary Agriculture Credit Co-operative Society" shall be inserted.
 - (ii) in sub-section (12), in the second proviso, after the words "Central Society", the words "or Primary Agriculture Credit Co-operative Society" shall be inserted.

STATEMENT OF OBJECTS AND REASONS

In a large number of Primary Agriculture Credit Co-operative Societies of the State, elected Board of Directors does not exist. The elections of those Primary Agriculture Credit Co-operative Societies are yet to be conducted by the Madhya Pradesh State Co-operative Election Authority.

- 2. Under section 49(7-A) and Section 53 of the Madhya Pradesh Co-operative Societies Act, 1960 (No. 17 of 1961), the Registrar Co-operative Societies has the power to appoint administrator in Co-operative societies under certain circumstances. Accordingly, Registrar Co-operative Societies has appointed government officials not below the rank of class III executive as administrators in the Primary Agriculture Credit Co-operative Societies also.
- 3. At present, a large number of Primary Agriculture Credit Co-operative Societies are being run by administrators appointed under the provisions of State Co-operative Act, but because of limited number of government officials, the administrator appointed in Primary Agriculture Credit Co-operative Societies has to manage at least 6-10 societies on an average.
- 4. There is a provision in Section 49(7-A), Section 53 (1) and Section 53(12) for the formation of a Committee of five persons to assist the administrator but those provisions are applicable to Apex or Central Society only. These provisions are not applicable to primary societies. It is proposed to make similar provisions for the smooth functioning of Primary Agriculture Credit Co-operative Societies.
 - 5. Therefore, it is proposed to amend the Madhya Pradesh Co-operative Societies Act. 1960 (No. 17 of 1961).
