THE MADHYA PRADESH PEYA JAL PARIRAKSHAN
(SANSHODHAN) VIDHEYAK, 2022

A Bill further to amend the Madhya Pradesh Peya Jal Parirakshan Adhiniyam, 1986.

Be it enacted by the Madhya Pradesh Legislature in the seventy-third year of the Republic of India as follows :—

- Short title.** 1. This Act may be called the Madhya Pradesh Peya Jal Parirakshan (Sanshodhan), Adhiniyam, 2022.
- Substitution of section 9.** 2. For Section 9 of the Madhya Pradesh Peya Jal Parirakshan Adhiniyam, 1986 (No. 3 of 1987), the following Section shall be substituted, namely :—
- Offences.** "9. The contravention of the provision of Section 3, Section 4 or Section 6 shall be punishable with a fine of five thousand rupees for the first offence, and a fine of ten thousand rupees or with imprisonment which may extend to two years for each subsequent offence."

STATEMENT OF OBJECTS AND REASONS

"Ease of doing business" is an important factor that helps in the faster economic growth of Nation and State. In order to commensurate the quantum of punishment with gravity of offence of the contravention of the provisions of Section 3, Section 4 or Section 6 of the Madhya Pradesh Peya Jal Parirakshan Adhiniyam, 1986 (No. 3 of 1987), suitable amendment is proposed in Section 9 of the Act.

2. Hence this Bill.
