## MADHYA PRADESH BILL

No. 8 OF 2024

## THE MADHYA PRADESH VISHWAVIDYALAYA (SANSHODHAN) VIDHEYAK, 2024

A Bill further to amend the Madhya Pradesh Vishwavidyalaya Adhiniyam, 1973.

Be it enacted by the Madhya Pradesh Legislature in the Seventy-fifth year of the Republic of India, as follows :-

Short title and commencement.

1. (1) This Act may be called the Madhya Pradesh Vishwavidyalaya (Sanshodhan) Adhiniyam, 2024.

(2) It shall come into force from the date of its publication in the Madhya Pradesh Gazette.

Substitution of certain words throughout the principal Act.

2. Throughout the Madhya Pradesh, Vishwavidyalaya Adhiniyam, 1973 (No. 22 of 1973) (hereinafter referred to as the principal Act), for the words "Kulapati", or "Kulpati" wherever they occur, the word "Vice-Chancellor" shall be substituted.

Amendment of First Schedule.

3. In the First Schedule to the principal Act, after serial number 8, the following serial number and entries relating thereto shall be added, namely :—

"9. Pandit S. N. Shukla Vishwavidyalaya Adhiniyam, 2016 (No. 28 of 2016)."

Amendment of Second Schedule.

4. In the Second Schedule to the principal Act,—

(1) in Part I,—

(i) for serial number 5 and entries relating thereto, the following serial number and entries relating thereto shall be substituted, namely :—

(ii) after serial number 6, the following serial number and entries relating thereto shall be added, namely :—

### STATEMENT OF OBJECTS AND REASONS

There functioning under there are 8 affiliating universities and 8 other unitary public universities, the Madhya Pradesh Vishwavidyalay Adhiniyam, 1973 (hereinafter referred to as Adhiniyam, 1973). The objectives and reasons of the proposed amendment to the Adhiniyam, 1973 are as follows-

- (1) Shahdol Division is a forest area. The students studying in the colleges here mostly come from rural, hilly or forested areas. The distance of Awadhesh Pratap Singh Vishwavidyalay, Rewa from some areas of this Division is up to 300 kilometres, due to which students are facing extreme difficulties in access to the university. It is necessary to increase the source of income of the Vishwavidyalay. If colleges of the Shahdol Division are affiliated to the Pandit Shambhunath Shukla Vishwavidyalay, Shahdol, then the income of the Vishwavidyalay shall increase. Therefore, by repealing the present act of Pandit Shambhunath Shukla Vishwavidyalay, Shahdol, this University has been brought under the Adhiniyam, 1973 and the districts of Shahdol division- Anuppur, Umaria, Shahdol have been included in its jurisdiction.
- (2) Dr. Harisingh Gaur Vishwavidyalay, Sagar, the State University located in Sagar, was converted into a Central University in the year 2009. The number of students admitted to the Central University was limited, as a result of which the number of students admitted in the two government colleges located at the Divisional headquarters has increased to more than twenty thousand and the students from the poor class are being deprived of higher and quality education. A total of 06 districts namely Sagar, Chhatarpur, Damoh, Panna, Tikamgarh and Niwadi are located under the Sagar Division. At present, all the Government and private colleges located in the said districts are affiliated with Maharaja Chhatrasal Bundelkhand Vishwavidyalay, Chhatarpur. The distance of Maharaja Chhatrasal Bundelkhand Vishwavidyalay, Chhatarpur is about 165 km from Sagar. Due to this reason, students and staff are facing inconvenience in examinations, academic and other administrative works related to the university. Therefore, to provide quality education to the students of Bundelkhand region and provide facilities to the students in examinations, extra-academic activities and other university-related works, it is proposed to establish "Rani Avantibai Lodhi Vishwavidyalay, Sagar" in Sagar.

- (3) In the 100<sup>th</sup> meeting of the University Coordination Committee held under the Chairmanship of the Honorable Governor, it has been recommended to change the designation of "Kulapati" to "Kulguru". In the sequel for the word "Kulapati", in the English version of the Adhinyam, 1973 to the word "Vice-Chancellor" and in the hindi version of the Adhinyam, 1973 for the word "Kulpati", the word "Kulguru" is to be substituted.
2. Therefore, to cancel the Pandit S.N. Shukla Vishwavidyalay Adhinyam, 2016 and bring Pandit Shambhunath Shukla Vishwavidyalay, Shahdol under Adhinyam, 1973, for establishing a new university at Sagar and changing the designation of "kulapati" as mentioned above in English and Hindi versions to the Adhinyam, 1973.
3. Hence this Bill.
