**THE MADHYA PRADESH MUNICIPALITIES (AMENDMENT)
BILL, 2024**

A Bill further to amend the Madhya Pradesh Municipalities Act, 1961.

Be it enacted by the Madhya Pradesh Legislature in the seventy-fifth year of the Republic of India as follows :—

| Short title. | 1. This Act may be called the Madhya Pradesh Municipalities (Amendment) Act, 2024. |
| Amendment of Section 20. | 2. For Clause (i) of sub-section (3) of Section 20 of the Municipalities Act, 1961 (No. 37 of 1961) (hereinafter referred to as the principal Act), the following clause shall be substituted, namely:—

“(i) It is presented within thirty days, in case of election of Councillor from the date on which result of such election or nomination was notified in the official Gazette, and in case of election of President, from the date on which the election of the President is completed in the meeting convened under Section 55; and.” |
| Amendment of Section 45. | 3. In Section 45 of the Principal Act, in the marginal heading and provision, the words “President and” shall be omitted. |
| Repeal and saving. | 4. (1) The Madhya Pradesh Municipalities (Amendment) Ordinance, 2024 (No. 3 of 2024) is hereby repealed.

(2) Notwithstanding the repeal of the said Ordinance, anything done or any action taken under the said Ordinance shall be deemed to have been done or taken under the corresponding provision of this Act. |

STATEMENT OF OBJECTS AND REASONS

Section 43 of the Madhya Pradesh Municipalities Act, 1961 (No. 37 of 1961) provides that the elections of Presidents of Municipalities / Nagar Parishads are conducted through indirect method by elected Councillors whose election is already notified in the official Gazette, therefore, there is no need to publish election of Presidents in the Gazette. Thus it is required to omit the word “President” in Section 45 and also sub-section (3) of Section 20 of the said Act to be substituted suitably.

2. As the matter was urgent and the legislative Assembly was not in session, the Madhya Pradesh Municipalities (Amendment) Ordinance, 2024 (No. 3 of 2024) was promulgated for the purpose. It is now proposed to replace the said ordinance by an Act of the State Legislature without any modification.

3. Hence this Bill.
