## THE MADHYA PRADESH LOCAL AUTHORITIES (ELECTORAL OFFENCES) AMENDMENT BILL, 2024

#### A Bill further to amend the Madhya Pradesh Local Authorities (Electoral Offences) Act, 1964.

Be it enacted by the Madhya Pradesh Legislature in the seventy-fifth year of the Republic of India as follows:—

Short title.

1. This Act may be called the Madhya Pradesh Local Authorities (Electoral Offences) Amendment Act, 2024.

Amendment of section 3.

2. In clause (b) of sub-section (1) of section 3 of the Madhya Pradesh Local Authorities (Electoral Offences) Act, 1964 (No. 13 of 1964), the words "or print media" shall be omitted.

#### STATEMENT OF OBJECTS AND REASONS

In the Representation of People Act, 1951 (43 of 1951) of Election Commission of India, the provision of clause (b) of sub-section (1) of Section 126 provides that no person shall display any matter related to the election to the public through cinematography, television or other similar apparatus. These provisions do not include print media. Accordingly, amendment is proposed in clause (b) of sub-section (1) of Section 3 of the Madhya Pradesh Local Authorities (Electoral Offences) Act, 1964 (No. 13 of 1964) to bring it at par with provisions of the Representation of People Act, 1951.

3. Hence this Bill.
