## MADHYA PRADESH BILL

No. 11 OF 2024

THE MADHYA PRADESH VISHWAVIDYALAYA (DWITIYA SANSHODHAN)  
VIDHEYAK, 2024

A Bill further to amend the Madhya Pradesh Vishwavidyalaya Adhiniyam, 1973.

Be it enacted by the Madhya Pradesh Legislature in the Seventy-fifth year of the Republic of India, as follows :-

**Short title and commencement.**

1. (1) This Act may be called the Madhya Pradesh Vishwavidyalaya (Dwitiya Sanshodhan) Adhiniyam, 2024.

(2) It shall come into force from the date of its publication in the Madhya Pradesh Gazette.

**Amendment of Second Schedule.**

2. In the Second Schedule of the Madhya Pradesh, Vishwavidyalaya Adhiniyam, 1973,-  
(1) in Part I, for serial number 3 and 4 and entries relating thereto,

the following serial numbers and entries relating thereto shall be substituted namely :—

(2) in Part II, after serial number 3 and entries relating thereto, the following serial numbers and entries relating thereto shall be added, namely :—

3. (1) The Madhya Pradesh Vishwavidyalaya (Sanshodhan) Adhyadesh, 2024.

**Repeal and Saving.**

(No. 2 of 2024) is hereby repealed.

2. Notwithstanding the repeal of the said Ordinance, anything done or any action taken under the said Ordinance, shall be deemed to have been done or taken under the corresponding provision of this Act.

## STATEMENT OF OBJECTS AND REASONS

Madhya Pradesh is a geographically vast and socially diverse State. Providing quality in the higher education to the youth of this vast State is a challenging task. Madhya Pradesh is the leading State to implement the National Education Policy, 2020. The gross enrollment ratio of the Madhya Pradesh for the year 2021-22 is 28.9 percent and the average gross enrollment ratio of the country is 28.4 percent. In the National Education Policy, 2020, the target is to increase the gross enrollment ratio to 50 percent by the year 2035.

2. Among the goals of qualitative improvement in the field of higher education, the aim is also to reduce the affiliation burden of universities. Limiting the jurisdiction of already established universities shall reduce their affiliation burden, which shall increase their working efficiency.
3. In view of the above, it is necessary that new affiliating universities shall be opened and universities capable of giving affiliation shall be established in tribal areas. In the sequel, Krantisurya Tantya Bhil University, Khargone is being established in Khargone and Krantivir Taty Topte University, Guna is being established in Guna.
4. Therefore, for the purpose of establishing Krantisurya Tantya Bhil University, Khargone and Krantivir Taty Tope University, Guna, appropriate amendments are proposed in the Madhya Pradesh University Act, 1973 (No. 22 of 1973).
5. As the matter was urgent and the legislative Assembly was not in session, the Madhya Pradesh Vishwavidyalaya (Sanshodhan) Adhyadesh, 2024 (No. 2 of 2024) was promulgated for the purpose. It is now proposed to replace the said Ordinance by an Act of the State Legislature without any modification.
6. Hence this Bill.
