MADHYA PRADESH BILL

THE MADHYA PRADESH GOVANSH VADH PRATISHEDH (SANSHODHAN) VIDHEYAK, 2024

A Bill further to amend the Madhya Pradesh Govansh Vadh Pratishedh Adhiniyam, 2004.

. Be it enacted by the Madhya Pradesh Legislature in the Seventy-fifth year of the Republic of India as follows:-

Short title and commencement.

- 1. (1) This Act may be called the Madhya Pradesh Govansh Vadh Pratishedh (Sanshodhan) Adhiniyam, 2024.
 - (2) It shall come into force from the date of its publication in Official Gazette.

Amendment of Section 11.

- 2. In Section 11 of the Madhya Pradesh Govansh Vadh Pratishedh Adhiniyam, 2004 (No. 6 of 2004),-
 - (i) in sub-section (5), the following proviso shall be inserted, namely:-

"Provided that no order of confiscation shall be made under this Section unless the Collector issues an intimation in the prescribed format regarding the initiation of proceedings for confiscation of the seized conveyance, cow progeny and beef to the court having jurisdiction to try the offence for which such seizure has been made.

- (ii) after sub-section (5), the following sub-section shall be added, namely:-
- "(6) Notwithstanding anything to the contrary contained in the Act or any other law for the time being in force, the Court having jurisdiction to try offences covered by Section 4, 5, 6, 6-A and 6-B on account of which seizure has been made, shall not make any order about the disposal or custody of the conveyance, cow progeny and beef seized after it is received from the Collector an intimation under sub-section (5) above about the initiation of the proceedings for the confiscation of the seized conveyance, cow progeny and beef.".

STATEMENT OF OBJECTS AND REASONS

In order to bring a change in the provision of confiscation of vehicles carrying the cow progeny or beef, the present provision is that such confiscation is initiated by the court of Judicial Magistrate and later on such seized vehicles are delivered by the said court. Therefore, to bring an amendment in sub-section (5) of Section 11 of the Madhya Pradesh Govansh Vadh Pratishedh Adhiniyam, 2004 (No. 6 of 2004) a provision is proposed that no order of confiscation shall be made under this section unless the Collector issues an intimation in the prescribed format regarding the initiation of proceeding for confiscation of the seized conveyance, cow progeny and beef. Therefore, a suitable amendment is made in the Madhya Pradesh Govansh Vadh Pratishedh Adhiniyam, 2004 (No. 6 of 2004) accordingly.

2. Hence this Bill.
