THE MADHYA PRADESH APPROPRIATION (NO. 4) BILL, 2024

A Bill to authorise payment and appropriation of certain sums from and out of the Consolidated Fund of the State of Madhya Pradesh for the services of the Financial Year 2024-2025.

Be it enacted by the Madhya Pradesh Legislature in the Seventy-fifth year of the Republic of India as follows:-

- Short title. 1. **This Act may be called the Madhya Pradesh Appropriation (No.4) Act, 2024.**

2025. 2. **From and out of the Consolidated Fund of the State of Madhya Pradesh there may be paid and applied sums not exceeding those specified in column (3) of the Schedule amounting in the aggregate inclusive of the sums specified in column (3) of the Schedule to the Madhya Pradesh Appropriation (Vote on Account) Act, 2024 (No.5 of 2024) to the sums of Rs. Three lakh sixty five thousand sixty seven crore thirty seven lakh twenty four thousand towards defraying the several charges which shall come in the course of payment during the Financial Year 2024-2025 in respect of services and purposes specified in column (2) of the Schedule.**
- Appropriation. 3. **The sums authorised to be paid and applied from and out of the Consolidated Fund, of the State of Madhya Pradesh by this Act, shall be appropriated for the services and purposes expressed in the Schedule in relation to the said year.**

STATEMENT OF OBJECTS AND REASONS

This Bill is introduced in pursuance of Article 204 (1) of the Constitution of India to authorise for the appropriation from and out of the Consolidated Fund of the State of Madhya Pradesh of the moneys required to meet the expenditure charged on the Consolidated Fund of the State of Madhya Pradesh and the grants made in advance by the Legislative Assembly in respect of the estimated of the Government of Madhya Pradesh for the part of the Financial Year 2024-2025.
