Amendment Notification

In exercise of the powers conferred by Sub-section (1) of Section 28 of the Madhya Pradesh Niji Vishwavidyalaya (Sthapana Evam Sanchalan) Dwitiya Sanchalan Adhiniyam 2007 the State Government hereby makes the Amendment Notification of the LNCT University, Bhopal.

1. They shall come into force from the date of their publication
2. In the Ordinance of LNCT University, Bhopal the following additions /modification/deletion/substitution shall be as indicated therein:

1. **Amendment in the Ordinance No.2 "University Examination"**
in clause 5.24 shall be added as follows after examination concerned:

"In case of semester system/annual system courses the candidate will be promoted to next semester/year with two backlog subjects even if he/she fails in previous semesters/year with maximum two subjects. He/she can appear in the two failed subjects along with the regular semester/annual system provided if it is in accordance with the provision of the concerned regulatory body, if any.

2. **Amendment in the Ordinance No.3 "The Conduct of University Examination"**

In clause 2.17 shall be added as follows after malpractice

"with the prior approval of Vice Chancellor and as per State Govt. norms from time to time accordingly."

In clause 2.18 shall be modified as follows

"The squad may consist of two officers, not below the rank of Assistant Professor and shall be drawn from other Institutions in the University"

In clause 2.21 shall be added as follows after clinical examination

"with the prior approval of Vice Chancellor

In clause 2.31.1 under the heading "Panel of Examiners" shall be modified as follows

"The controller shall arrange to get the panel of both internal and external examination for UG and PG courses prepared by examination committee. There shall be a minimum of 15 examiners in external panel in each subject. Such panel can be reviewed each year by additions and deletions as required"

In Clause 2.32 under the heading "Theory Question Papers" shall be added as follows:-

- 2.32.1 The process of procuring question papers for theory examination shall be initiated 6 months in advance.
- 2.32.2 Examination Committee will short list a panel of three names for the appointment of the paper setter of each written paper.
- 2.32.3 The Examination Committee will also short list a panel of three names of appointment of practical/ viva-voce examiner as well as evaluator and re-evaluator.
- 2.32.4 He/she shall supply syllabus, scheme of question and marks and Acceptance and Declaration forms to the examiner. Acceptance and Declaration shall be obtained in a form to the effect that examiner is ready to accept the examination as paper setter as well as declare commitment to maintain confidentiality. He/ She also certify whether any of relatives (Blood) are appearing for the examination or not.
- 2.32.5 He/She shall make arrangement to procure two sets of question papers 6 month in advance of commencement of each examination to maintain availability of at least one sets of question paper as reserve.
- 2.32.6 University will develop question bank for each subject for all the courses conducted by the University. Controller of Examination will randomly put up the papers in prescribed pattern before the Vice Chancellor shall select the paper randomly.

3. Amendment in the Ordinance No. 64 " Bachelor of Computer Application (BCA)"

Clause 5.2 shall be substituted as follows:

BCA - Candidates should have passed 10+2 exam in any stream with at least 45% in aggregate or as per UGC/State Govt norms from time to time.

ORDINANCE NO.108

MASTER OF DESIGN UNDER FACULTY OF ARCHITECTURE & PLANNING

1. INTRODUCTION :

The CBSC provides a flexible type approach in which the student can take courses of their choice, learn at their own pace, undergo additional courses and acquired more than the required credits, and adopt an interdisciplinary approach to learning. The courses shall be evaluated on the grading system, which is considered better than the conventional marks system. It is necessary to introduce the grading system to make the uniformity among all technical institutions of India. This will benefit the students to move across institutions within India to begin with and across countries. The uniform grading system will also enable potential employers in assessing the performance of the candidates. In order to bring uniformity in evaluation system and computation of the Cumulative Grade Point Average (CGPA) based on student's performance in examinations, this document is in accordance to the guidelines of LNCT University, Bhopal B. Arch & Tech Ordinance.

2. Duration

- The duration for Master of Design Programme shall be Two Years Maximum Period of programme completion: Four Years.
- The Student admitted to 1st year M. Des shall complete the course within a period of three academic years from the date of first admission, failing which he/she has to discontinue the course.

3. Eligibility

The candidates seeking admission to the Master of Design must have passed Bachelor of Design with minimum aggregate 50% marks for general category and 5% relaxation to reserve category from recognized University in India or passed equivalent examination of any recognized University or examinations Board to which equivalence is granted by State Govt. and norm of Regulatory Body (CoA, New Delhi), if required.

4. Admission process

Admission to the programme shall be made by admission committee approved by the Vice-Chancellor. The admission process shall take place as per Ordinance No. 1 of the LNCT University.

5. Number of Seats for the Programme

Faculty of AYUSH

3.0 Duration

The Under Graduate Programmed for Bachelor of Naturopathy and Yogic Sciences (BNYS) shall be four and half (4½) Years and 1 year internship. Maximum Period of Programmed completion: Eight years.

4.0 Eligibility

The candidate seeking admission to the Bachelor of Naturopathy and Yogic Sciences (BNYS) must have passed 10+2 examination with Science stream (Physics, Chemistry and Biology subject) from recognized Boards in India or passed Diploma in Naturopathy and Yogic Science (DNYS) or as specified by State Govt/statutory body.

5.0 Admission process

Admission shall be made as per the State Govt norms after getting the permission from State Govt and the admission process shall take place as per Ordinance No. 1 of LNCT University, Bhopal.

UNDER THE FACULTY OF MEDICAL SCIENCE****1.0 AIMS & OBJECTIVES**

- 1.1 The overall aim of this programme is to develop expertise in the field of basic health sciences. A process of rational thinking and cogent action will be inculcated in an individual so that he/she shall be competent to pursue various activities as demanded by any professional.
- 1.2 The Objectives of this programme are to prepare post graduate student in the subject of Master of Medical Science (M.Sc.) in Medical Anatomy, Medical Physiology, Medical Pharmacology, Medical Biochemistry/ Medical Microbiology under the Faculty of Medical Science who shall:-
 - 1.2.1 Teach and train future undergraduate and postgraduate medical students in basic medical subject in medical College & research Institutions.
 - 1.2.2 Carry out & guide, contribute to research advancement of the subject.

 - 1.2.4 Developing human resource for government organization and industries.

2.0 APPLICABILITY

Vascular Technology, Anesthesia, Operation Theatre Technology, Dialysis Technology, Optometry and Radiology

- 3.5 Regular Students: A students who is enrolled in constituent institution for the purpose of obtaining a Degree Diploma Certificate/ other recognized education credential to receive education on a full time basis on payment of tuition fee.

1. ELIGIBILITY

- 4.1 Candidate possessing following minimum qualification shall be eligible for admission.

4.1.1 Graduate with MBBS/BDS/BPT/B.Pharm/BMLT, B.Sc. Biology (i.e. Zoology/Botany/ Biotechnology / Microbiology/ Biochemistry/ Bio-Science as major paper) from a recognized university with minimum aggregate 50% marks in aggregate at the qualifying examination (Relaxation as per norms) or as per MCI norms. MBBS shall be preferred.

- 4.5 Candidate who has already appeared in the last year examination of graduate programme may be considered for admission. if he/she have successfully passed last year examination, such candidate shall be admitted provisionally and shall be required to submit, certificate and mark-sheet as proof of passing qualifying examination, within three months of commencement of the programme. Otherwise his/her admission shall be cancelled. Such candidate shall not be eligible for refund of fees.

- 4.6 Candidates who are already in service will be required to apply through proper channel along with NOC from the employer.

- 4.7 If a selected candidate does not join the course by the stipulated date, the selection will be offered to the first candidate on the waiting list.

5.0 DURATION

- After completion of one academic year, M.Sc. part- I Examination will be conducted No student shall be permitted to join M.Sc. part- II Training unit he/she passed in all the subject of M.Sc. part- I examination.
- After completion of local three academic years, M.Sc. Part- II Final university examination will be conducted.
- The dissertation is compulsory for candidates registered for P.G. degree and should include candidates own work under a supervisor, qualified for the purpose and recognized as a P.G. teacher by the university after six months of admission. The subject of dissertation along with synopsis (about 200 words) signed by P.G. teacher H.O.D. and Head of the Institution will be submitted within six months of admission to the university. Ethics committee of the institution must approve the topic of dissertation. Completed dissertation will be submitted to the university that is, six months before the date of final examination.
- The candidate shall publish at least two research paper in National or International indexed medical research journal, or submit the evidence of acceptance of paper, related to his/her subject/ dissertation topic, before submission of final dissertation to the university.

- Theory and Practical Clinical examination for the subjects including basic Medical Science shall be conducted to test the knowledge & competence of the candidates for making valid and relevant observation based on the experimental Laboratory studies and his ability to perform such studies as are relevant to his/her subject.

➤ The Oral examination shall be thorough and shall aim at assessing the candidate knowledge and competence about the subject, investigative procedures, therapeutic technique and other aspects of the specialty, which form a part of the examination.

8.2 The University shall conduct not more than two examinations in a year i.e. one main and another supplementary with an interval of not less than 4 and not more than 6 months.

8.3 Details of subjects and course curriculum shall be prescribed by the scheme of Examination prepared and proposed by BOS and approved by Academic Council.

9.0 HEAD OF PASSING AND PASSING CRITERIA:

A candidate shall secure not less than 50% marks in each Head of passing which shall include (1) Theory (2) Practical including clinical and viva voce examination.

10.0 APPOINTMENT OF UNIVERSITY EXAMINERS:

13. Medium of Instructions and Examination

The medium of instruction and examinations shall be Hindi/English.

14. Attendance

Attendance in theory and practical classes shall be compulsory as per statutes and as per norms of AICTE. Presently, it is 75% in theory and practical separately.

15. Notwithstanding anything stated in this Ordinance for any unforeseen issues arising and not covered by this Ordinance or in the event of differences of interpretation, the Vice-Chancellor may take a decision. The decision of the Vice-Chancellor shall be final.

Ordinance No. 121**ELECTRO HOMEOPATHY**

University shall impart course in certificate and diploma skills development courses for gainful employment generation to rural/urban youth. The course will lead for the award of diploma and certificates. The Certificate and diploma with sound knowledge shall develop a candidate as a profitable entrepreneur.

01. Duration of courses :

Diploma in Electro- Homeopathy	-	2 Years
Degree in Electro- Homeopathy	-	4½ Years

02. Fees Structure:

The Fees for each course shall be decided by Board of Management of the University from time to time.

03. Eligibility

Minimum qualification for admission to the course shall be the High School Certificate /Higher Secondary School Certificate Examination (10+2) conducted by MP Board of Secondary Education or an equivalent examination from a recognized Board.

3.1 Number of seats

It will be decided by the university from time to time, as per the norms laid down by concerned Apex Regulatory Body, if any.

3.2 Lateral Entry:

The certificate holder in Electro- Homeopathy will be eligible for lateral entry i.e. 2nd year of Diploma course.

The Diploma holder in electro homeopathy will be eligible for lateral entry i.e. 3rd year of degree in Electro Homeopathy.

04. Admission procedure:- Fill the Form.

Admission under these Courses will be made as follows.

- The University will issue admission notification in news papers, the University's website, notice Board of the University and publicity in media before the start of every cycle. Hoardings will be used for attracting Students and other stake holders.
- List of candidates provisionally selected for admission/ shortlisted based on merit will be displayed on the notice Board of the University/ University website/ or the student will be informed directly of their admission.
- The candidates whose result of the qualifying exam/ interview is awaited can also apply who will be admitted provisionally. Such candidates however must produce the previous year mark sheet/school/ college certificates as a proof of required eligibility criteria. The candidates so

admitted shall have to be present mark sheet of the qualifying examination within a month of the due date of admission the provisional admission granted to him will be cancelled.

- d) The application from may be rejected due to any of the following reasons:-
- The candidate does not fulfill the eligibility conditions.
 - The prescribed fee is not enclosed.
 - The application from is not signed by the candidate and his/her parent guardian wherever required.
 - Supporting documents for admission are not enclosed.
- e) Enrollment /Registration number will be assigned to the student by the University after verification & submission of all the necessary documents/fees.
- f) Admission rules as farmed by the University shall be applicable for all admission from time to time.

05. Academic year:

There will be two academic cycles every years, one from July to June and January to December.

06. Examination & Attendance:-

- a) Each student shall have to appear in the examination of theory/practical workshop practice and continuous internal assessment. The internal assessment will be held in the manner prescribed from time to time by the University.
- 30 percent marks of each paper will be earmarked of internal assessment (for each semester, there will be two separate evaluations of 15 marks each)
 - Main examination will carry 70 percent marks.
 - For passing the examination the candidate that be required to secure at least 36 % marks in University examination separately in the term end theory. Practical and internal assessment in each on the prescribed paper and aggregate of 40% marks wherever applicable.
 - There will be an external examiner to evaluate the project report. The minimum passing marks for project work will be 50%.
- b) Each certificate program shall have one theory and one practical paper. The Diploma course may have thane one theory/practical papers that are decided by the concerned Board of Studies for each course.

07. Course: -

As decide by Academic Council of University.

08. Medium of Instruction:-

Medium of Instruction will be English.

09. Award of Certificate/Diploma: -

Candidate has to score 50% passing mark in theory & practical separately to qualify for Certificate/Diploma. Candidate securing 75% marks will be graded as excellent, 60 to 75% very good, 50% to 60 Good and below. 50% marks will be treated as failed in certificate/Diploma course.

“(40) **“Licensed Architect / Structural Engineer / Engineer / Supervisor /Town Planner /Fire Engineer/ Group”** means, respectively, any qualified Architect / Structural Engineer / Engineer / Supervisor /Town Planner / **Fire Engineer/ Group** who, where necessary, has been licensed as such by the Authority.”

2. In rule 16,

(1) In sub-rule (8), for serial number (i), the following serial number shall be substituted, namely:-

“(i) Specifications both general and detailed, giving type and grade of materials being used, duly signed by the Licensed Architect, Structural Engineer, Engineer, Supervisor, Town Planner, **Fire Engineer or Group**, as the case may be, shall accompany the application.”

(2) For sub-rule (9), the following sub-rule shall be substituted, namely:-

“(9) **Supervision**-The application shall be further accompanied by a certificate in form given in **Appendix-B** by the Licensed Architect, Structural Engineer, Engineer, Supervisor, Town Planner, **Fire Engineer or Group**, as the case may be, undertaking the supervision.”

3. In rule 26,

- (1) For sub-rule (1), the following sub-rule shall be inserted, namely:-

“(1) The Authority may issue licenses in form given in **Appendix-C** to Structural Engineers, Engineers, Supervisors, Town Planners and **Fire Engineers**, who possess the minimum qualifications as laid down in the sub-rule (2).”

- (2) In sub-rule (2), after serial no. 5, the following serial no. shall be inserted, namely:-

Designation	Minimum Qualification
(1)	(2)
“6. Fire Engineer	Graduate in Fire Engineering/ Technology or equivalent of recognized Indian or foreign university with three years experience in this field.”

- (3) In sub-rule (9), for serial number (F), the following serial number shall be substituted, namely:-

“(F) Fire Engineer-Competence.- The **Fire Engineer** shall be competent to carry out work related to fire Safety and Fire Audit in all types of buildings, which are covered under National Building Code Part-IV.”

- (4) In sub-rule (9), after serial number (F), the following serial number shall be inserted, namely:-

“(G) **Group or Agency**- When an agency or group of qualified Architects, Structural Engineers, Engineers, Town Planners, **Fire Engineers** is practicing, then the qualification and competence of work shall be equivalent to the highest competency of individual in the group or agency.”

4. In rule 87,

- (1) After sub-rule (3), the following sub-rules shall be added, namely:-

“(4) The following provisions shall be binding on all building owners falling under the provisions of the National Building Code (NBC), namely :-

- (a) No kitchen will be allowed on rooftops or basements. No cooking activity of any kind will be permitted on rooftop or basement.
- (b) Storage of inflammable material will not be allowed on the rooftops.

- (c) No temporary roofing over the roof or terrace using FRP or any inflammable material will be allowed.
 - (d) Flammable materials of construction will not be used in passage, corridors or staircase like wooden paneling, foam paneling, carpet etc.
 - (e) Gas Bank, if any will be installed conforming to the standards prescribed in the National Building Code (NBC).
 - (f) Main electrical panels like HT, LT & main power distribution, DG changeover and main supply panels of all types high rise buildings, buildings carrying on any type of commercial activity, offices, hospitals, nursing homes production, testing, educational, storage and godown etc. should be protected with in cabinet clean agent gas fire suppression system.
 - (g) Natural or mechanical arrangement be made for smoke ventilation of the all passages / corridors at each floor level and staircase.
 - (h) Fire Doors having fire resistance rating of not less than 1 hour at the entrance of staircases at each floor level be provided where number of occupants are more than 10 on each floor.
- (5) The fire audit of such buildings as mentioned in clause 4.10.1 of the National Building Code (NBC) shall be carried out once in a year and the owner of the building shall be responsible for the following:
- (a) Submission of Fire Audit report in prescribed Form-S given in Appendix-L by 30th of June of every financial year.
 - (b) If the owner fails to comply with the provisions of clause (a) as mentioned above: in case of non-compliance for the first time, a warning will be issued to him with the direction to submit the same in the next three months. In case of non-compliance for the second time, a show cause notice stating as to why the Fire NOC issued to him should not be cancelled, will be issued to him. After giving a reasonable opportunity of being heard, a decision regarding cancellation of Fire NOC may be taken by the Fire Authority.”

AMENDMENT**1. Short Title and Commencement**

(1) These Regulations shall be called the 'Madhya Pradesh Electricity Regulatory Commission (Recovery of expenses and other charges for providing electric line or plant used for the purpose of giving supply) Regulations, (Revision-I) 2009 (Seventh Amendment) {ARG-31(1)(vii) of 2020}.

(2) These Regulations shall extend to the whole of Madhya Pradesh.

(3) These Regulations shall come into force on the date of their publication in the Madhya Pradesh Gazette.

2. Amendment to the Regulation 5.0

In the said regulation, for regulation 5.0, the following regulation shall be substituted, namely: -

“5.0 Other Charges to be recovered from consumers: -

5.1.1 As provided for in Section 45(3)(b) of the Electricity Act, 2003 (No. 36 of 2003), the Distribution Licensee may charge from the consumers a rent or other charge in respect of any electric Meter or Electrical Plant provided by the Distribution Licensee. Accordingly, the Commission notifies schedule of metering charges and other charges as mentioned in Annexure I appended to this Regulation. However, metering charges prescribed in the Annexure I appended to this regulation shall be levied up to the effective period of the retail supply tariff order for FY 2019- 20. Thereafter, metering charges (if any) shall be applicable in accordance with the respective retail supply tariff order issued by the Commission from time to time.”

Statutes No. 06**APPOINTMENT, TERMS AND CONDITIONS AND POWERS
OF THE VICE- CHANCELLOR****1. Short title and commencement:**

- (a) This Statute may be called the LNCT University, Bhopal, and Madhya Pradesh Appointment of Vice-Chancellor: Terms & Conditions, Powers and Functions.
- (b) This shall come into force with effect from the date of Publication in the Official Gazette.

2. APPOINTMENT OF VICE-CHANCELLOR:

- (a) The Vice-Chancellor shall be appointed by the Chancellor from the panel recommended by the 'selection committee' constituted as per the provision of MPPURC Act, 2007 for the purpose.
- (b) The selection committee, referred to in sub-section (a) shall consist of the following members, namely:
- (c) Two eminent academicians nominated by the Sponsoring Body; and
- (d) One eminent person nominated by the State Government.
- (e) The Chancellor shall appoint one of the members of the Selection Committee as its Chairman.
- (f) The selection committee shall submit a panel of at least three eminent persons for the appointment of Vice-Chancellor. Provided that if the Chancellor does not approve the recommendations of the 'selection committee', he may call for fresh recommendation from it (the selection committee).
- (g) Notwithstanding anything contained in the foregoing sub-section, the chancellor may appoint the first Vice-Chancellor for a period of two years to conduct the affairs of the University, as prescribed in the Act 2007.
- (h) The Vice-Chancellor shall, subject to the provision contained in sub-section (a), hold office for a term of four years.

Provided that a Vice-Chancellor shall continue to hold office even after expiry of his term till a new Vice-Chancellor joins, however in any case this period shall not exceed 6 months.

3. TERMS AND CONDITIONS:

- (a) The Vice-Chancellor shall be a whole time salaried officer of the University.**
- (b) The Vice-Chancellor shall receive a fixed pay as per the norms of the U.G.C. Regulation per month plus other allowances as admissible from time to time.**
- (c) During his/her tenure of office, the Vice-Chancellor shall be entitled to have a rent free furnished residential accommodation maintained by the University.**
- (d) The Vice-Chancellor shall be entitled to use a University vehicle for official purposes and private local use as per Statutes.**
- (e) The Vice-Chancellor shall have the tenure as prescribed in the Act 2007;**
- (f) If at any time upon representation made or otherwise, it appears to the Chancellor that the Vice-Chancellor-**
 - i. Has made default in performing any duty imposed on him by or under this Act**
 - ii. Has acted in a manner prejudicial to the interest of the University; or**
 - iii. Is incapable of managing the affairs of the University.**

The Chancellor may, notwithstanding the fact that the term of office of Vice-Chancellor has not expired, by an order in writing stating the reasons therein require the Vice-Chancellor to relinquish his office from such date as may be specified in the order.

- (g) No order under sub-section (e) shall be passed unless the particulars of the grounds on which such action is proposed to be taken are communicated to the Vice-Chancellor and he is given**

reasonable opportunity of showing cause against the proposed order.

- (h) As from the date specified in the order under sub-section (e), the Vice-Chancellor shall be deemed to have relinquished the office and the office of the Vice-Chancellor as per Act 2007.

5. POWERS OF VICE CHANCELLOR:

- (a) The Vice-Chancellor shall preside at the convocation of the University in the absence of the Visitor and the Chancellor.
- (b) If in the opinion of the Vice-Chancellor it is necessary to take immediate action on any matter for which powers are conferred on any other authority by or under the Adhiniyam 2007 he may take such action as he deems necessary, and shall at the earliest opportunity thereafter report his action to such officer or authority as would have, in the ordinary course dealt with the matter:

Provided that if in the opinion of the officer concerned or authority such action should not have been taken by the Vice-chancellor, then such case shall be referred to the Chancellor, whose decision, thereon, shall be final:

Provided further that where any such action taken by the Vice-Chancellor affects any person in the service of the University, such person shall be entitled to prefer, within three months from the date on which such action was communicated to him, an appeal to the Governing Body and the decision of the Governing Body shall be communicated to the person concerned within three months from the date of appeal.

- (c) If in the opinion of the Vice-Chancellor, the decision of any authority of the University is not in conformity with the power conferred by the Adhiniyam and Statutes, Ordinances or Regulations made there under or is likely to be prejudicial to the interest of the University, he shall request the authority concerned to revise its decision and in case the authority refuses to revise such

decision wholly or partly or fails to take any decision within fifteen days, then such matter shall be decided by the Chancellor.

- d. The Vice-Chancellor shall exercise such powers and perform such duties as may be prescribed by the Statutes and the Ordinances.**

6. FUNCTIONS:

- (a) The Vice-Chancellor shall be the principal executive and academic officer of the University and shall exercise general superintendence and control over the affairs of the University and shall execute the decision of various authorities of the University.**
- (b) Vice-Chancellor shall be ex-officio Chairman of the Board of Management and Academic Council.**
- (c) The Vice Chancellor shall be responsible for presenting to the Governing Body for its deliberations and consideration, matters of concerns to the University. He/She shall have powers to convene the meeting of the Board of Management and the Academic Council.**
- (d) The Vice-Chancellor shall exercise general control over the affairs of the University and shall be responsible for the due maintenance of discipline in the University.**
- (e) The Vice-Chancellor shall ensure the faithful observance of the provisions of the Adhinyam and the Statutes and the Ordinances and shall possess all such powers as may be necessary for the purpose.**
- (f) The Vice-Chancellor shall be responsible for close coordination and integration of teaching, research and other work and shall exercise such other powers as may be prescribed by the Statutes or Ordinances.**

LNCT UNIVERSITY, BHOPAL**STATUTE NO.37****APPOINTMENT, TERMS AND CONDITIONS AND POWERS
OF THE PRO- CHANCELLOR**

The Appointment, Term and Conditions, and Powers of the Pro-Chancellor will be.

- 1. The Pro-Chancellor shall be a salaried officer of the university and shall be appointed by the sponsoring Body in consultation with Chancellor.**
- 2. The Pro-Chancellor shall report to the Chancellor and Sponsoring Body.**
- 3. The Pro Chancellor shall hold office for a period of three years and shall be eligible for reappointment with the approval of sponsoring body following the procedures laid down above under clause (1) of this statute.**
 - (a) Provided that on expiry of his term, the Pro-Chancellor shall continue to hold his office until he is reappointed, or his successor assumes his office, whichever is earlier.**
 - (b) Provide further that, in case of emergency like illness, absence, or death of the Pro-Chancellor, the sponsoring body or Chancellor may nominate a person to perform the duties, till the Pro-Chancellor reassumes his office or a new Pro- Chancellor appointed, whichever is earlier, for a period not exceeding six month.**
- 4. The Pro-Chancellor may in writing resign from his office by addressing a letter to the Sponsoring Body or Chancellor and shall cease to hold his office on the acceptance of such resignation.**
- 5. The sponsoring body may consider a No Confidence Motion against the Pro Chancellor and, consider the removal, if passed by two third majorities.**
- 6. The Pro-Chancellor shall be exercise all powers and functions as assigned by the Chancellor.**
- 7. The Pro-Chancellor shall be ex-office member of Governing Body.**
- 8. The Pro-Chancellor shall monitor the academic and related activities of the university and shall assist the Chancellor in the efficient functioning of the university.**

9. **The Pro-Chancellor shall be entitle to receive honorarium, expenses and allowances as may be decided by the sponsoring body, with appropriate amendments from time to time.**
10. **The Pro-Chancellor shall be competent to call from time-to-time such information or record relating to academic, affairs of the university as he may think necessary. It shall be lawful for the Pro-Chancellor, after perusal of such information or records to give any suggestion to the Chancellor, in the interest of university.**
11. **The Pro-Chancellor shall discharge his duties as delegated to him by the Chancellor, without prejudice to the role of Chancellor and Vice-Chancellor.**
12. **The Pro-Chancellor shall have the powers to call for any information and record, in accordance with the provisions of Act.**
13. **The Pro-Chancellor shall also have such other powers as may be specified elsewhere in the Act and Statutes, in force from time to time.**
