**SARDAR PATEL UNIVERSITY****BALAGHAT MADHYA PRADESH****ORDINANCE No. 66, of 2019****Five Year Dual Degree Integrated Post Graduate Degree Program****(B.Tech. + M.Tech.) & (BBA + MBA)**

**1.0** This Ordinance shall be applicable for the award of Five years (Ten Semesters) Integrated Post Graduate Degree Program (B.Tech. + M.Tech.) & (BBA + MBA) in various branches. In the case of Lateral Entry Admissions in which the minimum duration of the course shall be of four academic years.

**1.1** The branches of study can be any of the branch in which the university has its University Teaching Department (UTD).

**1.2** On the completion of the course the candidate shall be awarded Bachelor of Technology (B.Tech.) and Master of Technology (M.Tech.) Degree (B.Tech. + M.Tech). On the completion of the course the candidate shall be awarded Bachelor of Business Administration (BBA) and Master of Business Administration (MBA) Degrees (BBA + MBA).

**1.3** These programmes are offered by concerned faculty approved by the Board of Studies and Academic Council.

**1.4** Other specialization according to the need of the market and the academia can also be offered under this ordinance on the recommendations of the Board of Studies. The university reserves the right to offer any particular specialization.

**2.0 ADMISSIONS**

**2.1** Minimum qualification for admission to the first year of (B.Tech. + M.Tech.) program shall be the qualifying Higher Secondary School Certificate Examination (10+2) scheme with Physics, Chemistry & Mathematics conducted by M.P. Board of Secondary Education or an equivalent examination from a recognized Board / University. Minimum qualification for admission to the first year of Five Year Dual Degree Integrated Post Graduate Degree Program (BBA + MBA) shall be the qualifying Higher Secondary School Certificate Examination (10+2) scheme in any stream or an equivalent examination from a recognized Board.

- 2.2 The admission shall be on merit of test conducted by the University. In any eventuality, if entrance test is not conducted for some reasons, the admissions shall be made on the basis of the performance of the candidates in their qualifying examination.
- 2.3 Candidates with Diploma of 3 years may be allowed lateral entry at 3<sup>rd</sup> Semester level of B.Tech+M.Tech integrated Degree Course. Such candidates will be considered for admission to the 3<sup>rd</sup> semester of B.Tech+M.Tech. integrated in any discipline under Lateral Entry System only if they have passed Diploma Course in any discipline from a recognized Board/University.
- 2.4 Reservations and admissions to NRI / Foreign Students / Persons of Indian Origin (PIO) / Children of Indian Workers in the Gulf Countries and Management / Institute Preference Quota shall as per the policy laid down by this University. The reservations for SC / ST / PH / OBC (excluding creamy layer) / Minority communities shall be as per the policy laid down by University.

### 3.0 ELIGIBILITY FOR DEGREE :

- 3.1 However, candidate will have the option to move out with a B.Tech. degree in parent discipline after successful completion of four years (three years in case of lateral entry admissions). After successful completion of 5 year (10 semesters) the candidate will be eligible for B.Tech+M.Tech. degree.
- 3.2 After successfully completing 3 years (6 semesters) the candidate will be eligible for a BBA degree and after successfully completing four year a candidate will be eligible for a BBA honors degree. After successful completion of 5 year (10 semesters) the candidate will be eligible for MBA degree.
- 3.3 Only those successful students will get BBA/BBA honors degrees that leave the program after three/four year respectively.

### 4.0 EXAMINATIONS

The subjects to be studied in different semesters of this course shall be as per the schemes and syllabi, approved by the respective Board of Studies.

### 5.0 LEGAL JURISDICTION:

All matters of any dispute shall be limited to Balaghat court only. The University reserves the rights to change configuration, courses, contents, fee structure, scheme of evaluation, time schedule of face to face program and examination as per need.

- 6.0 Notwithstanding anything stated in this ordinance, for any unforeseen issues arising , and not covered by this ordinance , or in the event of differences of interpretation, the Vice-Chancellor may take a decision after obtaining , if necessary , the opinion / advice of a committee consisting of any or all the directors of the schools. The decision of the Vice-Chancellor shall be final.
- 7.0 The Reservation to SC/ST/ other category candidates shall be applicable as per the norms of the state government of Madhya Pradesh.

**The University reserves the right to frame, amend or cancel any rule or a part there of at any time and the candidate shall be subjected to such rules made by the University from time to time.**

**ORDINANCE No. 67, of 2019****BACHELOR OF AYURVEDIC MEDICINE & SURGERY (B.A.M.S.)**

**Statutory Body:** Central Council of Indian Medicine (CCIM) or Any Other Regulatory Body

The programme shall be governed by the norms, rules and guideline of the concerned regulatory council Central council of Indian Medicine, New Delhi and the policies of Government of Madhya Pradesh. This ordinance shall be applicable to candidate admitted for Bachelor of Ayurvedic Medicine & Surgery (B.A.M.S.) degree.

**1.0 DEFINITION & DURATION:**

The duration of the programme for the degree of Bachelor of Ayurvedic Medicine & Surgery (BAMS) shall be Four Year and Six Months, followed by compulsory rotating internship for one year.

This period of Four Year and Six Months will be divided as follows:-

- I<sup>st</sup> Professional 12 Month
- II<sup>nd</sup> Professional 12 Month
- III<sup>rd</sup> Professional 12 Month
- Final Professional 18 Month
- Compulsory Internship by Rotation 12 Month

**2.0 ADMISSION & ELIGIBILITY:**

A candidate who attains the age of 17 years or more on or before 31<sup>st</sup> December of the year and has passed:

- i) 10+2 examination from the MP Board of Secondary Education, with at least 50% of marks in aggregate of Physics, Chemistry & Biology for unreserved category and 40% for SC / ST / OBC category students.

**OR**

- ii) An examination of any other University / Board recognized by state govt. or Central Govt. or CBSE or equivalent there to with at least 50% of marks in aggregate of Physics, Chemistry & Biology for unreserved category and 40% for SC / ST / OBC category students.
- iii) English should be essentially a subject in 10+2 examination.

### 3.0 PROCEDURE:

Procedure of Admission shall be made through merit of NEET (National Eligibility cum Entrance Test) conducted by govt. authorized agency or test conducted by any other govt. authorized agency. The reservation to SC/ST/Other category candidates shall be applicable as per the norms of the State Government of Madhya Pradesh.

### 4.0 EXAMINATION:-

4.1 The examination shall be open to a person:-

A. Who possesses the qualification laid down in clauses 3.

B. (i) Who has been on the rolls of a college admitted to the privileges of this University for the period provided in clause 2.1.

(ii) Whose name is submitted to the Registrar/Controller of Examination by the School/Departments of University provided that the Director of the School/Department certifies that the candidate has attended not fewer than 75% of the full course of lectures delivered in each subject 85% of the period assigned to practical work in each subject (the lectures & practical work shall be counted up to 21 days before the commencement of the examination).

4.2 The examination shall be held according to the syllabus prescribed by central council of Indian medicine New Delhi and adopted by the University for regular students. Provided that the syllabus for candidates for the compartment examination shall be the same as was in force in the last Annual Examination.

4.3 Number of Papers teaching hours and Marks for Theory / Practical are as below:

**NOTE:** The period of theory and practical shall not be less than 60 minutes (one hour) The duration of the practical of clinical subjects and RachnaSharir (dissection) shall be of at least 120 minutes (Two hours).

### 4.4 FIRST PROFESSIONAL EXAMINATION;

a) The first professional examination shall be at the end of one academic year of first professional session. The first professional session will ordinarily start in July.

b) The first professional examination shall be held in the following subjects:-

1. PadarthVigyanevamAyurvedkaItihas
2. Sanskrit
3. KriyaSharir (Physiology)
4. RachnaSharir (Anatomy)
5. MaulikSiddhantevamAshtangHridaya (Sutra Sthan).

- c) A student failed in not more than two subjects shall be eligible to keep the terms for the second professional Courses, however he/she will not be allowed to appear for second professional examination unless he/she passes in all the subjects of the first professional.

#### 4.5 SECOND PROFESSIONAL EXAMINATION:

- a) The Second professional session shall start every year in the month of July following completion of First Professional examination.
- b) The second professional examination shall be ordinarily held and completed by the end of month of May/June every year after completion of one year of Second Professional session.
1. Dravyaguna Vigyan (Pharmacology and MateriaMedica)
  2. Rasashastra-Bhaishajya Kalpana (Pharmaceutical Science)
  3. Roga Nidan Vikriti Vigyan (Diagnostic Procedure and Pathology)
  4. Charak- Puravardh (An Ancient Ayurvedic Text Part – I)
- c) A student failed in not more than two subjects shall be eligible to keep the terms for the third professional examination, however he/she will not be allowed to appear for third professional examination unless he/she passes in all the subjects of second professional examinations,

#### 4.6 THIRD PROFESSIONAL EXAMINATION

- a) The Third Professional session shall start every year in the month of July following completion of second professional Examination.
- b) The Third Professional examination shall be ordinarily held and completed by the end of the month of May/June every year after completion of one year of third professional session.
1. Agad Tantra Vyavhar Ayurvedevam Vidhi Vaidyaka (Toxicology and Medical Jurisprudence)
  2. Charak Samhita Uttarardh (An Ancient Ayurvedic Text Part – II)
  3. SwasthaVritta & Yoga (Preventive and Social Medicine & Yoga)
  4. Prasuti & Striroga (Obstetrics & Gynecology)
  5. Bal Roga (Pediatrics)
- c) A Student failed in not more than two subjects shall be eligible to keep the terms for the final professional examinations, however he/she will not be allowed to appear for final professional examination unless he/she passes in all the subjects of Third Professional examination.

#### 4.7 FINAL PROFESSIONAL EXAMINATIONS

- a) The final professional session will be of 1 and ½ years duration and shall start every year in the month of July following completion of Third professional examination .the final professional examination Shall be ordinarily held and completed by the end of month of Oct/Nov. every year after completion of one half year of final professional examinations.
- b) Final professional examination shall comprise the following subjects:
1. ShalyaTantra (General Surgery)
  2. ShalakyaTantra (Diseases of Head& Neck including Ophthalmology, ENT and Dentistry)
  3. Kayachikitsa (Internal Medicine-including anasRoga,Rasayan&Vajkarana).
  4. Panchakarma
  5. Reaearch Methodology & Medical – statistics.

#### 4.8. EXAMINATION FEE:

The examination fee to be paid by a candidate shall be as per University norms for each examination, or a part thereof.

**5.0 EVALUATION:**

- 5.1** Minimum marks required to pass in each subject shall be 50% (written & practical separately).
- 5.2** Every candidate on passing the Bachelor of Ayurvedic Medicine & Surgery course of studies shall be required to, undergo compulsory by rotation internship training for a period of one year as under before the degree of Bachelor of Ayurvedic Medicine & Surgery is conferred upon his/her.

- (d) Any Ayurved Hospital or Dispensary

All the above centers (a,b,c and d) will have to be recognized by the University and concerned Govt. designated authority concerned for taking such a training.

Internship will start after the declaration of final year B.A.M.S. examination result and Registration of Madhya Pradesh Ayurwada Unani Chikitsa board Bhopal.

- 8.0** The fees structure laid down in the admission bulletin of the specific year will remain applicable all through the course duration of the candidates who have taken admission in the concerned academic year.

**ORDINANCE No. 68, of 2019****POST GRADUATE DIPLOMA IN MANAGEMENT (PGDM)****(TWO YEARS COURSE)**

Post Graduate Diploma in Management (PGDM) is a full-time post-graduate diploma course.

**1.0 DURATION OF COURSE:**

The duration of PGDM course is 2 years divided into 4 semesters.

**2.0 ELIGIBILITY & ADMISSION PROCEDURE:**

**2.1** Candidates who have completed bachelor's degree from a recognized university are eligible for PG Diploma in Management (PGDM) course.

**2.2** Reservations and admissions to NRI / Foreign Students / Persons of Indian Origin (PIO) / Children of Indian Workers in the Gulf Countries and Management / Institute Preference Quota shall as per the policy laid down by this University. The reservations for SC / ST / PH / OBC (excluding creamy layer) / Minority communities shall be as per the policy laid down by University.

**3.0 CURRICULUM:**

The 2 years curriculum has been divided into 4 semesters and shall include lectures, and other curricular, co-curricular and extra-curricular activities as may be prescribed by the University from time to time etc. as defined in the scheme of instructions and examination and executive instruction issued by the University from time to time.

**4.0 EXAMINATION:**

The subjects to be studied in different semesters of PGDM shall be as per the schemes and syllabi, approved by the respective Board of Studies.

**5.0 MEDIUM OF INSTRUCTION**

The medium of instruction and examination shall be English throughout the program.

**6.0 LEGAL JURISDICTION:**

All matters of any dispute shall be limited to Balaghat court only. The University reserves the rights to change configuration, courses, contents, fee structure, scheme of evaluation, time schedule of face to face program and examination as per need.

**7.0** Notwithstanding anything stated in this ordinance, for any unforeseen issues arising , and not covered by this ordinance , or in the event of differences of interpretation, the Vice-Chancellor may take a decision after obtaining , if necessary , the opinion / advice of a committee consisting of any or all the directors of the schools. The decision of the Vice-Chancellor shall be final.

**8.0** The Reservation to SC/ST/ other category candidates shall be applicable as per the norms of the state government of Madhya Pradesh.

**ORDINANCE NO. 69, of 2019****BACHELOR OF HOTEL MANAGEMENT AND CATERING TECHNOLOGY****(BHMCT)****1.0 ELIGIBILITY FOR ADMISSION**

- 1.1 Minimum qualification for admission to the first year of BHMCT program shall be the qualifying Higher Secondary School Certificate Examination (10+2) scheme in any stream or an equivalent examination from a recognized Board.
- 1.2 Reservations and admissions to NRI / Foreign Students / Persons of Indian Origin (PIO) / Children of Indian Workers in the Gulf Countries and Management / Institute Preference Quota shall as per the policy laid down by this University. The reservations for SC / ST / PH / OBC (excluding creamy layer) / Minority communities shall be as per the policy laid down by University.

**2.0 DURATION OF THE COURSE**

Duration of the Course leading to the Degree of Bachelor of Hotel Management and Catering Technology (BHMCT) shall be of four academic years, spread-over eight semesters.

**3.0 ADMISSION**

- (a) Admission to BHMCT Course shall be based on the merit of the Entrance Test or marks in qualifying exams.
- (b) In any eventuality, if entrance test is not conducted for some reasons, the admissions shall be made on the basis of the performance of the candidates in their qualifying examination (i.e., marks obtained in 10+2 or equivalent).

**4.0 EXAMINATION**

The subjects to be studied in different semesters of BHMCT shall be as per the schemes and syllabi, approved by the respective Board of Studies.

5.0 Notwithstanding anything stated in this Ordinance, for any unforeseen issues are not covered by this Ordinance, or in the event of differences of interpretation, the Chancellor may take a decision after obtaining, if necessary, the opinion/advise of a Committee consisting of any or all the Directors of the Departments/Institutions. The decision of the Vice-Chancellor shall be final.

6.0 The reservation to SC/ST other category candidates shall be applicable as per the rules of the State Government of M.P.

**7.0 LEGAL JURISDICTION**

All matters of any dispute shall be limited to Balaghat court only. The University reserves the rights to change configuration, courses, contents, fee structure, scheme of examination and time schedule of face to face program and examination as per need.

**ORDINANCE No. 70, of 2019****B.Sc. (Fire & Safety / Disaster Management / Fire & Hazard Management /  
Fire & Disaster Management / Fire & Industrial Safety /  
Interior Designing / Jewellery Designing)**

This Ordinance shall be applicable for the award of Bachelor of Science course in Fire & Safety / Disaster Management / Fire & Hazard Management / Fire & Disaster Management / Fire & Industrial Safety / Interior Designing / Jewellery Designing

- These programmes are offered by concerned faculty approved by the Board of Studies and Academic Council.
- Other specialization according to the need of the market and the academia can also be offered under this ordinance on the recommendations of the Board of Studies. The university reserves the right to offer any particular specialization.

**1.0 DURATION:**

The Duration will be 3 years spread over 6 semesters.

**2.0 ADMISSION:**

- 2.1** Candidate seeking admission in these courses must have passed basic eligibility criteria i.e. 10+2 exam or its equivalent from any recognized Central / State Board with any stream.
- 2.2** Reservations and admissions to NRI / Foreign Students / Persons of Indian Origin (PIO) / Children of Indian Workers in the Gulf Countries and Management / Institute Preference Quota shall be as per the policy laid down by Central government / State government of MP. The reservations for SC / ST / OBC (excluding creamy layer) / Minority communities shall be as per the policy laid down by Central government / State government of MP.

**3.0 COURSE STRUCTURE:**

The course structure and detailed syllabus shall be finalized by Board of Management on the Proposal of Board of Studies and the faculty from time to time.



**4.0 EXAMINATION :**

The subjects to be studied in different semesters of these Courses shall be as per the schemes and syllabi, approved by the respective Board of Studies.

**5.0 LEGAL JURISDICTION:**

The Duration for the Post Graduate Course M.Sc. (Ag) PG Program is two years spread over four semesters and as per the guidelines of Fifth Deans' Committee of ICAR.
3. **MODE OF ADMISSION**

(Ag) Courses shall be made on merit computed on the basis of marks obtained by candidates in an Entrance Examination Test for Agriculture to be conducted by the Examination Department of Sardar Patel University, Balaghat, on a date and centers to be announced from time to time.
  - 3.2 In any eventuality, if entrance test is not conducted for some reasons, the admissions shall be made on the basis of the performance of the candidates in their qualifying examination.
  - 3.3 Reservations and admissions to NRI / Foreign Students / Persons of Indian Origin (PIO) / Institute Preference Quota shall as per the policy laid down by the Central / State Government. - 2.2** A candidate for M.D. (Homeopathy) can opt one of the subject of specialty at the time of admission and the degree shall be awarded in that specialty.

### **3.0 DURATION OF THE ACADEMIC PROGRAMMES:**

**3.1** The duration of an academic programme shall be 3 years, including 1 year of house job, during which the candidate shall be a resident in the campus and shall be given training as per the provision of sub regulation (2) of regulation 10, CCH guidelines.

Training as per (Sub regulation (2) of regulation 10, CCH guidelines): The emphasis should be on in service training and not on didactic lectures. The candidate should take part in seminars, group discussions, clinical meetings etc., The candidate should be required to write a thesis or dissertation with detailed commentary which should provide the candidate with necessary background of training in research methods and techniques along with the art of writing research papers and learning and making use of library. The candidate shall be a resident in the campus and shall be given graded responsibility in the management and treatment of patients entrusted to his care. He shall participate in teaching and training of undergraduate students or interns. Adequate number of posts of clinical or tutors shall be created for this purpose.

**3.2** The maximum period which a student can take to complete a full time academic programme shall be double the normal duration of the programme, i.e., 6 Years for M.D. (Homeopathy).

**3.3** After completion of Maximum Duration NO EXTENSION in any case will be granted.

### **4.0 EXAMINATION SYSTEM & EVALUATION:**

**4.1** In Each M.D Part I & II there shall be two Internal Examinations as part of Continuous Evaluation.

**4.2** The University Examination shall be conducted in two parts namely :

(iv) M.D. (Homeopathy) Part - I, which is to be held six months after completion of house job of one year's duration.

(v) M.D. (Homeopathy) Part - II, which is to be held one year and six months after Part I examination.

**4.3** Every candidate seeking admission to University exam of M.D. (Homeopathy) Part - I shall submit application to the University with the following documents, namely :

**4.3.1** A certificate from the Principal or Head of the institution about the Completion of the course of studies in the subjects in which the candidate seeks admission to the examination; and

- 4.3.2** A certificate of having completed one year house job in a Homeopathic hospital. (Hospital of colleges of Sardar Patel University).
- 4.4** Every candidate seeking admission to University examination of M.D. (Homeopathy) Part - II shall submit
- (i) A certificate showing that he has passed Part – I Examination.
  - (ii) A dissertation of not less than 10,000 words. (The dissertation shall form the basis of viva-voce examination) and
  - (iii) Every candidate shall prepare and submit four printed or typed copies of dissertation embodying his own research and contribution in advancing the knowledge in the subject to the University for approval not later than six months prior to the holding of Part II examination.
  - (iv) The Dissertation shall be submitted to the Guide/ Supervisor at least three months before the time fixed for submitting it to the university, and the Guide/Supervisor shall certify that the work has not previously formed the basis for award of any post graduate degree or diploma and that the work is the record of the candidate's personal efforts and submitted to the University duly countersigned by the Guide/ Supervisor.
  - (v) The examiners appointed to conduct the examinations shall scrutinize the dissertation and jointly report whether the dissertation be accepted or rejected or may make suggestions, as they deem fit.
  - (vi) The candidate shall be allowed to appear for the Part II examination three months after the examiner accepts the dissertation.
  - (vii) Provided that the candidates, Whose dissertation has not been accepted, may be permitted to resubmit the same within a period six months and not more than one year after rejection.
- 4.5** Viva-Voce/Practical examination in each subject, to be held by not less than three Examiners together out of which one shall be the Supervisor (Guide).
- 4.6** Three examiners shall jointly assess the knowledge of candidate for recommending the result to the University as pass or fail.
- 4.7** The University Examination (Theory) of M.D. (Homeopathy) Part – I & Part - II will be conducted by the Controller of Examinations following the procedures laid down by the University.
- (i) The Panel of the Board of Studies of the Faculty shall propose a list of examiners. The provost shall select 3 examiners out of this list which will include at least 1 Internal & Examiners:-

1. The criteria for examiners shall be the same as of the Supervisor External Examiner (Guide) or Co-Supervisor (Co-Guide) as the case may be.
  2. A Panel of examiners shall be prepared by the Universities, which shall be approved by the Central Council.
  3. One of the examiners out of the panel shall be appointed as Supervisor (Guide) or Co-Supervisor (Co-Guide) as the case may be.
  4. At least 50 % of the examiners shall be external examiners.
- (ii) The Controller of Examinations shall arrange to get one set of question paper each from the three examiners.
  - (iii) The Question Paper shall cover the entire syllabus and will be of 5 Questions of 20 marks.
  - (iv) The answers will be evaluated by concerned subject examiners from the selected viva-voce team.
  - (v) In case a student is aggrieved with the marks obtained in the subject in the Final University Examination, the student may apply for Re- Assessment of answer script by paying the prescribed fees.
  - (vi) Arrangement shall be made by the Controller of Examinations for Re-Assessment.
  - (vii) If the difference in marks awarded between 1<sup>st</sup> and 2<sup>nd</sup> examiners is atleast 10% of maximum marks then the paper is sent to a 3<sup>rd</sup> examiner. If the difference in marks awarded between the 1<sup>st</sup> and 3<sup>rd</sup> examiner is a minimum of 10% of the maximum marks then, the average of the marks awarded by the 2<sup>nd</sup> and 3<sup>rd</sup> examiners shall be awarded to the student.
  - (viii) The Controller of Examinations shall arrange for Final University Examination Marks and announcing the result.

## 5.0 DETENTION:

5.1 A student is said to have been detained and not allowed to appear for Final University Examinations, If

- (i) The student does not have a minimum 75% attendance or 65% attendance with condonation in all subjects put together in that year.
- (ii) Such student shall have to attend the regular classes in same class in next academic year subsequently and satisfy the above requirements afresh to become eligible for next University Exam.



**5.2** A student is also said to have been detained and not allowed to appear for Final University Examinations, If

- (i) The student has not scored a minimum of 40% of marks in Internal Examinations (Continuous Evaluation).
- (ii) Such students shall have to appear for Internal Improvement Examination and satisfy the above requirements afresh to become eligible to appear for the University Examination.
- (iii) The Internal Improvement Examination shall be conducted immediately after result declaration of Last Internal Examination.
