2. Courses Name, Structure and Duration

Note:- The students admitted in above courses shall have to complete the courses within the maximum permissible duration of 4 years for 2 years courses.

3. Minimum Eligibility:

The candidate must have passed 10+2 with physics, chemistry and biology / biotechnology from recognized board.

Admission in the above course shall be as per guideline by M.P. Paramedical Council

The candidate should have completed minimum of 17 years of age on / before 31st December of the concerned academic session.

4. Admission Procedure:

On merit, on the basis of qualifying examination/ entrance examination as per the norms of the M.P. Paramedical Council.

5. Total Seats:

Decided by Admission Board/Academic Council of University as per the norms of the concerned regulatory body M.P. Paramedical Council and subject to revision from time to time

6. Examination:

Examination will be conducted on yearly basis as per the appropriate statutes and ordinance in this respect. The Scheme of examinations, promotion to subsequent years and course of studies shall be as per guidelines of M.P. Paramedical Council the recommendations of the concerned Board of Studies with due approval of Academic Council. For matters not recovered in this ordinance, general rules and regulation shall be applicable. For all other matters, the decision of the Board of management shall be binding.

7. Compulsory Rotatory Clinical Training:

For above mentioned courses students as per time prescribed by M.P. Paramedical Council Rotatory Clinical Training shall be compulsory as a part of partial completion of the course. The training shall be undertaken in any of medical laboratory attached with minimum 100 bedded hospitals.

8. Eligibility for Diploma:

Eligibility for Award of the Diploma

A student shall be declared to be eligible for award of the diploma if he/she has:

- registered and successfully completed all the core courses and projects.
- successfully passed all the theory and practical examinations separately.
- no dues to the University, Hostels, Libraries, NCC / NSS / NSO etc.
- no disciplinary action is pending against him/her.

9. Attendance Requirement:

A Candidate must have at least 75% attendance.

10. General Instruction and Provisions:

For matters not covered in this specific ordinance, general rules and regulation of University regarding specific course are applicable. In the other matters Academic Council / Board of Management shall be competent to take any decisions.

2. **Duration of the Course** Minimum 4 Years (8 Semesters)
Maximum 6 Years (12 Semesters)
3. **Minimum Eligibility** A person who has secured at least 50% marks in Intermediate /10+2 with PCMB/PCB/Inter (Agriculture) (P-Physics, C-Chemistry, M-Mathematics, B-Biology) from a recognized Board / University.

The reservation in seats and relaxation in the qualifying marks for SC/ST/OBC/PWD and other categories shall be as per the rules of the Central/State Government whichever is applicable.
4. **Admission Procedure** On merit, on the basis of the qualifying examination/entrance examination following norms of the concerned regulatory body UGC and approved by Admission Board of University.
5. **Total Seats** Decided by Admission Board/ Academic Council of University as per norms of the concerned regulatory body UGC and subject to revision from time to time.
6. **Examination** Examinations will be conducted as per the appropriate statutes and ordinances in this respect. The scheme of examinations, promotion to subsequent semesters and course of studies shall be as per the recommendations of the concerned Board of Studies with due approval of Academic Council. For matters not covered in this ordinance, General rules and regulation shall be applicable. For all other matters, the decision of the Board of Management shall be binding. The mode of examination will be English only.
7. **Eligibility for Degree** **Eligibility for Award of the B.F.Sc.**
A student shall be declared to be eligible for award of the B.F.Sc. degree if he/she has:
 - a) registered and successfully completed all the core courses and projects;
 - b) successfully acquired the minimum required credits as specified in the regulations corresponding to the branch of his/ her study within the stipulated time;
 - c) earned the specified credits in all the categories of subjects;
 - d) secured a CGPA of 5.0.
8. **Attendance Requirement** A candidate must have at least 75% attendance.

उक्त विनियमों में, -

1. विनियम 23 के स्थान पर निम्नलिखित विनियम 23 स्थापित किया जाए, अर्थात् :-
23. **मामले की सुनवाई.-**
 - (1). प्रत्यर्थी या उसकी ओर से लिखित जवाब प्रस्तुत किये जाने के पश्चात अधिकरण प्रकरण में विवादकों के स्थरीकरण एवं पक्षकारों की ओर से अपने पक्ष समर्थन में साक्ष्य प्रस्तुत किये जाने हेतु दिनांक नियत कर सकेगा.

F.No. 11-12/11/Arb.Tri/2022.—In exercise of the powers conferred by Section 10 of the Madhya Pradesh Madhyastham Adhikaran Adhiniyam, 1983 (No. 29 of 1983), the Arbitration Tribunal, hereby, makes the following amendments in the Madhya Pradesh Madhyastham Adhikaran Regulations, 1985, namely :-

AMENDMENT

In the said regulations, -

(1) In place of present Rule 23, following Rule 23 be substituted :-

23. Hearing of the case – (1) After the written reply is filed by or on behalf of the respondent/respondents, a date will be fixed for settlement of points in dispute and the evidence which the parties will adduce in support of their respective cases.

(2) When after admission and denial of the documents, the case is fixed for evidence, it will be listed before the single Bench constituted to record the evidence and the single Bench will complete the recording of the evidence including deciding the matter with regard to allowing or disallowing the prayer of the party to take additional documents on record and to prove the same in accordance with the prescribed procedure.

(2) In place of present Rule 24, following Rule 24 be substituted :-

24. Final hearing – (1) On settlement of points for determination and completion of recording of the evidence, the case shall be posted for final hearing.

(2) When the case is fixed for final hearing, the case will be placed before the Chairman or in absence of the Chairman for more than seven days, before the Vice Chairman of the Tribunal for consideration of re-allotment of the case to the Bench consisting two or more Members as required in view of the nature of the case, value of the case and other relevant factors and the case will be finally disposed off by the aforesaid Bench subject to further order of the Chairman.

(3) Both the parties are required to submit in paper book form two or more copies in consonance with the number of Members, the copies of reference petition, petitioner's documents which is / are admitted in evidence and affidavit evidence, likewise, the opposite party is required to submit the copies of written reply, respondents' documents which is / are admitted in evidence and affidavit evidence, at least one weeks before the date of final hearing. Each party is required to furnish copy of its paper book to the opposite party.

15. Oath of Affirmation-

Every person, appointed to the service by direct recruitment, shall make and subscribe before such person as may be specified by the Chief Justice, an Oath or affirmation in the following form:-

“I, _____, having been appointed as a District Judge in the Higher Judicial Service of the State of Madhya Pradesh, do swear in the name of God/solemnly affirm, that I will bear true faith and allegiance to the Constitution of India as by law established, that I will duly and faithfully and to the best of my ability, knowledge and Judgement perform the duties of my office without fear or favour, affection or ill-will and that I will uphold the Constitution and the Law.”
