P.K.UNIVERSITY, SHIVPURI (M.P)
ORDINANCE NO. 53
TITLE OF DEGREE: BACHELOR OF SCIENCE
NAME OF COURSE: 1. COMPUTER SCIENCE
2. INFORMATION TECHNOLOGY

This Ordinance framed as per rules/ regulations/ guidelines laid down by UGC shall be applicable to candidates admitted to B.Sc. Computer Science (B.Sc. CS) and B.Sc. Information Technology (B.Sc. IT)

1.0 DURATION

1.1 The duration of the course leading to the Degree of B.Sc. (Computer Science) and B.Sc. (Information Technology) shall be of three years. Each year shall be divided into two semesters i.e. July to December and January to June. There shall be actual teaching of 90 days in each semester excluding admissions, preparatory holidays and examination days. The examinations for the First, Third and Fifth semesters will ordinarily be held in the month of December/January and for the Second, Fourth and Sixth Semesters in the month of May/June, on such dates as may be fixed by the Registrar and notified by the Controller of Examinations.

1.2 Re-Examination for fail candidates of each semester will be held in December/January and May/June examinations simultaneously with the main examinations of Odd and Even Semester.

2.0 ADMISSION PROCEDURE

2.1 A person who has passed Senior Secondary (10+2) examination with at least five subjects including the subjects of English and Mathematics from a recognized Board/University shall be eligible to join the first semester of the course.

2.2 A candidate who has been placed under Compartment or Supplementary in one subject only in 10+2 Examination or any other examination recognized as equivalent thereto may be allowed to admit provisionally for First semester of the course. Such a candidate shall be allowed to clear the Compartment subject in two consecutive chances from concerned University/Board. If such a candidate fails to clear/qualify in Compartment subject at the Supplementary Examination, he/she shall be permitted to continue his/her studies for Second semester of the course and to appear again in the compartment subject alongwith Second semester of the above course at the Annual Examination. If he/she do not clear his/her Compartment subject even in the Second Chance, his/her provisional admission/result of First and Second Semester shall be cancelled from start (ab initio).

3.0 FEES & INTAKE

The fees and intake for each course shall be decided by Board of Management of the University, with prior approval of MPPURC.

4.0 ATTENDANCE

4.1 Minimum attendance –required for becoming eligible to appear in semester examination for each theory and practical paper shall be 75%.

4.2 The Head of the Department is empowered to condone the shortage of attendance up to 10% of the total lectures delivered in each subject in exceptional cases on reasonable grounds.

5.0 EXAMINATION

5.1 The First and subsequent Semester examinations shall be open to a regular student who:-

(i) Has passed the requisite qualifying examination as laid down in Clause 2.1 & 2.2 above, as the case may be, if he/she is a candidate for the First Semester examination, or, has passed the preceding Semester examination if he/she is a candidate for the Second/Third/Fourth/Fifth/Sixth Semester examination.

(ii) Has his/her name submitted to the Registrar of the university by the HOD and produces the following certificates signed by the HOD :-

(a) of good character;

(b) of having remained on the rolls of the constituent Unit of this University for the Semester preceding the examinations;

(c) of having attended not less than 75% of lectures delivered in each Paper, Practical, Seminars etc. up to the last day when the classes break up for the preparatory holidays viz. 7 days before the commencement of the examinations. Provided that a candidate who has not attended the requisite percentage of lectures in any paper(s) will be eligible to take examination in the remaining papers. For the purpose of counting of the last date when the classes shall break up for the preparatory holidays, first day of the commencement of any semester examination will apply to all semester examinations and all semester classes will have the preparatory holidays from the same date i.e. 7 days before the date on which the first examination of any semester commences.

5.2 A candidate who has passed I or II or III or IV or V Semester shall be eligible to join the next Semester II, III, IV, V, VI of the course, as the case may be. This is, however, subject to Clauses

5.3 A candidate who has failed in one or more paper(s) of I and II, and III and IV Semesters shall be promoted provisionally to the III and V Semesters respectively, as the case may be, only if he/she has earned exemption in the papers as mentioned below:-

From Semester I & II to Semester III	If he/she earned exemption in at least 50% papers (Theory and Practical's taken together) of Semesters I and II.
From Semesters III and IV to Semester V	If he/she has passed all the papers of Semesters I and II and has earned exemption in at least 50% papers (Theory and Practical's taken together) of Semesters III and IV.

5.4 A candidate who has failed in one or more paper(s) or having been eligible fails to appear in a semester examination shall be allowed two additional chances only, on the recommendation of the HOD, to pass the Semester examination subject to Clause 6 below. Such a candidate may be exempted from re-appearing in the papers/practical/Sessional in which he/she may have obtained at least 40% marks.

5.5 A candidate for the B.Sc. (Computer Science) degree must pass the whole course (all the six semesters) within a period of five years, failing which he/she will be required to repeat the course de novo.

5.6 The examination shall be held according to the Scheme of Examination and the Syllabus prescribed by the Academic Council. A candidate, who fails in an examination or having been eligible fails to appear at an examination, shall, unless approved otherwise by the Academic Council take the examination according to the Syllabus prescribed by the University for regular students appearing for that examination.

6. SESSIONAL:

6.1 40% marks in each Theory paper shall be assigned internal assessment/ sessional and 60% marks in each paper for end-term examination shall be reserved. However for Practical courses 60% marks shall be reserved for internal assessment and 40% marks for end-term examination.

The Sessional be evaluated by the teachers concerned based on the work done during the semester on the basis of the following weightages:

(a) For Theory Subjects:

(i) Class Tests 40%

(ii) *Class Attendance (Lecture/Tutorial) 40%

(iii) Class Work/Assignment/Case Studies 20%

(b) For Practical Tests:

(i) Viva-Voce/Test 20%

(ii) Lab Record 20%

(iii) *Class Attendance 40%

(iv) Class work 20% *(Marks will be awarded proportionate to attendance.)

For Seminar courses, the marks will be awarded by the Teacher In-charge of the Seminar.

6.2 The candidate is required to obtain Pass Marks in each of the Theory and Practical papers in aggregate of the external and internal assessment/sessional subject to obtaining pass marks separately in each paper of external examinations. The internal assessment award of any candidate who fails in one or more papers of any semester examination shall be carried forward to the next examination. He/She will, however, be allowed to improve his/her marks of sessional examinations at the time of appearing in the ATKT.

6.3 The HOD shall forward the sessional awards to the Controller of Examinations at least one week before the commencement of Semester examination.

6.4 The question papers will be set and answer- books examined by the external examiner (s) from a panel approved by the Academic Council as recommended by the Board of Studies.

6.5 The Practical/Viva-Voce shall be jointly conducted by an External Examiner and Internal Examiner approved by the Academic Council on the recommendation of the Board of Studies.

6.6 The amount of examination fee for each Semester examination shall be as prescribed by the University. A candidate who re-appears in one or more paper(s) shall pay fee as for the whole Semester examination.

6.7 The medium of instruction and examination shall be English.

6.8 The minimum number of marks required to pass the examination in each Semester shall be, as under: (i) 40% in each written paper/practical/seminar/viva-voce examination. (ii) 40% in the aggregate of Sessional and external examination marks for each theory subject/practical paper subject to obtaining pass marks separately in each paper of external examination.

7. CREDIT-BASED SYSTEM OF EVALUATION:

7.1 Credit based system followed in the University in order to determine the performance of the candidates will be as under: - CREDIT COUNTS: All courses would have a Credit Count and teaching of subjects would be reckoned in terms of Credits. The number of credits of a course shall ordinarily be calculated as under:- (a) LECTURES : One Lecture per week shall be assigned ONE credit. (b) TUTORIALS: One Tutorial per week shall be assigned ONE credit. (c) PRACTICAL'S: One Lab. Period per week shall be assigned HALF a credit. (d) SEMINAR: ONE credit.

* The Teaching, Examination Scheme and the syllabus of different subjects shall be prepared by the concerned departments and be passed by their respective Departmental Councils. Later on, it will be presented before the Board of Studies and Academic Council for their approval and implementation from the next academic year or the semester as the case may be.

The Reservation to SC/ST/EWS Other category candidates shall be applicable as per the norms of the State Government of Madhya Pradesh.

- (i) For existing clause 1 and entries relating thereto the following clause and entries relating thereto shall be substituted, namely :-

“1. The higher degree in research field in the different specializations such as Engineering, Science, Management, Humanities and Social Science and Mathematical Sciences is referred as Ph.D. As per the guidelines, the duration of the doctorate shall be 03 Yrs (minimum) and 06 Yrs (maximum) through full time as well as part time basis. The degree shall be designated as DOCTOR OF PHILOSOPHY (Ph.D.) in the respective branches/research area.

The doctorate degree or Doctor of Philosophy (hereinafter called Ph.D.) shall include:

(i) Electronics & Communication Engineering (ECE)

(ii) Computer Science & Engineering (CSE)

(iii) Chemical Engineering (CHE)

(iv) Civil Engineering (CE)

(v) Mechanical Engineering (MEC)

(vi) Environmental Engineering (ENV)

(vii) Sciences i.e. Physics, Chemistry, Electronics, Applied Sciences

(viii) Mathematical Sciences i.e. Mathematics, Operations Research, Statistics, Computer Science, Data Science, Applied Mathematics

(ix) Management/ Humanities & Social Sciences (HSS)”

- (ii) In existing clause 2, under the heading “Admissions”, the following sub clause shall be substituted, namely :-

- “2 (a) Minimum qualification for admission to the first year Ph.D. shall be M.E./M.Tech./ Master's Degree/M.Phil. in appropriate specialization with at least 55% marks aggregate or its equivalent CGPA from any recognized university/institutions/Technical university/Deemed University or any other qualification as recommended by UGC/AICTE for a particular course. In case of exceptional candidates having B.E/ B.Tech from reputed institutions with minimum five years experience in relevant industry/ research organization, Vice Chancellor can relax the minimum qualification. However in such cases, the candidate has to earn extra course credits as decided by the university.
- (b) Deleted
- (e) Deleted”
- (iii) In existing clause 3, for existing sub clause (a), the following sub clause shall be substituted, namely :-
- “(a) For every Ph.D. student, Ph.D. Supervisor(s) will be decided considering available specializations of the faculty members and research interests of the student. If required, co-supervisor (s) may be appointed with the approval of the Vice-Chancellor.
- There will be a Doctoral Program Monitoring Committee (DPMC) for every PhD scholar. The DPMC will consist of the Dean – Academic/Research (Chairman), respective supervisor(s), the Head of the Department and three senior faculty members (including one from an allied discipline) to be nominated by the Vice-Chancellor;”
- (b) For existing sub clause (b), the following sub clause shall be substituted :-
- “(b) The supervisor shall himself/herself be a Ph.D. degree holder and adhering to University/UGC guidelines;”
- (c) For existing sub clause (c), the following sub clause shall be substituted, namely :-
- “(c) The DPMC may with permission of the Vice Chancellor permit a co-supervisor from within or outside the university who fulfills the same condition as the main supervisor.”
- (iv) For existing clause 4, the following clause shall be substituted, namely :-
- “4 course work.
- (a) Every student admitted to the PhD program will have to register for a minimum of 8 credits and maximum of 16 credits of course work as recommended by the DPMC.
- (b) The course work should be successfully completed within the first two semesters after registration
- (c) The Research scholar must obtain a minimum of ‘B+’ Grade to qualify every registered course.
- (d) Obligatory courses/subjects are
- (i) Research Methodologies including Quantitative Methods and Computer Applications
- (ii) Review of published Research Work in the relevant field (Literature Survey and Seminar)
- (iii) deleted
- (v) For item (iv) of sub clause (a) of clause 5, the following item shall be substituted, namely :-
- “(iv) Such candidates will have to be in constant touch with the Supervisor(s) from University. It is desirable that they spend at least two weeks every semester in university

and interact with the supervisor(s).”

(vi) For item (iii) of sub clause (b) of clause 5, the following item shall be substituted, namely :-

“Publish at least two papers in refereed indexed journals, and”

(vii) For item (vi) of sub clause (b) of clause 5, the following item shall be substituted, namely :-

“The candidate will be required to submit his/her Ph.D. thesis in the specified format and fulfilling other requirements within two months of the submission of the final Ph.D. Synopsis. The thesis should adhere to guidelines of the University/UGC on plagiarism”

(viii) For existing clause 6, the following clause shall be substituted, namely :-

“6. Depository with UGC-

Following the successful completion of the evaluation process and before the announcement of the award of the Ph.D. degree, a soft copy of the Ph.D. thesis shall be submitted to the UGC depository.”

(ix) For sub clause (a) of clause 7, the following sub clause shall be substituted, namely

“Each course, along with its weightage in terms of units and equivalent credits, shall be recommended by the DPMC and be approved by the Vice Chancellor. Only approved courses can be offered during any semester.”

(x) Clause 9 added :
